### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Cedar Grove Warehouse, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 - Description of Plan**

The following brief description of the Cedar Grove Warehouse, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan, as adopted effective January 1, 2017 and restated effective January 1, 2022, covering substantially all employees of Cedar Grove Warehouse, Inc. (the "Company"), who have met the eligibility requirements and elect to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** - Participants may elect to contribute a portion of their compensation to the Plan, not to exceed the amount allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct their contributions into various investment options offered by the Plan.

The Plan is operated as a safe harbor 401k plan; as such, the Company will make a nonelective safe harbor contribution equal to 3 percent of a participant's compensation each year. For the period January 1, 2025 to July 23, 2025 and the year ended December 31, 2024, the Company safe harbor contribution was \$0 and \$204,418, respectively.

Additionally, the Company may make discretionary matching or nonelective safe harbor contributions to the Plan. The Company did not make discretionary matching or nonelective contributions for the period January 1, 2025 to July 23, 2025 or for the year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's safe harbor nonelective contribution, (b) the Company's discretionary matching contribution or nonelective contribution and (c) Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants are immediately vested in their voluntary contributions, safe harbor contributions and rollover contributions, if any, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service, as defined by the Plan document. Participants are 100 percent vested in other Company contributions after six years of credited service.

**Participant Loans** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms generally range from one to five years, but may be longer if for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear a fixed interest rate equal to 2 percent above the USA Today prime rate when the loan is taken out. Interest rates range from 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits** - Upon termination of service, a participant will receive the value of his or her vested account balance in a lump-sum distribution or a series of substantially equal periodic installments not to exceed the participant's life expectancy (requirement minimum distribution rules), as described in the plan's provisions. The Plan also provides for in-service distributions upon the attainment of age 59 ½ or have incurred a financial hardship.

**NOTE 1 - Description of Plan - Continued**

**Administrative Expenses** - All administrative expenses may be paid out of the Plan unless paid by the Plan sponsor. During the period January 1, 2025 to July 23, 2025 and year ended 2024, expenses were paid by both the Plan and the Plan sponsor.

**Forfeited Accounts** - Nonvested portions of participants' accounts will be forfeited upon termination of employment. These accounts may be used to pay administrative expenses. At July 23, 2025 and December 31, 2024, forfeited, nonvested accounts totaled \$0. During the period January 1, 2025 to July 23, 2025 and year ended 2024, there were no amounts from forfeited, nonvested accounts to apply against administrative expenses.

**NOTE 2 - Summary of Significant Accounting Policies**

A summary of the significant accounting policies applied in the preparation of the accompanying financial statements and supplemental schedule is as follows:

**Basis of Accounting and Presentation** - The financial statements of the Plan are prepared using the accrual method of accounting and are presented in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) as codified by the Financial Accounting Standards Board.

**Notes Receivable From Participants** - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions** - Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Payment of Benefits** - Benefits are recorded when paid.

**Subsequent Events** - The Plan has evaluated subsequent events through August 25, 2025, the date which the financial statements were available to be issued.

**NOTE 4 - Fair Value Measurements**

The Plan has determined the fair value of certain assets in accordance with the provisions of U.S. GAAP, which provides a framework for measuring fair value under generally accepted accounting principles.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

---

**Level 1**      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

---

**Level 2**      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

---

**Level 3**      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

---

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 - Fair Value Measurements - Continued**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 23, 2025 and December 31, 2024.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Mutual funds (Portfolio Models):** Mutual fund portfolio models represent a product where the underlying holdings consist of all mutual funds that are pooled together to achieve a specific investment strategy. Each individual fund is valued at the daily closing price as reported by the fund. The funds held are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Plan custodian generates an overall NAV for the model based on the percentage of each individual fund held.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - Information Certified by the Plan Custodian**

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at March 31, 2025 and December 31, 2024, as well as net appreciation (depreciation) in fair value of investments and dividends for the period January 1, 2025 to March 31, 2025 and the year ended December 31, 2024, was obtained or derived from the information furnished to the Plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan. The value of notes receivable from participants and related interest income; as well as, the Plan activity after March 31, 2025 were not certified by the custodian.

**NOTE 6 - Tax Status**

The Plan sponsor became a participating employer in the CCH Incorporated DBA FT Willam Com Non-Standardized Pre-Approved Profit Sharing Plan and Trust effective January 1, 2022, and is relying on its opinion letter dated June 30, 2020. The Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. The Plan administrator and the Plan's tax counsel believe it is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and have concluded that as of July 23, 2025 and December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**NOTE 7 - Transactions with Parties-in-Interest**

Fees for professional services rendered to the Plan may be paid for by the Company at its discretion. The Plan allows participants to take out loans against their account balances. These transactions are considered party-in-interest transactions; however, they are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

**NOTE 8 - Amounts Owed to Participants Withdrawing from the Plan**

There were no amounts owed to participants who had elected to withdraw from the Plan, but had not been paid as of July 23, 2025 and December 31, 2024.

**NOTE 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.
