INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Lakeshirts Inc. & Affiliates 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Lakeshirts Inc. & Affiliates 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Lakeshirts Inc. & Affiliates 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Note 1. Description of Plan

The following description of the **Lakeshirts, Inc. & Affiliates 401(k) Profit Sharing Plan** (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan effective April 1, 1998, which covers employees of Lakeshirts, Inc. and affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan if they have completed twelve months of service and are 18 years of age. Employees may enroll in the Plan on the first day of each month.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The employer provides matching contributions of 50 percent of the participant's contributions. The maximum employer match is 4% of compensation. Contributions are subject to certain limitations. Participants may direct the investment of the contributions into various investment options under the Plan. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with participant contributions and an allocation of the employer's contribution and plan earnings (loss). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Upon termination of service, a participant may elect to receive either a lump sum amount equal to the value of his or her account, annual installments, or direct rollover to an IRA of another qualified plan.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant's account vests at the rate of 20% per year after one year of credited service and is 100% vested after five years of credited service.

Distribution of Benefits

A participant is entitled to benefits equal to the vested balance of funds allocated to his or her account, beginning at the latter of normal retirement age (65) or actual retirement. The Plan permits earlier distribution of benefits for death or permanent disability of participant, or termination of participant's employment. Distribution of benefits upon termination becomes automatic if the participant's account balance is less than \$5,000. The Plan also permits hardship distributions if certain conditions are met.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to a variety of pooled separate accounts maintained by John Hancock Life Insurance Company (U.S.A.). The investment options range from low risk income funds to high-risk international growth funds. Additionally, the Plan offers an individual brokerage account option.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,971 and \$3,289, respectively. These forfeitures can be used to reduce future employer contributions to the Plan. In 2024, no forfeitures were used to reduce employer contributions.

Administrative Fees

Certain administrative fees of the Plan are paid by Lakeshirts, Inc. & Affiliates.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net gain from investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

Management evaluates events occurring subsequent to the date of the balance sheet in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through **November 17, 2025**, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by **John Hancock Life Insurance Company USA**, the custodian of the Plan.

Note 4. Tax Status

The Plan is a Prototype Non-Standardized 401(k) Profit Sharing Plan sponsored by Tax Sheltered Compensation. The Internal Revenue Service advised on March 31, 2008, that the Plan constitutes a qualified trust under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, exempt from federal income taxes under provisions of Section 401(a). The Plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Termination of Plan

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 6. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 2 Fair Value Measurements

Pooled Separate Accounts: Valued at the NAV of units of an insurance pooled account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal in order to ensure that securities liquidation will be carried out in an orderly business manner.
