1. Description of Plan

The Educational Bus Transportation, Inc. 401(k) Plan (the "Plan") is a defined contribution plan for Educational Bus Transportation, Inc., Educational Bus, Inc., E.B.T., Inc., and Jaco Transportation, Inc. (collectively, the "Company"). The Plan was amended January 1, 2014 to allow E.B.T., Inc. to become a participating employer. The Plan was also amended October 31, 2017 to allow Jaco Transportation, Inc. to become a participating employer. The following description provides only general information. The Plan document should be consulted for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a 401(k)-feature covering all employees of the Company. Employees who are eighteen years or older can enter the Plan and commence elective deferrals on the first day of the month following the date of being hired. Participants are eligible to receive discretionary matching and profit-sharing contributions on the first day of the month following their completion of one year of service (consisting of 1,000 hours of service within one employment year) if they are still employed by the Company at year end. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The plan administrator oversees governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of eligible pretax compensation up to the maximum allowed by law. Participants are also permitted to make contributions as "Roth" contributions. In addition, participants may contribute distributions from other qualified plans (rollovers). Each year the Company may elect to make a matching and/or profit-sharing contribution to the Plan at the discretion of the Company's Board of Directors and subject to limitation by law. Participants must be employed at year end to participate in Company contributions. For 2024, the Board of Directors elected to match 25% of each employee's annual contribution, up to a maximum of 2.5% of eligible compensation. All contributions are participant directed.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching and allocations of discretionary contributions and Plan earnings (losses) and charged with the participant's withdrawals or distributions and an allocation of administrative expenses. Allocations are based on participant account balances as defined in the Plan document. The benefit to which a participant is entitled is the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants' vesting of Company contributions plus actual earnings thereon is based on years of service. A participant vests 20% after two years of credited service and each year thereafter, until 100% vested after six years of credited service. Upon death, disability, or retirement, as defined by the Plan document, a participant will become fully vested.

1. Description of Plan (continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans require repayment within no more than 5 years, or up to 30 years if for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest must be paid ratably through payroll deductions or otherwise in at least equal quarterly installments.

Forfeited Accounts

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. At December 31, 2024 and 2023 forfeited non-vested accounts totaled \$3,170 and \$9,641. Forfeitures will be used to reduce employer matching contributions. For the year ended December 31, 2024, no forfeitures were used to reduce employer matching contributions.

Payment of Benefits

Upon termination of service due to disability or retirement, a participant, or his or her beneficiary, may elect to receive one of the following forms of payment equal to the value of the participant's vested interest in his or her account: 1) Lump sum; 2) Life annuity; 3) Survivor annuity; or 4) partial distribution. In those cases where the vested balance, excluding rollovers, is less than \$7,000, a participant will receive the value of the vested interest as a lump sum distribution. Death benefits paid to a beneficiary will be paid in a lump sum distribution.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Fair Value Measurements (continued)

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares/units of the registered investment companies are valued at quoted market prices. The registered investment companies of the Plan are deemed to be actively traded. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administration fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

5. Common/Collective Trusts

The State Street Cash Series U.S. Government Fund Class L (the “Cash Series Fund”) is a collective investment fund issued by State Street Global Advisors Trust Company. The Cash Series Fund invests in U.S. Government securities and in repurchase agreements collateralized by U.S. Government securities. Participants may purchase units of the Cash Series Fund daily based on the established unit value of \$1. Net investment income is distributed to participants monthly and is reinvested to purchase additional units of the Cash Series Fund.

The State Street S&P 500 Index Securities Lending Series Fund Class IX, State Street S&P MidCap Index Non-Lending Series Fund Class J, and State Street Russell Small Cap Index Securities Lending Fund Class VIII (the “Funds”) are collective investment funds issued by State Street Global Advisors Trust Company. The Funds hold U.S. and non-U.S. stocks and cash. Participants may purchase units of the Funds daily based on the established unit value. The principal value per unit of the Funds is determined at the end of each day by dividing the net assets by the number of outstanding units. Units are issued and redeemed at their unit value. Net investment income and realized and unrealized gains and losses on investments are not distributed to participants but are reflected in the unit value.

6. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the prototype document preparer, ADP, by a letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

6. Tax Status (*continued*)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions for periods since 2021; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan Document, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts. In the case of a partial termination, only those who separate from service will become fully vested.

9. Risks and Uncertainties

The Plan invests in various types of investment securities. Investment securities are exposed to various market risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.
