### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of White Space Design 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of April 1, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits for the period January 1, 2025 through April 1, 2025, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 – Description of Plan

The following description of the White Space Design 401(K) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General and eligibility

The Plan was established on January 1, 2023, as a defined contribution plan. The Plan covers all eligible employees of White Space Design, Inc. (the Company, Employer or Plan Sponsor). Eligible employees are full time employees who have completed two hundred fifty (250) hours within a three (3) month period, as defined in the Plan document. There is no age requirement for eligibility to participate. An eligible employee may enter the Plan on the first day of the month following the date the eligible employee completes the service requirements. The Company is the Plan Administrator.

Transamerica Financial Life Insurance Company (Transamerica), the Agent for Reliance Trust Company, (the Trustee) is the Plan's Custodian to hold the Plan's investment assets, and Transamerica's affiliate, Transamerica Retirement Solutions, LLC (TRS), provides recordkeeping services. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Plan merger

Effective April 1, 2025, the Plan Sponsor executed an adoption agreement with Choice Pooled Employer Plan III (successor plan), a pooled employer plan, and transferred the participant accounts and substantially all of the Plan's assets totaling \$1,579,208 to the successor plan. The financial statements reflect activity in the Plan through the date of transfer, April 1, 2025.

##### Contributions

Each year, participants may voluntarily contribute up to 90% of their annual compensation, as defined by the Plan, within the limits prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Roth 401(k) contributions are permitted under the Plan's provisions.

The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Automatic enrollment deferral contributions are increased by 1% each year subsequent to enrollment up to 6%. Participants direct the investment of their contributions into various investment options offered by the Plan.

Through April 1, 2025, the Company made a qualified automatic contribution arrangement (QACA) safe harbor match which is equal to 100% of the first 1% of a participant's eligible compensation, plus 50% of the next 6% of the participant's eligible compensation, as defined, that a participant contributes to the Plan. For the period ended April 1, 2025, the Company's QACA safe harbor matching contribution totaled \$56,194. The Company may make additional discretionary contributions to the Plan. No such discretionary contributions were made during the period ended April 1, 2025. Participants are eligible for the Company's safe harbor or discretionary contributions after meeting the eligibility requirements to participate in the Plan. All Employer contributions are invested in funds in accordance with the participant's direction and the Plan's provisions.

Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of: (a) the Employer's contributions (if any) and (b) Plan earnings or losses thereon. Participants are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All participant contributions are participant-directed and may be invested into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their individual contributions. Participants fully vest in their Employer's QACA safe harbor contributions after two (2) years of credited service, plus actual earnings or losses thereon based on a two year cliff vesting schedule. Vesting in the Employer's discretionary contributions, plus earnings or losses thereon, is based on years of credited service. A participant is 100% vested in the Employer's discretionary contributions after six years of credited service based on a six-year graded vesting schedule. Regardless of years of service, participants are 100% vested upon reaching normal retirement age (65), becoming disabled, or upon death or termination of the Plan.

Forfeitures

Forfeited nonvested accounts may be used to offset Plan administrative expenses or reduce future Employer contributions. For the period ended April 1, 2025, \$3 in forfeitures were used to offset Plan administrative expenses. At April 1, 2025 and December 31, 2024, unallocated nonvested forfeited account balances totaled \$7,897 and \$5,222, respectively. The forfeited nonvested accounts were transferred to the successor plan on April 1, 2025.

Notes receivable from participants

Plan participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loans are secured by the vested account balance in the participant's account and bear interest at the Prime Rate plus 1% per year and is fixed for the term of the loan. Principal and interest are paid ratably through regular payroll deductions. All loans are required to be repaid within a period of five years, except loans to acquire the participant's principal residence which must be repaid in a reasonable period of time, not to exceed thirty years. Any delinquent notes receivable from participants are recorded as distributions under the Plan's provisions.

Payment of benefits

On termination of service due to death, disability, or normal retirement age (65), a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum distribution. For termination of service due to other reasons, a participant may choose to leave the vested interest in the Plan if such amounts exceed \$5,000 or elect a lump-sum distribution. Participants with vested amounts less than \$1,000 must elect a lump-sum distribution. Participants may take in-service withdrawals upon attainment of age 59½ or for immediate and heavy financial hardship needs, as defined.

Plan administration

The Company is the Plan Administrator, and as such, controls and manages the operations of the Plan. The Plan's investment assets are maintained by Transamerica as agent for Reliance Trust Company, the trustee of the Plan. Transamerica invests cash received, interest and dividend income and makes distributions to participants (subject to the direction of participants).

Plan administration, continued

The Plan Sponsor contracted with TAG Resources, LLC to act as the Plan's third-party administrator and fiduciary. The Plan allows certain administrative expenses to be paid directly from Plan investment assets.

**Note 2 – Summary of Significant Accounting Policies**

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts which are valued at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan management and its advisor determine the Plan's valuation policies utilizing information provided by the investment advisor and Custodian.

Interest income is recognized when earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from such estimates, and those differences could be material.

Risks and uncertainties

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the high level of risk associated with certain investment securities, including the uncertainty related to changes in the values of investment securities, it is at least reasonably possible that changes in such risks in the near-term would materially affect participant account balances the amounts reported in the financial statements.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Related fees are recorded as administrative expenses and expensed as incurred. If a participant ceases to make scheduled repayments and the Plan Administrator deems the participant note receivable to be in default, the note receivable balance is reduced, and a benefit payment recorded. There was no reserve for credit losses on notes receivable from participants at April 1, 2025 and December 31, 2024.

Payment of benefits

The Plan records benefits when paid.

**Note 2 – Summary of Significant Accounting Policies, Continued**

Administrative expenses

The Plan allows certain administrative expenses to be paid from Plan investment assets. Certain administrative expenses are paid directly by the Plan Sponsor and are not reflected in the financial statements.

Uncertain tax positions

U.S. GAAP requires the Plan management to assess its uncertain tax positions for the likelihood they would be overturned upon examination by the IRS. In accordance with this guidance, the Plan management has determined it does not have any positions at April 1, 2025, that it would be unable to substantiate.

**Note 3 – Certified Investment Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Financial Life Insurance Company, the Agent for Reliance Trust Company, the trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of April 1, 2025 and December 31, 2024;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the period January 1, 2025 through April 1, 2025; and
- Investment information included in Schedule H, line 4i – Schedule of Assets (held at end of period) as of April 1, 2025, as shown on the ERISA-required supplemental schedule.

At the request of the Plan's Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and disclosures related to the investments to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 4 – Fair Value Measurements**

Accounting guidance provides a framework for measuring fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 3	Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the applicable methodology used at April 1, 2025 and December 31, 2024.

Following is a description of the valuation methodology used for assets measured at fair value:

*Pooled separate accounts* - Valued at net asset value (NAV) based upon the units of such pooled separate accounts held by the Plan at period-end multiplied by the respective unit value. The unit values of the pooled separate accounts are based upon significant observable inputs but are not based upon quoted market prices in an active market and are therefore considered Level 2 investments within the fair value hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Investment Contract with Insurance Company**

The Plan invests in a fully benefit-responsive investment contract with Transamerica (the issuer) with a contract value totaling \$0 and \$24,703, respectively, as of April 1, 2025 and December 31, 2024. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The effective rate of interest is established every January 1 and July 1 and is based on the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period.

The average crediting rate for the period ended April 1, 2025 was 2.60%. Per the contract's terms, Transamerica may not terminate the agreement prior to the scheduled maturity date.

**Note 5 – Investment Contract with Insurance Company, Continued**

The contract meets the fully benefit-responsive investment criteria and, therefore, is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts, because it is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Transamerica's ability to meet its financial obligations. Transamerica's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with Transamerica. Such events include amendments to the Plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or premature termination of the contract. The Plan Administrator does not believe any events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The Plan Administrator does not believe the termination of the Plan will materially limit the ability of the Plan to transact at contract value with Transamerica and that also would limit the ability of the Plan to transact at contract value with the participants. In addition, certain events allow Transamerica to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan's investment guidelines, a breach of material obligation under the contract, a material misrepresentation, or a material amendment to the agreement without the consent of Transamerica.

**Note 6 – Party-In-Interest Transactions**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Plan's investments are issued, managed, and administered by Transamerica. Transamerica is the agent for the Plan's trustee, Reliance Trust Company, and Transamerica's affiliate, TRS, is the Plan's recordkeeper, and therefore, these transactions with Transamerica, TRS, and the Trustee qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules under ERISA.

Certain administrative functions are performed by officers and employees of the Employer. No officer or employee receives compensation from the Plan for these services.

**Note 7 – Plan Merger**

On April 1, 2025, the Plan merged into the Choice Pooled Employer Plan III (successor plan). Participant account balances along with all Plan assets and liabilities were transferred to the successor plan as of April 1, 2025. The Plan's investment assets continue to be managed by Transamerica under the successor plan.

**Note 8 – Tax Status**

On August 17, 2021, the IRS stated that the Non-Standardized Pre-Approved Profit-Sharing Plan with CODA adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the Plan and its related trust is tax-exempt.

**Note 8 – Tax Status, Continued**

The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the Non-Standardized Pre-Approved letter, however, the Plan Administrator and the Plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**Note 9 – Delinquent Participant Contributions**

The Plan Sponsor is required to segregate participant contributions from its general assets as soon as it is practicable in accordance with ERISA Section 2510.3-102. For the year ended December 31, 2024, the Plan Sponsor failed to timely remit to the Plan certain participant contributions and loan repayments totaling \$29,936. The Plan Sponsor corrected the delinquent participant contributions for lost earnings during 2025.

**Note 10 – Subsequent Events**

The Plan evaluated events occurring subsequent to April 1, 2025 through November 19, 2025, the date on which the financial statements were available to be issued, for matters that should be recorded in the financial statements or disclosed in the footnotes thereto.
