### 1. Description of Plan

The following brief description of the Rainbow Tree Company 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

#### **General**

The Plan is a defined contribution plan sponsored by Rainbow Treecare Company and Subsidiaries (the "Company" and "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Code ("IRC").

#### **Eligibility**

Substantially all employees who have reached 21 years of age, are not subject to a collective bargaining agreement, are not non-resident aliens and residents of Puerto Rico, and are not part-time, temporary or seasonal employees, are eligible to participate in the Plan. Eligible employees may enter the Plan on their date of hire if eligibility requirements are met, or on the date when the eligibility requirements are met as defined by the Plan.

#### **Contributions**

Each year, participants may contribute up to 100 percent of eligible compensation, as defined in the Plan, up to IRC annual limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

The Company, at its discretion, may annually contribute a percentage of each participant's pre-tax annual base compensation. For 2024, the Company matched 50% percent of each participant's first 6% of eligible compensation. Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

The Company can also, at its discretion, make a non-elective contribution that is allocated to participants based on the proportionate share of eligible participant compensation. The Plan did not make a non-elective contribution during the year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Plan's matching contribution and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

#### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions are subject to a graded vesting schedule and are fully vested after six years of service.

#### **Notes Receivable From Participants**

Participants are permitted to borrow up to 50% percent of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000. Only one note may be outstanding at any given time. Notes generally have a term of not more than five years, unless the note is for the purchase of a principal residence in which case the note repayment period may not extend beyond 15 years. The loans are secured by the balance in the participant's account and bear interest at rates of 4.25% to 9.50% at December 31, 2024 and 2023. Notes receivable from participants are valued at their unpaid principal balance plus accrued interest.

### 1. Description of Plan (Continued)

#### **Payment of Benefits**

Upon termination of employment, participants may receive a distribution of the vested portion of their Plan accounts. If the vested account balance exceeds \$5,000 (including rollovers), distribution requires participant consent. If the balance is \$5,000 or less, the Plan will automatically distribute the amount, and if it exceeds \$1,000, it will be rolled over to an IRA unless otherwise directed. Distributions may be made as a lump sum or partial payments, subject to Plan Administrator guidelines. Participants become fully vested upon reaching Normal Retirement Age (65) or upon termination due to disability. Distributions following attainment of age 62 or Normal Retirement Age do not require consent and must occur within 60 days after the end of the Plan Year in which employment ends. Special provisions apply for military service and disability, including full vesting and standard distribution rules.

Active participants may also take distributions from the Plan for reasons of financial hardship or upon attainment of age 59 ½. In-service withdrawals are subject to certain limitations.

#### **Forfeited Accounts**

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is moved from the participant's account into a forfeitures account. The balance in the forfeitures account may be used to pay administrative expenses and to reduce any employer matching contributions to the Plan. At December 31, 2024 and 2023, there was approximately \$7,000 and \$25,000, respectively, of forfeited nonvested account totals in the Plan. Forfeited amounts that were used to reduce Plan expenses and Employer contributions during 2024 totaled approximately \$29,000 and \$21,000, respectively.

### 2. Summary of Significant Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

#### **Accounting Estimates**

Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates and those differences could be material.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value (except for the fixed income guaranteed option, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year are presented in the net appreciation in fair value of investments.

#### **Payment of Benefits**

Benefit payments are recorded when paid.

#### **Administrative Expenses**

All audit and trustee fees are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment transaction fees, record keeping service fees, and fees related to the administration of notes receivable from participants are allocated or charged directly to the participants' accounts and are included in administrative expenses.

#### **Excess Contribution Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed approximately \$23,000 of excess contributions for the year ended December 31, 2024 in 2025.

#### **Fair Value of Financial Instruments**

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Fair Value of Financial Instruments (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Self directed investments: Consists of publicly traded common stock as part of the Alerus managed income program.

#### Recently Issued Regulations

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reform that began with the 2020 CARES act. Most of the provisions of SECURE 2.0 became effective in 2024 and beyond. The Plan Administrator has determined which provisions apply to the Plan and their impact on the Plan.

#### Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through November 14, 2025, the date which the financial statements were available to be issued.

### 3. Information Prepared and Certified by Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A., the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the direction of the Plan Administrator, the Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 5. Fully Benefit-Responsive Contract

The Plan provides a fixed income guaranteed option issued by Reliance Trust Company that simulates the performance of a guaranteed investment contract. Reliance Trust Company maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest that is guaranteed to the Plan.

The contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

### 6. Party-In-Interest Transactions

Certain Plan investments include shares of registered investment company mutual funds managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee for the administrative service totaled approximately \$36,000.

### 7. Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

### 9. Plan Termination

Although the Plan has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.
