All assets and liabilities of the Plan were transferred to the PEP on that date, and the Plan ceased to be a separate, standalone plan. This report covers the short plan year from January 1, 2025 to January 13, 2025. Our opinion is not modified with respect to this matter.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the Dimensions Management of Chippewa Falls 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Dimensions Management of Chippewa Falls, LLC (the Company). The purpose of the Plan is to provide eligible employees of the Company with retirement and other benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective January 1, 2015.

Participation

Employees are eligible to participate in the Plan after having completed two months of service and having reached 21 years of age. The entry date is the first day of the month coinciding with or next following the date on which the eligibility is met.

Funding Policy

A participant may elect to defer up to 100% of his or her compensation on a pretax basis. The Plan also allows for after-tax contributions through its Roth 401(k) account option. All employee contributions are subject to Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation, and their contributions invested in a designated default investment option until changed by the participant.

In addition to elective employee contributions, the Company may make matching contributions, non-elective or discretionary contributions, or required minimum contributions under the Top-Heavy rules. The Company made employer matching contributions of up to 3% of compensation for eligible exempt employees and up to 2% of compensation for eligible non-exempt employees totaling \$0 and \$60,936 for the Plan years ended January 13, 2025 and December 31, 2024, respectively.

Vesting

Participants are vested immediately in their employee contributions plus actual earnings on the contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. The vesting schedule for matching and discretionary employer contributions is as follows:

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures

Amounts forfeited by former participants are used to reduce the Company's contributions to the Plan. Forfeited nonvested accounts in the amount of \$19,162 were included in the transfer of assets to the RetireReady 401(k) Plan on January 13, 2025 to be used to reduce the Company's future contributions to the Plan .

Payment of benefits

Distributions of benefits are made when a participant retires, dies, becomes totally and permanently disabled, or otherwise ceases to be an employee. Participants are also allowed to withdraw all or any part of their vested account balance while still employed, but only after the attainment of age 59½. Hardship distributions are not allowed under the terms of the Plan.

Notes Receivable from Participants

Participant loans are not allowed by the Plan.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by Dimensions Management of Chippewa Falls, LLC (the Company) and are excluded from these financial statements. Fees related to the administration of participant withdrawals and plan administration are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE C - PLAN MERGER**

Effective January 13, 2025 (the "Merger Date"), the Plan was merged with and into the RetireReady 401(k) Plan (the "PEP Plan"), a qualified defined contribution pooled employer plan. This was accounted for as a transfer of assets and liabilities from the Plan to the PEP Plan. In connection with the merger, all assets of the Plan, totaling \$1,090,691, were transferred to the trustee of the PEP Plan. All liabilities and obligations of the Plan were assumed by the PEP. The operations of the Plan ceased as of this date and all participant records and accounts were transferred the PEP's administrative system. The accompanying financial statements reflect the transfer of all assets as a single line item, "Transfer of Assets to RetireReady 401(k) Plan due to Plan Merger" within the Statement of Changes in Net Assets Available for Benefits. The Plan's operations for the short period from January 1, 2025 through January 13, 2025, are presented in these financial statements. A final Form 5500 will be filed for this short plan year.

**NOTE D - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at January 13, 2025 and December 31, 2024, and net appreciation in fair value on investments and interest income for the years ended January 13, 2025 and December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

**NOTE E - TAX STATUS**

The Dimensions Management of Chippewa Falls 401(k) Plan was adopted under the Volume Submitter 401(k)/Profit Sharing Plan sponsored by Goldleaf Partners effective January 1, 2015. The Prototype Plan Sponsor has obtained from the IRS an opinion letter dated June 30, 2020, specifying that the form of this adoption agreement and the basic plan document satisfy, as of the date of the opinion letter, Code Section 401. Although the plan has been amended since receiving the determination letter, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the plan is qualified and the related trust is tax exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - LATE REMITTANCE OF PARTICIPANT CONTRIBUTIONS**

Defined contribution plans must remit employee contributions to the plan as soon as they can be reasonably segregated from the employer's general assets. The Company failed to timely remit participant contributions to the plan totaling \$3,852 and \$6,617 during the plan years ended December 31, 2024 and 2023, respectively. These late deposits were corrected in their entirety in 2025 after the transfer of assets to the PEP Plan.

**NOTE G - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets of the Plan measured at fair value:

Pooled Separate Accounts: the initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value determined in a manner similar to mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

NOTE H - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT WITH EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA

Effective January 1, 2015, the Plan invested in Empower Annuity Insurance Company of America’s (Empower) Key Guaranteed Portfolio Fund. The fund is credited with interest earned based on the stated interest rates over the life of the contract. Withdrawals can be made at any time for the purpose of participant withdrawals or benefit payments at contract value. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The contract is included in the financial statements at contract value, as it is fully benefit-responsive, as reported to the Plan by Empower.

Contract value represents contributions made under the contract, plus earnings, less any participant withdrawals or benefit payments. There are no reserves against contract value for credit risk of Empower or otherwise.

The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. The average yield earned by the Plan for Key Guaranteed Portfolio Fund was 1.45% and 1.41% for the plan years ended January 13, 2025 and December 31, 2024, respectively.
