A. Description of Plan

The following description of the US&S Inc. 401(k) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General.** The plan is a defined contribution plan covering substantially all employees of the Company who have one month of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.
2. **Contributions.** Each year, participants may contribute up to a specified amount or percent of pretax or after-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions in various investment options offered by the Plan. The Company contributes percentage of each Qualifying Contributing Participant's Elective Deferral (and/or Nondeductible Employee Contribution, if applicable) which the Employer, in its sole discretion, determines. The amount, the allocation formula, and the percentage or dollar amount limit applicable to such match, if any, is at the complete and sole discretion of the Employer and may vary. Any Matching Contribution will be allocated in a nondiscriminatory manner based upon each Contributing Participant's Elective Deferrals (and/or Nondeductible Employee Contributions, if applicable). Additional amounts may be contributed at the option of the Company's board of directors. The Company made employer contributions \$134,218 and \$164,949 for the years ending December 31, 2024 and 2023, respectively.
3. **Participant Accounts.** Each participant's account is credited with the participant's contribution, the Company's matching contribution, and allocations of Plan earnings and expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. **Vesting.** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

5. **Payment of Benefits.** On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
6. **Notes Receivable from Participant.** A participant or beneficiary loan can be made to the extent that such loan, when added to the outstanding balance of all other loans to the Participant, would not exceed the lesser of 1) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans during the one year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made, or 2) 50 percent of the Present Value of the nonforfeitable Individual Account of the Participant. For the purpose of the above limitation, all loans from all plans of the Employer and other members of a group of employers described in Code sections 414(b), 414(c), and 414(m) are aggregated. Furthermore, any loan will by its terms require that repayment (principal and interest) be amortized in level payments, not less frequently than quarterly, over a period not extending beyond five years from the date of the loan, unless such loan is used to acquire a dwelling unit which, within a reasonable time (determined at the time the loan is made), will be used as the principal residence of the Participant.

B. Summary of Accounting Policies

1. **Basis of Accounting.** The financial statements of the Plan are prepared under the modified cash method of accounting, which is a special purpose framework other than generally accepted accounting principles. Consequently, investment income is recognized when received and disbursements when made. Securities investments are reflected at fair value and notes receivable from participants are measured at their unpaid balance. Accordingly, the financial statements are not

intended to present the net assets and changes in net assets of the Plan in conformity with generally accepted accounting principles.

2. **Investment Valuation and Income Recognition.** The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note I for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded as received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.
3. **Payment of Benefits.** The Plan records benefit payments to withdrawing participants when paid.
4. **Date of Management's Review.** Subsequent events were evaluated through November 14, 2025, which is the date the financial statements were available to be issued.

C. **Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company (the trustee of the Plan). The Plan's independent accountant did not perform auditing procedures with respect to this information, except for comparing such information to the related information in the financial statements and supplemental schedule.

- D. **Plan Termination.** Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan Termination, participants will become 100 percent vested.
- E. **Tax Status.** The Plan adopted a prototype non-standardized profit-sharing plan with CODA that has received an opinion letter dated April 10, 2014, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

- F. **Forfeited Nonvested Accounts.** The Plan has \$15,172 and \$17,601 of forfeited non-vested accounts at December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, employer contributions were reduced from forfeited nonvested accounts by \$0 and \$6,688, respectively.

G. Plan Administrative Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

H. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the net asset value (NAV) of shares held by the plan at year end.

Common/Collective Trust - The fair value of the investments in common/collective trusts (pooled) funds is determined by each fund's trustee based on the fair value of the underlying securities within the fund, which represent the net asset value of shares held by the Plan at year end. The investment in the trust is carried at fair value based on the closing price on NASDAQ. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates.

I. Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Mid Atlantic Trust Company. Mid Atlantic Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$28,389 and \$13,827 for the years ended December 31, 2024 and 2023. The fees are deducted from participants' account and presented net of investment gain or loss.

The Plan sponsor paid Paychex Securities Corporation, third party administrators, for annual administration fees. Paychex Securities Corporation also receives compensation from the Plan related to individual transactions fees, which are deducted from individual participant accounts.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

An officer of the Plan Sponsor serves as the trustee and plan administrator of the Plan.
