#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### (1) Description of the Plan

The following description of the *TPI Composites, Inc. 401(k) Plan* (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General** – The Plan is a defined contribution plan covering substantially all employees of TPI Composites, Inc. and affiliates (collectively, the "Company" or "Sponsor") who meet the Eligible Employee criteria. An Eligible Employee is defined as an employee who is not (1) bargain class, (2) leased employee, (3) independent contractor or (4) part-time, temporary or seasonal. A part-time, temporary or seasonal employee is an employee who is regularly scheduled to work less than 1,000 hours of service in a year. The Plan Administrator controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Effective January 1, 2024, the Plan transitioned its asset custodian and recordkeeper from Principal Trust Company to Fidelity Management Trust Company. In preparation for the transfer, certain participant accounts were liquidated on December 29, 2023, using the closing values at the end of the business day. The resulting cash, totaling \$2,439,208 as of December 31, 2023, was held in a non-interest-bearing account until the transfer to the new custodian. A total of \$33,484,140 in participant accounts was transferred to Fidelity on January 1, 2024, with the assets being allocated to participant accounts on January 18, 2024.
- B. Plan transfer** – Effective July 1, 2024, the Plan was amended and the Company transferred its automotive business unit to Clear Creek Investments, LLC. The participant accounts related to employees of the automotive business totaling \$9,053,840 were also transferred to the TPI, Inc. 401(k) Plan sponsored by Clear Creek Investments, LLC.
- C. Participant contributions** – Contributions to the Plan are made as directed by participants. Participants may contribute up to 100% of their compensation on a pre-tax basis, as defined by the Plan, subject to certain limitations prescribed by the Internal Revenue Service ("IRS"). The Plan has an automatic enrollment feature, which automatically enrolls Eligible Employees and contributes 3% of eligible compensation for each pay period for those participants who do not opt out of the feature, or elect to contribute at a different percentage. Participants may also contribute amounts representing distributions from other qualified plans as rollover contributions. Participants age 50 and older are permitted to make a catch-up contribution up to \$7,500 for the year ended December 31, 2024.
- D. Employer contributions** – Prior to January 1, 2020, employer matching contributions were made equal to 50% of the first 8% of each participant's 401(k) elective deferral. The Plan Sponsor could also make additional matching and/or qualified non-elective contributions to the Plan at the discretion of the Sponsor. Effective January 1, 2020, the Plan was amended to allow for safe harbor contributions equal to 100% of the first 4% of the participants' eligible compensation contributed as an elective deferral each pay period. The amendment also allows for qualified non-elective contributions at the discretion of the Sponsor. For the year ended December 31, 2024, the Plan made no qualified non-elective contributions.
- E. Investment options** – Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a money market fund as investment options for participants.

(1) **Description of the Plan (continued)**

- F. **Vesting** – Participants are immediately vested in their participant contributions, safe harbor contributions, and qualified non-elective contributions, plus actual earnings thereon. For employer matching contributions made to the Plan prior to January 1, 2020, plus related earnings, participants vest as follows:

1	34%
2	66%
3 or more	100%

The Plan defines a year of credited service to be a Plan year with the participant rendering at least 1,000 hours of service.

- G. **Participant accounts** – Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, Plan earnings and losses are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- H. **Notes receivable from participants** – Participants may borrow against their vested account balances, subject to certain limits. The minimum loan amount permitted is \$1,000. The maximum loan available to a participant is the lesser of \$50,000, reduced by the excess of the participant's highest outstanding loan balance during the preceding one-year period over the current outstanding loan balance at the time of the new loan, or one-half of the present value of the participant's vested interest in their account. Notes receivable from participants are secured by the vested balance in the participant's account. All loans bear a reasonable rate of interest as determined by the Plan administrator, based on the prevailing interest rates charged by lenders for similar loans under comparable circumstances.

Loans will be considered in default if any scheduled repayment remains unpaid at the end of the cure period specified in the Plan's loan procedures (unless payments are deferred for participants on approved leave), or if any principal remains outstanding after the final repayment date. Upon default, the outstanding principal and accrued interest become immediately due and payable. Unpaid loans will be treated as a taxable distribution from the Plan.

- I. **Payment of benefits** – On termination of service due to death, disability, or retirement, a participant or the participant's beneficiary becomes 100% vested in his or her account and receives a lump-sum distribution equal to the value of the participant's account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Amounts contributed on a before-tax basis may only be withdrawn upon demonstration of financial hardship, disability, or after the participants reach the age of 59½ years. Hardship distributions are permitted upon demonstration of financial hardship, as defined by the Plan and applicable regulations of the IRS.

### (1) Description of the Plan (continued)

- J. Forfeitures** – Forfeitures are created when participants terminate employment before becoming fully vested in their benefits under the Plan. These amounts may be used to pay administrative expenses or offset employer contributions made to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$986 and \$1, respectively. During 2024, no amounts of forfeited non-vested accounts were used to offset employer contributions.
- K. Plan termination** – Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. The Sponsor also reserves the right to amend the Plan or contributions in any matter that it considers necessary and permissible by the IRS. In the event of the Plan's termination, participants will become 100% vested in their accounts.

### (2) Summary of significant accounting policies

The significant accounting policies followed by the Plan are as follows:

**Basis of accounting** – The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, income and contributions are recognized when earned and expenses are recorded when incurred.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Administrative expenses are paid by the Plan Sponsor, unless otherwise provided by the Plan document. Expenses relating to specific participant transactions (notes receivable and benefit payments) are charged directly to the participant's account.

**Subsequent events** – The Plan has evaluated subsequent events through November 19, 2025, which is the date the financial statements were available to be issued and noted the following item for disclosure:

On August 11, 2025, the plan sponsor filed for protection under Chapter 11 of the U.S. Bankruptcy Code. Plan assets are held in trust and are not part of the sponsor's bankruptcy estate. Management has evaluated the potential impact of the sponsor's bankruptcy on the plan's ability to continue as a going concern. As of the financial statement date, the impact of the sponsor's bankruptcy on employer contributions, ongoing plan operations, and administrative expense payments is not known. Management has not identified substantial doubt about the plan's ability to continue as a going concern.

### (3) Fair value measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs other than quoted prices that are observable for securities, either directly or indirectly. Examples include matrix pricing utilizing yield curves, prepayment speeds, credit risks, etc.; quoted prices for similar assets in active markets; and inputs derived from observable market data by correlation or other means.
- Level 3 Unobservable inputs, which contain assumptions by the party valuing those assets.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Mutual funds* – Stated at net asset values ("NAV"), which are readily determinable fair values of those shares as they are published daily and are the basis for current transactions.
- *Money market fund* – Stated at cost, which approximates fair value. These investments consist primarily of cash and cash equivalents with values that are readily determinable through published prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value measurements could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, the Plan's investments in mutual funds and the money market fund totaled \$27,480,890 and \$31,044,932 respectively, all of which are measured using Level 1 inputs within the fair value hierarchy.

### (4) **Information covered under certification**

The Plan Sponsor has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Fidelity Management Trust Company certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Interest and dividends on investments
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule H, line 4(i) – schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### (5) **Party-in-interest transactions**

The Company provides all employer contributions to the Plan. Therefore, these transactions are party-in-interest transactions. Certain Plan investments were held in funds managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services provided by the trustee for the year ended December 31, 2024, totaled \$19,055.

Commonwealth Financial Network provides investment advisory services to the Plan; therefore, transactions with this organization also qualify as party-in-interest transactions. Fees paid by the Plan to Ashton Thomas Private Wealth for investment advisory fees totaled \$27,993 for the year ended December 31, 2024.

### (6) **Income tax status**

The IRS has determined that the prototype Plan is designed in accordance with applicable sections of the Internal Revenue Code ("IRC") and informed the trustee of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC.

### (7) **Risks and uncertainties**

The Plan provides for various investment fund options which, in turn, invest in any combination of stocks, bonds and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
