NOTES TO FINANCIAL STATEMENTS
MARCH 31, 2025 AND 2024

Note 1 – Description of Plan

The following description of the UNITE HERE HEALTH Staff Welfare Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan offers health, dental, prescription, and vision benefits to eligible employees of UNITE HERE HEALTH and to their covered dependents. Additionally, the Plan offers short term disability, long term disability and life insurance benefits to eligible employees. Effective January 1, 2021, eligible employees of the Neighborhood Health Center, a wholly owned subsidiary of UNITE HERE HEALTH, and their dependents are covered under the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan offers benefits on a self-funded and insured basis. Medical and prescription benefits are offered on a self-funded and insured basis. Dental benefits are offered on an insured basis. Vision benefits were insured through December 31, 2022, and effective January 1, 2023, vision benefits are self-funded. Disability and life insurance benefits are offered on an insured basis. The Plan also offers Flexible Spending Account benefits to eligible employees. Benefits are offered to employees of UNITE HERE HEALTH who work at least 30 hours per week. Effective January 1, 2021, benefits are offered to employees of Neighborhood Health Center, who work at least 30 hours per week.

Contributions

UNITE HERE HEALTH (the Plan Sponsor) contributes to the Plan the insurance premiums and benefit payments of the Plan. Enrolled employees share in the cost of health benefit coverage by contributing a specified amount each payroll period based upon their selected level of coverage.

The Plan may also receive contributions from participants under the provisions of COBRA (Consolidated Omnibus Budget Reconciliation Act) which provides that participants can elect to continue, for specified periods of time, their health care benefits which otherwise would have been lost due to certain events by making the required contribution.

Note 2 – Summary of Significant Accounting Policies

Basis of Presentation

The financial statements have been prepared using the modified cash basis of accounting, which is a comprehensive basis of accounting other than generally accepted accounting principles. That basis differs from accounting principles generally accepted in the United States of America primarily because the Plan has not recognized balances, and the related effects on earnings, of payables to vendors and the receivables from the sponsor. However, the Plan does record the obligations of benefits for claims incurred but not reported as required for health and welfare plans.

Date of Management's Review

Subsequent events were evaluated through November 19, 2025, which is the date these financial statements were issued. All subsequent events requiring recognition as of November 19, 2025, have been incorporated into these financial statements herein.

Note 2 – Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting described above requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Benefit of Obligations

Plan obligations for estimated claims incurred, but not reported are based upon the Plan's payment history. Amounts represent claims incurred prior to March 31, but not yet submitted for payment. The Plan's benefit obligation for estimated claims incurred but not reported were \$1,324,715 and \$1,180,214 at March 31, 2025 and 2024, respectively. The Sponsor generally funds these obligations as they are presented for payment.

Administrative Expenses

Administrative expenses paid by the Plan represent third-party administrator fees. Any other administrative expenses of the Plan are paid for by the Sponsor.

Note 3 – Tax Status

The Plan is designed to meet the requirements under Section 501(c)(9) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under the present income tax law. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualifications. The Sponsor of the Plan is not aware of any course of action or series of events that have occurred that might adversely affect the Trust's qualified status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Plan Termination

It is the intent of the Sponsor to continue the Plan in full force and effect. However, in the unlikely event of termination and in order to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event the Plan terminates, the net assets of the Plan will be allocated as set forth in the Trust agreement and as prescribed by ERISA and its related regulations.

Note 5 – Plan Amendments
