INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of the
Menarini Silicon Biosystems 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Menarini Silicon Biosystems 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Notes to Financial Statements December 31, 2024 and 2023

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Menarini Silicon Biosystems 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

[1] General:

The Plan is a defined contribution plan covering substantially all employees of Menarini Silicon Biosystems (the “Company”) with the exception of union employees, nonresident aliens and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Nationwide Financial Services, Inc. and Nationwide Trust Company, FSB are the recordkeeper and trustee, respectively. National Benefit Services, LLC provides third party administrator services to the Plan. The Plan was initially established April 1, 2017 and was most recently restated effective November 1, 2023.

Effective February 1, 2025, the Plan sponsor executed a service agreement for recordkeeping services with Fidelity Workplace Services, LLC, appointing Fidelity Management Trust Company as the trustee of the Plan. In addition, the Plan was restated effective February 1, 2025, with no substantial change in the provisions of the Plan. The Plan adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by FMR, LLC. Following the execution of the service agreement, approximately \$8,800,000 in investment assets were transferred from Nationwide Trust Company to Fidelity Management Trust Company and approximately \$105,000 in notes receivable from participant balances were transferred in kind.

[2] Eligibility:

There is no minimum service or age requirement for participation in the Plan. Employees are eligible to enter the Plan beginning with the first payment of compensation made on or after the enrollment date on which the employee becomes eligible to participate in the Plan. Effective February 1, 2025, employees must have attained the age of 18 in order to participate in the Plan.

[3] Contributions:

Participants may contribute up to 80% of pre-tax eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, participants may contribute after-tax amounts representing Roth contributions, as defined by the Plan. In no event may participant pre-tax and Roth contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matches 100% of the first 4% of eligible compensation deferred and 50% of the next 1% of eligible compensation deferred, as defined by the Plan, as 401(k) ADP Test Safe Harbor Contributions (“ADP Contributions”). The Plan also permits the Company to declare additional employer matching contributions up to 6% of eligible compensation, as well as employer nonelective contributions. Such amounts are discretionary in nature. During the year ended December 31, 2024, the Company contributed amounts representing additional employer matching contributions so that, when combined with ADP Contributions, participants received a total employer contribution matching 100% up to 6% of eligible compensation. Total ADP Contributions and additional employer matching contributions approximated \$438,000 and \$131,000, respectively, for the year ended December 31, 2024. Both ADP contributions and additional employer matching contributions were calculated on a quarterly basis. The Company did not contribute any amounts representing employer nonelective contributions during the year ended December 31, 2024.

Effective February 1, 2025, the Company matches 100% up to 6% of eligible compensation, as defined by the Plan, as 401(k) Safe Harbor Matching Contributions. Additional matching employer contributions and nonelective employer contributions continue to be available under the Plan and discretionary in nature.

Participants direct the investment of participant and employer contributions into various investment options offered by the Plan.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[4] Participant accounts:

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, (b) Plan earnings and losses, and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

[5] Vesting:

Participants are immediately vested in their contributions, ADP Contributions, and employer matching contributions, plus actual earnings thereon. Vesting in the employer nonelective contribution portions of their accounts, plus actual earnings thereon, is as follows:

<u>Years of Service</u>	<u>Vesting</u>
0 – 1 year	25%
2 years	50%
3 years	75%
4 years	100%

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, and not have more than two loans outstanding at any given time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate of prime plus 1%, determined at inception of the loan. Interest rates on outstanding loan balances range from 3.25% to 9.50% as of December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[7] Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or monthly installment payments. In service withdrawals are permitted upon attainment of normal retirement age of 59½ and at least five years in the Plan in the form of lump-sum or installment payments. In-service withdrawals are also permitted upon experiencing financial hardship, as defined by the Plan, from a participant’s vested account balance.

[8] Forfeitures:

Forfeited nonvested accounts may be used to reduce future Company contributions and pay Plan expenses. During the year ended December 31, 2024, forfeitures of approximately \$10,000 were used to reduce Company contributions. Forfeited nonvested accounts available at December 31, 2024 and 2023 were approximately \$27,800 and \$9,400, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

[2] Subsequent events:

The Plan has evaluated subsequent events through November 19, 2025, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Participant related transaction fees related to the administration of notes receivable from participants or other participant initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation of fair value of investments.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Nationwide Trust Company, FSB, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Account Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Pooled separate accounts – Valued at net asset value ("NAV"), as a practical expedient, based on the market value of the underlying investments. The NAV is not a publicly-quoted price in an active market. The pooled separate accounts are invested primarily in mutual funds. Certain pooled separate accounts may charge a redemption fee ranging from .50% to 2.00% for investments that are held for less than a period ranging from 30-90 days. There are no unfunded commitments or redemption restrictions.

Self-directed brokerage accounts – Accounts primarily consist of equities and exchange traded funds that are valued based on readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

On February 1, 2017, the Plan entered into a group annuity contract with Nationwide Life Insurance Company. Contributions are maintained in a general account by the insurance company. The contract is reported at contract value. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract and transfers to the contract, plus credited interest on deposits or transfers, less participant withdrawals, transfers out of the contract and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed quarterly, and is guaranteed against change during each quarter once declared. The contract cannot be terminated before the scheduled maturity date. During the year ended December 31, 2024, the average effective interest crediting rate was 1.6%.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan’s failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan’s prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan’s normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

Participants are not permitted to make exchanges from the contract to any other competing fixed investment option for a period of six months. The insurance company may terminate the contact with ninety days' notice.

NOTE F - TAX STATUS

The Plan has adopted a Non-standardized Pre-approved Profit Sharing/Money Purchase/CODA sponsored by National Benefit Services, LLC. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risks related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Nationwide Trust Company, FSB. Nationwide Trust Company, FSB is the Plan trustee, therefore, transactions related to these investments qualify as party-in-interest transactions. Participants are also charged certain participant initiated transaction fees by Nationwide Financial Services, Inc. and National Benefit Services, LLC, the Plan's recordkeeper and third party administrator, respectively. As service providers to the Plan, fees paid to these service providers qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$3,645 for the year ended December 31, 2024.

NOTE I - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

NOTE J - NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, certain amounts withheld from participants were not timely remitted to the Plan. Untimely remittances of approximately \$81,000 originated during the year ended December 31, 2024. Principal amounts under these remittances were also remitted to the Plan during the year ended December 31, 2024. The Plan administrator is in the process of calculating lost earnings to make the impacted participants whole.
