## INDEPENDENT AUDITORS' REPORT

To the Plan Participants and Trustees of the  
Remedi SeniorCare 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

### 1. DESCRIPTION OF THE PLAN

The following description of the Remedi SeniorCare 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan formed on January 1, 1996. Non-union and non-leased employees become eligible to participate in the Plan upon completion of one month of employment with Remedi SeniorCare Holding Corporation as well as employees of affiliates, as defined in participation agreements and the Plan document (collectively, the Company). Participants may enter the Plan on the first day of the month subsequent to meeting the eligibility requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended and restated effective July 1, 2022 to comply with tax law changes and to increase the automatic escalation maximum.

Effective January 1, 2025, the Plan merged into the Clarest Health 401(k) Plan (the CH Plan). In connection with the merger, all Plan investments were liquidated on December 31, 2024, and the proceeds were reported as due from broker at year-end. The Plan's net assets available for benefits of \$45,950,009 were transferred to the CH Plan during January 2025. The transfer was completed in accordance with the terms of the merger, and the assets were received by the CH Plan in January 2025.

#### Participant Contributions

Participants may contribute any percentage of their eligible compensation, as defined by the Plan, not to exceed the limits established by Section 402(g) of the Internal Revenue Code (the Code). Participants may also contribute Roth elective contributions. Participants Roth elective contributions are allocated to a separate account maintained for such contributions. Roth contributions are treated as elective contributions for all purposes under the Plan. The maximum allowable contributions totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year may make additional catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023. Participants are permitted to make rollover contributions to the Plan.

The Plan includes an automatic enrollment provision in which participants are automatically enrolled into the Plan upon becoming eligible to participate at a deferral rate of 3% of compensation, as defined, unless a participant elects not to contribute, or contribute a different percentage. There is also an automatic increase provision where the automatic deferral percentage will increase each year on the anniversary date for employees automatically enrolled by 1% up to a maximum of 10%.

#### Company Matching Contributions

The Company may provide discretionary matching contributions to eligible participants, equal to a discretionary percentage of participant elective deferrals or a discretionary percentage or dollar amount of eligible participants' compensation to be determined by the Company. Such contributions are calculated on a quarterly basis. For the years ended December 31, 2024 and 2023, there were no additional requirements for contributing employees to share in Company matching contributions. During the years ended December 31, 2024 and 2023, the Company did not elect to make matching contributions.

#### Company Profit Sharing Contributions

The Company may provide profit sharing contributions to eligible participants. Profit sharing contributions are made at the Company's discretion and are allocated pro rata based on each eligible participant's eligible compensation for the Plan year. In order to share in Company profit sharing contributions, participants must have completed 1,000 hours of service and be employed on the last day of the Plan year. Such contributions are calculated on an annual basis. For the years ended December 31, 2024 and 2023, the Company did not elect to make discretionary profit sharing contributions.

#### Participant Accounts

Each participant's account is participant-directed and contributions and withdrawals are credited according to the investment options selected by the participant. Any earnings, gains/losses, and administrative expenses are allocated to the participant's account based upon the investments selected by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement (age 65), or early retirement (age 59½), a participant (or their beneficiary in the event of death) is entitled to a distribution of their vested account balance. In-service withdrawals are also allowed beginning at age 59½. Prior to retirement, distributions from the Plan are payable in the form of a lump sum payment or may be rolled into another qualified retirement plan. If the vested account balance is less than \$5,000, it will be paid upon termination whether or not the terminated employee requests a distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, vested amounts contributed may be withdrawn for a hardship purpose.

Distributions are subject to the applicable provisions of the Plan agreement. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59½. As of December 31, 2024, there were no amounts allocated to participants who had elected to withdraw from the Plan but had not been paid as of year-end. As of December 31, 2023, there were \$2,000 in net assets available for benefits payable to participants who had elected to withdraw from the Plan but had not been paid as of year-end.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company matching and profit sharing contributions, plus actual earnings thereon, is based on years of service, according to the following schedule:

Participants become 100% vested in discretionary Company matching and profit sharing contributions at the time of death, total or permanent disability or upon attainment of retirement.

#### Notes Receivable from Participants

Participants may borrow up to 50% of their vested account balance, not to exceed \$50,000. The minimum note amount is \$1,000. Only one note may be outstanding at any given time. Notes for any purpose other than the purchase of a primary residence must be repaid within 5 years. Extended note amortization is allowed for purchase of a principal residence. Notes are secured by the vested balance in the participant's account and bear interest at rates that commensurate with commercial rates in the local lending area for similar type notes at the date of note origination. Principal and interest are paid ratably through payroll deductions.

#### Forfeitures

Forfeitures may be used to pay Plan administrative expenses as well as future Company matching and profit sharing contributions. For the years ended December 31, 2024 and 2023, respectively, forfeitures of \$802 and \$2,935, were used to pay Plan administrative expenses. As of December 31, 2024 and 2023, there were forfeitures of \$1,487 and \$220 available to the Plan, respectively.

#### Plan Expenses

The Plan's administrative expenses are paid with assets of the Plan, unless paid by the Company, at its discretion. Plan expenses paid by the Plan sponsor are excluded from the Plan's financial statements. Distribution and loan fees are paid by the Plan and its participants. Investment related expenses are included in net appreciation in fair value of investments.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to net assets available for benefits and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### **Risks and Uncertainties**

The Plan invests in various investment securities that are exposed to risks, such as interest rate, credit and market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the method used for assets measured at fair value:

*Interests in registered investment companies:* Valued at the closing price of shares held by the Plan at year end. Funds are traded in an active market.

#### Fair Value Measurement – cont’d.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in the method used as of December 31, 2024 and 2023.

There were no Plan investments at fair value as of December 31, 2024.

#### Payment of Benefits

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are treated as distributions based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Subsequent Events

The Plan evaluated for disclosure any subsequent events through November 12, 2025, the date the financial statements were available to be issued and determined there were no material subsequent events that warrant disclosure except as disclosed in Notes 1 and 9.

### 3. INVESTMENTS

All investment data contained in the accompanying financial statements, including assets held at December 31, 2024 and 2023 and interest and dividend income and net realized and unrealized appreciation in fair value of investments for the years then ended, was obtained or derived from the information supplied to the Plan administrator and certified as complete and accurate by Ascensus as authorized agent for Ascensus Trust Company, the Trustee of the Plan.

### 3. INVESTMENTS – cont'd.

In connection with the merger (Note 1), the Plan sold certain investments on December 31, 2024 that were to be liquidated under the merger. Investments liquidated on December 31, 2024 but not settled as of year-end are reported as due from broker on the statement of net assets available for benefits at December 31, 2024.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by an affiliate of Ascensus Trust Company. The Plan loans funds to its participants according to the applicable provisions of the Plan agreement. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

### 5. INCOME TAX STATUS

The Plan has adopted a non-standardized pre-approved plan sponsored by Legacy Retirement Solutions, LLC. The pre-approved plan received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The Plan has been amended since receiving the favorable opinion letter. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. Given the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements.

The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants affected by the termination will become 100% vested in their accounts. As of January 1, 2025, the Plan merged into the CH Plan (Notes 1 and 9).

### 7. CORRECTIVE DISTRIBUTIONS

During the year ended December 31, 2023, the Plan failed to comply with certain non-discrimination rules. As a result, the Plan was required to make corrective distributions to certain affected participants. Corrective distributions due to participants totaled \$36,364 as of December 31, 2023, and were distributed and paid during 2024.

### 8. OPERATIONAL FAILURES

During 2024, the Company became aware of certain operational failures related to the repayment of participant loans that occurred during Plan year 2023. The Plan Sponsor completed the correction of this failure under the IRS Employee Plans Compliance Resolution System Self-Correction Program (SCP). The correction of such operational failure did not result in any material adjustments to the Plan's financial statements. As of the report date, Plan management and legal counsel believe this issue has been fully remedied.

### 9. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For purposes of the Form 5500, the plan merger described in Note 1 is reflected as occurring as of December 31, 2024. All plan assets, including participant notes receivable and contributions receivable as of that date, were transferred to the CH plan in January 2025.
