INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of D&H 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the D&H 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of D&H Distributing Company, D&H Corporate Group Inc., and D&H Scale LLC (collectively, the Company). Union employees, temporary and seasonal employees who have completed less than one year of service, leased employees, and reclassified employees are excluded from participation in the Plan. Eligible employees may enter the Plan after completion of three months of service. There is no age requirement. The Plan's 401(k) Plan Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute between 1% and 50% of their eligible compensation, as defined in the Plan agreement, on a pre-tax or Roth (after-tax) basis, up to the maximum permitted by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and have their contributions invested in a designated target date fund until changed by the participant. The Plan includes an automatic escalation provision whereby participants enrolled in the Plan will have their deferral rate increased by 1% per year until a maximum of 15% is reached.

The Company may make a discretionary matching contribution, determined annually by the Company's Board of Directors, to eligible participants who are employed with the Company on the last day of the plan year. For the years ended April 30, 2025 and 2024, the Company discretionary matching contribution was equal to 25% of the first 6% of eligible compensation that a participant contributed to the Plan, and totaled \$1,246,242 and \$1,144,082, respectively.

Additional nonelective amounts may be contributed at the discretion of the Company's Board of Directors. No discretionary nonelective contributions were made for the years ended April 30, 2025 and 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's discretionary matching and nonelective contributions, if any, and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investments for their account.

Vesting

Participants are 100% vested at all times in their elective deferrals, rollovers, and Company discretionary matching contributions, plus actual earnings thereon. Participants are vested in the Company discretionary nonelective contribution portion of their accounts based on years of continuous service, as follows:

6 years or more	100%

Regardless of the vesting schedule, participants become fully vested upon death or total and permanent disability.

Notes Receivable from Participants

Participants may not borrow from their fund accounts.

Corrective Distributions Payable

Corrective distributions payable generally represent the refund of certain assets to employees for the Plan to comply with ERISA nondiscrimination rules. Amounts payable to participants totaling \$35,283 and \$35,217 as of April 30, 2025 and 2024, respectively, for contributions in excess of amounts allowed by the IRS, are reflected as a liability in the accompanying statements of net assets

available for benefits. The excess contributions were refunded to the affected participants after the plan year end.

Payment of Benefits

The Plan permits withdrawals when a participant terminates employment, reaches retirement age, or becomes disabled or deceased. In-service withdrawals are also permitted for certain financial hardships and when a participant attains age 65. Benefits are payable in lump-sum payments or installments, subject to reasonable limits regarding timing and amounts as defined in the Plan agreement.

Forfeited Accounts

At April 30, 2025 and 2024, forfeited nonvested accounts totaled \$3,242 and \$3,123, respectively. These accounts may be used to reduce future employer contributions. No forfeitures were used during the years ended April 30, 2025 and 2024.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year, and indirect investment expenses.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. The Company discretionary matching and nonelective contributions, if any, are recorded when the related participant compensation is paid.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through November 20, 2025, the date the financial statements were available to be issued. See Note 10.

3. INVESTMENTS

Empower Trust Company, LLC holds the funds for the Plan and Empower Retirement, LLC maintains an individual account for each participant. Contributions made on a participant's behalf under the Plan are directly allocated to that participant's account and are invested, based on the participant's direction, in various mutual funds, self-directed brokerage accounts, and/or a common collective trust.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Offered through Charles Schwab & Co., Inc. Personal Choice Retirement Account and includes interest-bearing cash and common stocks. The carrying value of interest-bearing cash approximates fair value. The fair value of the common stocks is based on quoted market prices.

Common collective trust: A stable value fund that is valued at the NAV of shares of a collective investment trust based on audited financial statements of the fund. NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. INFORMATION CERTIFIED BY A QUALIFIED INSTITUTION

Certain information summarized below related to the accompanying financial statements and ERISA-required supplemental information was obtained by Plan management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan:

- Investment balances included in the statements of net assets available for benefits at April 30, 2025 and 2024, and in the notes to the financial statements.
- Investment income included in the statements of changes in net assets available for benefits for the years ended April 30, 2025 and 2024, and in the notes to the financial statements.
- Information included in the accompanying schedule of assets (held at end of year).

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company nonelective contribution portion of their accounts.

7. TAX STATUS

The Company has adopted a pre-approved plan provided by Empower Retirement, LLC. The pre-approved plan received an opinion letter dated November 14, 2022, in which the IRS stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the IRC.

In addition, the opinion letter stated that an employer who adopts this pre-approved plan may rely on the opinion letter with respect to the qualification of its own plan under the IRC. Although the Plan has been amended since the pre-approved plan received the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

A related party is any party who can control or significantly influence Plan management or operating policies. Parties in interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to, the custodian, trustee, third-party administrator (TPA), investment managers, investments advisors, legal counsel, and Plan auditor.

During the years ended April 30, 2025 and 2024, the Plan made direct payments of \$57,578 and \$43,398 to certain parties in interest for recordkeeping and investment advisory/management fees, as allowed by ERISA. The Company pays directly any other fees related to the operation of the Plan.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

10. SUBSEQUENT EVENT

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in the 2026 plan year and beyond. Plan management is evaluating these provisions and will update the Plan's governance and operations.
