Opinion on the 2024 Financial Statements

We have audited the accompanying financial statements of FM Systems Group, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for plan benefits as of March 31, 2024, and the related statement of changes in net assets available for plan benefits for the period from January 1, 2024 to March 31, 2024, and the related notes to the financial statements.

(1) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America and present the net assets available for plan benefits and changes in those net assets of FM Systems Group, LLC 401(k) Profit Sharing Plan (the "Plan").

Johnson Controls acquired FM Systems Group, LLC in July 2023, and as a result became the sponsor of the Plan. On October 3, 2023, the Trustees of the Plan approved the merger of the Plan into the Johnson Controls Retirement Savings and Investment Plan ("JCRSIP"). Effective January 1, 2024, the Plan was frozen. Each active participant in the Plan as of December 31, 2023 became a participant in the JCRSIP as of January 1, 2024. All participant account balances were legally transferred to the Johnson Controls Retirement Savings and Investment Plan on March 31, 2024. The net assets of the Plan, consisting of investments and participant loans totaling \$9,066,497, were transferred to the JCRSIP and the Plan was legally terminated.

(b) Fair Value Measurements

For determining fair value measurements, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Management follows an established framework for measuring fair value. That framework provides a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are described below:

Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly

Level 3: one or more significant inputs or significant value drivers are unobservable or based on market assumptions

(c) Investments

Investments in pooled separate accounts are reported at fair value based on net asset values provided by Principal Life Insurance Company ("Principal"). Guaranteed interest accounts are reported at fair value as provided by Principal (Level 3). The contract value of the guaranteed interest accounts approximates fair value.

Liquidation of the entire contract with Principal may cause a one-time adjustment to the contract value resulting in a fair value different from the contract value. This total liquidation is a contingent event which cannot be initiated by the Plan participants, and can only be initiated by the Plan trustees upon termination of the Plan, or complete change of funding vehicle.

(c) Investments, Continued

Investment transactions are accounted for on the trade-date basis. Investment income is recognized when earned. There are no unfunded commitments as of March 31, 2024 and December 31, 2023.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

(e) Administrative Expenses and Investment Fees

Certain administrative expenses, such as for member services, are paid by the Plan. Certain investment management fees are charged to the individual funds in the Plan and are included in the net appreciation (depreciation) in the fair value of investments. Certain administrative expenses are absorbed by the Plan sponsor.

(f) Benefits

Benefits are recorded when paid.

(g) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that affect the reported amounts of net assets available for plan benefits and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets available for plan benefits during the reporting period. Actual results could differ from those estimates.

(h) Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service, if applicable, are recorded as a liability with a corresponding reduction to employee contributions.

(2) Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

The Plan, a defined contribution plan initially sponsored by FM Systems Group, LLC (the "Company"), and now sponsored by Johnson Controls, was created in 1998 to provide retirement and disability benefits to employees of the Company, and to compensate and reward them for continuous, loyal and faithful service. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(2) Description of Plan, Continued

Eligible employees must be at least 21 years of age and may participate in the Plan on the first day of the calendar month following their date of hire.

Each Plan participant has two individual accounts: an employee pre-tax account which is funded by reductions in the employee's compensation and an employer matching account which is funded by employer matching of employee salary reduction contributions. In some cases, the participant may have a rollover account balance as described in note 3. The employee pre-tax account and employer matching account are fully vested at all times.

Upon death, disability, or retirement at age 65, the participant or beneficiary may elect to receive a distribution of the employee pre-tax account and the employer matching account in a lump sum or in another payment form approved by the plan administrator. Upon termination of employment for any other reason, including early retirement, participants are entitled to receive a distribution of their employee pre-tax account and the vested portion of their employer matching account.

The Plan's recordkeeper and custodian was Principal. Principal offers numerous investment options in which Plan participants can elect to invest their allocated contributions.

(3) Contributions

Eligible employees were able to make contributions through payroll deductions by electing to reduce their compensation by a percentage of their annual compensation. Salary deferrals for 2023 were limited to \$22,500, in accordance with the Internal Revenue Code. The employer may match a percentage of the employee contribution, based upon the discretion of the employer. In 2023, the employer matched 100% of the first 3% and 50% on the next 2% for a maximum match of 4% (when an employee contributes 5%).

In addition, the employer could make additional discretionary contributions to the Plan. No such additional contributions were made during 2024 and 2023.

The plan administrator established and maintained individual accounts for each participant. Individual accounts were also maintained for all former participants who have not received distribution of the vested amounts held for their account. Allocation of the net investment earnings was made on the ratio that the balance of each participant's account on the preceding January 1 bears to the balance of the accounts of all participants on that date. For this purpose, however, account balances are reduced by amounts distributed to participants during the year.

Participants could deposit "rollovers" (distributions from other qualified plans) into the Plan.

The Plan was funded with a group annuity contract with Principal. Contributions were made to the contract and were then invested in a variety of investment choices as directed by each participant. The investment objectives and underlying investments of the pooled separate accounts vary. Plan participants should refer to the Plan enrollment forms and prospectuses of the underlying investments for full descriptions of the investment strategies and redemption provisions of each individual pooled separate account.

As of December 31, 2023, investments under the contract were invested in pooled separate accounts and guaranteed interest accounts. The guaranteed interest accounts, which were not benefit responsive, represented amounts held in the general assets of Principal, which offered interest rate and principal guarantees. The rate of return totaled approximately 1.0% in 2023. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

During 2024 and 2023, the Plan's investments (including investments bought, sold and held during the year) appreciated in value \$603,016 (uncertified) and \$1,349,693, (certified) respectively.

Interest earned on investments totaled \$822 (uncertified) and \$452 (certified) in 2024 and 2023, respectively.

(5) Notes Receivable from Participants

Loans could be made from Plan assets to participants on a nondiscriminatory basis. Borrowings by participants could not exceed 50% of their vested participant account balance or \$50,000, and were subject to plan provisions. All notes were evidenced by a negotiable promissory note bearing interest at a reasonable interest rate and were secured by the participant's account balance. There was \$96,456 in notes receivable from participants as of December 31, 2023. These loans bore interest at rates ranging from 5.25% to 10.50% and were due at various times through 2028. Interest earned on loans totaled \$2,368 and \$9,468 in 2024 and 2023, respectively.

(6) Federal Income Taxes

The Plan's custodian has received a letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the prototype plan which the Company has adopted is acceptable under the applicable requirements of the Internal Revenue Code (the "Code") for use by employers for the benefit of their employees. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes the Plan was designed and was operated in compliance with the applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress

(7) Related Party Transactions

Certain Plan investments were shares of pooled separate accounts and guaranteed interest accounts managed by the custodian of the Plan and, therefore, such transactions qualified as party-in-interest transactions.

(8) Nonexempt Party-in-Interest Transactions

In 2022, it was discovered that during 2022 and previous years, the Company did not properly withhold certain participant contributions in accordance with Plan provisions related to employee commissions. These amounts totaled \$59,055 for 2022 and previous years. As a result, the Company owed the Plan approximately \$192,015 (including related Company match on these and certain other employee commissions, and estimated lost earnings) as of December 31, 2022. In 2023, the Company corrected the error by contributing \$202,181 to the Plan, which included cumulative estimated lost earnings.

At this time, management of the Company lacks sufficient information to determine an estimate of any potential taxes or penalties that may be levied by the IRS or Department of Labor as a result of the matter noted above.

(9) Subsequent Events
