### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

We have performed audits of the financial statements of PB Tech & Advisory, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (in liquidation) as of June 6, 2024 and December 31, 2023, the related statement of changes in net assets available for benefits (in liquidation) for the period January 1, 2024 through June 6, 2024, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 6, 2024 and December 31, 2023 and for the period ended June 6, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### ***Basis for Opinion on the Financial Statements***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. ### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As described in Note 1 to the financial statements, plan management adopted an amendment to terminate the plan on March 31, 2024, and management determined that liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to that matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. ## **Note 1. Description of Plan**

The following description of the PB Tech & Advisory, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

### ***General***

The Plan was a defined contribution plan covering substantially all employees of PB Tech & Advisory LLC (the “Company”) who had three months of service and had attained age 21. The Plan Administrator controlled and managed the operation and administration of the Plan. Benefit Trust Company served as the trustee of the Plan (“Guideline”) through January 15, 2023. Effective January 15, 2023, the Plan switched to Principal Trust Company (the “Trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### ***Termination of Plan***

On March 31, 2024, the Plan management adopted an amendment to terminate the Plan effective March 31, 2024. Contributions ceased to the Plan and affected participants became fully vested in their accounts. All assets were liquidated by June 6, 2024. As a result, the 2024 financial statements are presented under the liquidation basis of accounting as liquidation of the Plan was determined to be imminent during 2024.

### ***Contributions***

Prior to Plan termination, each year, participants could have contributed compensation, as defined in the plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participant salary deferrals could have been traditional 401(k) (pretax) or Roth 401(k) (after-tax). Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could have also contributed amounts representing distributions from other qualified plans and certain individual retirement accounts. The Plan included an automatic enrollment provision whereby all newly eligible participants were automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in accordance with the Plan’s investment policies, until changed by the participant. The Company contributed safe harbor matching contributions equal to 100% of the first 6% that a participant contributed to the Plan. Contributions are subject to certain limitations.

### ***Investment Options***

Participants directed the investment of their accounts into various investment options offered by the Plan. The Plan offered mutual funds as options.

### ***Participant Accounts***

Each participant’s account was credited with the participant’s contribution and allocations of the Company’s contributions, plan earnings (losses), and charged with benefit payments. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that can be provided from the participant’s vested account.

### ***Vesting***

Participants were immediately vested in all contributions plus actual earnings thereon.

***Notes Receivable from Participants***

Prior to Plan termination, participants could have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the participant's highest outstanding note balance during the prior twelve-month period. The loans were secured by the balance in the participant's account and bore interest at prime rate plus one percent. Principal and interest were paid ratably through payroll deductions.

***Payment of Benefits***

Upon termination of service, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount option as provided by the Plan. Amounts contributed could have only been withdrawn upon demonstration of financial hardship, disability, or after the participant reaches the age of 59.5 years.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that may affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustees. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities were recorded on a trade-date basis. Interest income was recorded on an accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from plan participants and non-elective contributions from the Company are recorded in the year in which the participants' contributions are withheld from amounts paid. All participant and Company contributions are participant-directed.

***Notes Receivable from Participants***

Notes receivable from participants were measured at their unpaid principal balance. Delinquent participant loans were reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits were recorded upon distribution to Plan participants.

**Administrative Expenses**

The Plan's administrative expenses were paid by the Company, as provided by the plan document. Certain administrative functions were performed by employees of the Company. No such employee received compensation from the Plan.

**Subsequent Events**

The Plan has evaluated subsequent events through October 21, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgement, and may affect the valuation of fair value asset and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at June 6, 2024 and December 31, 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Note 5. Exempt Party-In-Interest Transactions**

Certain Plan investments were funds managed by the Trustee, as defined by the Plan and, therefore, these transactions qualified as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the Trustee by the Plan for administrative services were \$32,921 for the period ended June 6, 2024.

**Note 6. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the standardized pre-approved plan that it is utilizing. The IRS has determined and informed by a letter dated June 30, 2020 that the pre-approved Plan document was designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.
