Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Refinery 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from the agent on behalf of the qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information provided to the management by the agent for the qualified institution, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and schedule of nonexempt transactions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1. DESCRIPTION OF THE PLAN

The following description of The Refinery 401(k) Plan (the Plan) is provided for general information purposes only. Participants and other interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Refinery 401(k) Plan (the "Plan") is a defined contribution plan established effective January 1, 2007, and is sponsored by Waldberg, Inc. dba The Refinery and its related employer, The Refinery AV, LLC (together, the "Company" or "Plan Sponsor"). The Plan covers substantially all employees of the Company who are at least 18 years old and have completed three consecutive months of service. Eligible employees may enter the Plan on the first day of the quarter following satisfaction of these requirements. The Plan is administered in accordance with the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 27, 2024, the Plan was amended to comply with the provisions of Setting Every Community Up for Retirement Enhancement (SECURE) Act of 2019. As a result, long-term, part-time (LTPT) employees who have attained age 21 and completed at least 500 hours of service in three consecutive 12-month periods are now eligible to make elective deferrals under the Plan beginning in the Plan year starting on January 1, 2024.

On December 22, 2024, Refinery AV, LLC (RAV), a division of the Plan Sponsor, was legally separated from the Plan Sponsor and sold as part of a corporate restructuring. See Note 7.

Contributions: Participants may elect to contribute to the Plan a percentage or dollar amount of compensation as elective deferrals or Roth contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The maximum employee deferral permitted by the Internal Revenue Service (IRS) for the year ended December 31, 2024 was \$23,000. Catch-up contributions of \$7,500 was available to participants who had attained age 50 or older by December 31, 2024, and had not exceeded Internal Revenue Code (IRC) pretax dollar contribution limits for the Plan year.

The Company may make matching contributions for each eligible participant who is participating in the plan equal to 50% of the salary deferral up to 6% of compensation. Effective May 27, 2024, the Plan was amended to eliminate Company matching contributions. Company matching contributions made prior to the elimination was \$132,473 for the year ended December 31, 2024. The Company may also make discretionary profit sharing contributions for employees who are employed by Waldberg, Inc. dba The Refinery on the last day of the Plan year and are credited with at least 1,000 hours of service during the Plan year. The employees of The Refinery AV, LLC are not eligible for discretionary profit sharing contributions. The Company made no discretionary profit sharing contributions for the year ended December 31, 2024.

NOTE 1. DESCRIPTION OF THE PLAN (Continued)

Participant Accounts: Each participant's account is credited or charged with the participant's contributions and allocations of (a) the Company's contribution, (b) the Plan earnings (losses), and (c) administrative expenses. Allocations of the Plan earnings (losses) for investments are based on participants' account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their employee contributions. Participants are vested in the Company's matching and discretionary profit sharing contributions according to the following schedule:

Years of Service	Percentage Vested
1	20%
2	40%
3	60%
4	80%
5 or more	100%

Notwithstanding the above, if a participant (1) dies, (2) incurs a disability while employed by the Company or (3) satisfies the conditions for early retirement age, the Company's matching and discretionary profit sharing contributions become 100% vested without regard to years of service.

Notes Receivable from Participants: Participants may borrow from their vested account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The notes receivable are secured by the vested balances in the participants' accounts and bear interest at prime rate (7.50% at December 31, 2024) plus 1%. Principal and interest are paid ratably through payroll deductions or participants' own personal funds over a term not to exceed five years, or 30 years for notes receivable borrowed for the purpose of purchasing a principal residence.

Investment Options: Participants may direct the investments of their compensation deferrals, rollover contributions, and Company matching and discretionary profit sharing contributions in various investment funds offered and held by Ascensus Trust Company.

Benefit Payments: Upon retirement, termination of service, death or disability, a participant or beneficiary is entitled to receive a partial or a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are permitted from elective and Roth deferrals in cases of financial hardship or for qualified reservist. Financial hardship withdrawals are subject to applicable excise and income taxes. If a terminated participant's vested account is less than \$5,000, his or her total vested benefit will be automatically rolled over to an IRA selected by the Plan Administrator.

Forfeitures: Forfeited Company matching and discretionary profit sharing contributions may be used to pay administrative expenses of the Plan or reduce Company contributions of the Plan. During the year ended December 31, 2024, the Plan Sponsor used \$55,753 of forfeitures to reduce Company matching contributions. The forfeitures balances available as of December 31, 2024 and 2023 were \$27,212 and \$75,401, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires the Plan Administrator to make estimates and assumptions that affect certain amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income (Loss) Recognition: Investments are reported at fair market value. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Money market funds are stated at their carrying values, which approximate fair values.

Realized and unrealized appreciation (depreciation) are based on the market value of the assets at the end of the Plan year compared to the market value of the assets at the beginning of the Plan year, or at the time of assets purchased or exchanged during the Plan year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions Receivable: Employee and employer contributions are recognized in the period related to the participant's service or compensation.

Notes Receivable from Participants: Notes receivable from participants are reported at their outstanding principal balances, plus any accrued but unpaid interest.

Benefit Payments: Benefit payments are recorded as expenses when paid.

Administrative Expenses: The Company incurs certain expenses in administering the Plan, which are not passed on as expenses of the Plan. Administrative expenses charged to the Plan consists of processing fees, loan origination and maintenance fees.

NOTE 3. CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the financial information included in the Plan's financial statements as it relates to investment assets, investment transactions, investment income, cash, notes receivable from participants and the schedule of assets held at end of year have been derived from information certified as complete and accurate by Ascensus LLC, the recordkeeper of the Plan, as agent of Ascensus Trust Company, the custodian of the Plan, in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4. TAX EXEMPT STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan which received a determination letter dated June 30, 2020 from the IRS, which stated that the form of the Plan is acceptable under the applicable sections of the IRC. The Plan was most recently amended on May 27, 2024, but the Plan Administrator believes that the Plan is currently designed and operating in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to December 31, 2021.

NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

The majority of the Plan investments include mutual funds managed by The Vanguard Group Inc. ("Vanguard"). During the year ended December 31, 2024, the Plan paid \$18,830 to Vanguard. Vanguard utilizes Ascensus as a subcontractor for the day to day recordkeeping services for the Plan. Therefore, these transactions qualify as party-in-interest transactions as defined by Section 3(14) of ERISA.

NOTE 7. PLAN ASSET TRANSFER RELATED TO SALE OF REFINERY AV, LLC

On December 22, 2024, RAV was legally separated from the Plan Sponsor as part of a corporate restructuring and was sold. After the sale, RAV and The Refinery are no longer in the same controlled group. RAV did not terminate the employees when the Plan transferred approximately \$5.8 million of vested account balances, representing approximately 28% of total Plan assets, related to the employees of the RAV to a new plan (New Plan) on March 12, 2025. Since the New Plan's provisions are the same as the Plan and RAV is no longer part of the controlled group with the Plan Sponsor, no partial Plan termination has occurred.

NOTE 8. PLAN TERMINATION

While the Company currently has no intention to terminate the Plan, it reserves the right to discontinue contributions or terminate the Plan at any time, subject to ERISA provisions. In the event of a full Plan termination, all participants would become 100% vested in their accounts.

NOTE 9. CORRECTIVE DISTRIBUTIONS

Amounts payable to participants for contributions in excess of amounts allowed by the IRS of \$21,804 and \$38,992 were recorded as liabilities in the accompanying statements of net assets available for Plan benefits as of December 31, 2024 and 2023, respectively. Corrective distributions relating to 2024 and 2023 plan years were paid out during 2025 and 2024 Plan years, respectively.

NOTE 10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11. FAIR VALUE MEASUREMENTS

In accordance with accounting principles generally accepted in the United States of America, the Plan establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in active markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following methods and assumptions were used to estimate the fair value of each class of assets:

There were no changes in methodologies in the years ended December 31, 2024 and 2023.

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that were assigned with the United States Securities and Exchange Commission. These funds were required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Money market funds are valued at carrying value, which approximates fair value.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 12. REVERSION OF FORFEITURES

Under the terms of the Plan, forfeitures of nonvested Company contributions may be used to offset future Company contributions or pay plan administrative expenses, as specified in the plan document. During the year ended December 31, 2024, \$28,503 in forfeitures was improperly reverted to the Plan Sponsor, which is not permitted under the Plan or applicable ERISA and IRS regulations. The Plan Sponsor has acknowledged the error and restored the full amount, including lost earnings of \$2,402, to the Plan on November 5, 2025. The restoration will be recognized as an addition to Plan assets upon receipt. As of December 31, 2024, the Plan has recorded \$28,503 as other receivable on statements of net assets available for benefits. Management has determined that, aside from the disclosure and correction described above, this error does not have a material effect on the Plan's financial statements.
