#### **1. Plan Description**

The following description of Anthem Memory Care 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan was established to provide a retirement savings program for eligible employees of Anthem Memory Care LLC (the “Company” or “employer”) and certain adopting affiliated entities. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). The Company is the plan administrator; accordingly, certain members of its management have been appointed to be responsible for overseeing the Plan’s operations including determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

##### **Eligibility**

All employees who have completed three months of consecutive service or one year of credited service are eligible to participate in the elective salary deferral portion of the Plan and receive employer matching contributions, if any. Upon satisfaction of the respective eligibility requirements, participants may enter the Plan on the first day of the next month.

##### **Contributions**

Each year participants may contribute a percentage or fixed amount of their annual compensation, as defined. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan permits after-tax elective deferrals (“Roth Elective Deferrals”). Participants may also contribute amounts representing distributions from certain other qualified plans. Under the terms of the plan document, the employer is permitted to make discretionary matching or profit sharing contributions to the Plan. For the year ended December 31, 2024, the employer elected to remit no matching or profit sharing contributions to the Plan. Participants direct the investment of all contributions credited to their accounts into the various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

##### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, employer matching contributions, and allocations of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company contributions portion of participant accounts is based on years of credited service. Participants vest according to a six year graded vesting schedule at the rate of 20 percent per year after two years of credited service. A participant is 100 percent vested after six years of credited service.

##### **Notes Receivable from Participants**

Participants may not borrow from their accounts in the Plan.

#### **Payment of Benefits**

On termination of service due to death, disability, resignation, discharge, retirement or proven hardship, a participant is eligible to receive a payment or payments in aggregate amounts up to the total value of the participant's vested interest in his or her account. Hardship withdrawals are permitted from the employee deferrals and employer matching portions of participant accounts.

#### **Forfeited Accounts**

Forfeited nonvested accounts may be used to reduce future employer contributions.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to certain participant initiated administration expenses are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

In preparing these financial statements, management has evaluated subsequent events through November 24, 2025, the date the financial statements were available to be issued.

#### 3. Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023. Fair values are provided by the custodian for all of the Plan’s assets as follows:

- **Cash:** Deposits with no stated maturity, such as cash accounts, are valued at the amount payable on demand.
- **Pooled separate accounts:** Pooled separate accounts are valued at the unit value as reported by the issuer of the accounts each day the principal market is open. The fair value of investments in this category has been estimated by the investment manager using the net asset value of the underlying investments, which consist primarily of mutual funds, per unit of participation. The unit value of the Plan’s investments in pooled separate accounts is not a publicly quoted price in an active market. There are currently no significant redemption restrictions on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Related Party and Party-In-Interest Transactions

Certain of the Plan's investments are managed by John Hancock Life Insurance Company ("John Hancock"). John Hancock is the Plan's investment custodian; therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid at the investment fund level rather than by direct payments from the Plan. During the year ended December 31, 2024, the Plan made direct payments to certain vendors totaling \$49,380 for contract administration and participant withdrawal fees. The plan sponsor pays directly certain other fees related to the Plan's operations.

#### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the employer contributions portion of their accounts.

#### 7. Plan Tax Status

The Plan has adopted a volume submitter agreement as the plan document. The volume submitter agreement obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable

requirements of the Internal Revenue Code (“IRC”). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **9. Delinquent Participant Contributions**

As reported on the supplemental schedule of (II) Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain participant contributions were not remitted to the Plan within the time frame required by the Department of Labor (“DOL”) for the years ended December 31, 2024 and 2023. Late remittances of participant contributions constitute nonexempt prohibited transactions between the Plan and the Company under ERISA. The Company is in the process of correcting these transactions via the calculation and remittance of lost earnings to the Plan in accordance with applicable DOL correction programs.
