GeoTol Inc was late in filing 5500's for the year 2022 and for the first part of 2023 as we had undergone a move from FL to CO and changed accountants. It was a complete oversight as our old accountant had always completed the forms for the company, but the new accountant did not do these when filing our taxes and we were not aware of this change.

Also, in 2023 we closed the Technical Consultants Inc 401K account and opened a new GeoTol retirement account. The 2023 5500 was filed for the new GeoTol retirement account, but again the Technical Consultants 401K account closing was missed as we were not aware that our new accountant was not filing these for us.
