Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Go Kids Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025 and June 30, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Go Kids Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's rules and regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Trust, a qualified institution, as of and for the year ended June 30, 2025, and from American Trust Services, a qualified institution, as of and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Go Kids Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Go Kids Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Go Kids Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statement.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Go Kids Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter-Supplemental Schedules Required by ERISA

The supplemental schedule of assets held for investment purposes at the end of the year is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description:

The following description of the Go Kids Retirement Plan (“Plan”) only provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan was amended and restated with an effective date of October 1, 2024. The Plan is a defined contribution plan covering employees age eighteen or older, as defined in the Plan, of Go Kids, Inc. (“Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The sponsor organization of the Plan is the Company.

Effective with the Plan amendment and restatement on October 1, 2024, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also rollover amounts from other qualified retirement plans and participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Participants direct the investment of the contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective trust fund as investment options. The Company contributes a safe harbor contribution of 3% of an eligible participant’s compensation into the plan. In addition, the Company may contribute a profit-sharing amount to the plan as determined by the Company’s board of directors.

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution, (b) Plan earnings, (c) Plan expenses, and (d) forfeitures of terminated participants’ nonvested accounts. Allocations are based on participant earnings, gross compensation, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants are immediately vested in their contributions plus actual earnings thereon as well as any safe harbor contributions. The Company’s profit-sharing contributions, and earnings thereon, are 100 percent vested after three years of credited service, or once they reach normal retirement age.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant’s vested account balance and bear interest at 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. The interest rate is fixed on the day of the loan and remains constant during the term of the loan. Principal and interest are paid ratably through payroll deductions.

Upon termination of service, a participant with a vested balance in excess of \$5,000 may elect to receive a lump-sum amount equal to the value of his or her account that is vested, installments over a period not more than their or their and their beneficiary(ies) assumed life expectancies, or partial withdrawals of at least \$1,000. If a participant’s vested balance does not exceed \$5,000, then a lump sum distribution will be made as soon as is administratively feasible. Vested account balances in excess of \$1,000 require the participant’s consent prior to distribution.

As of June 30, 2025 and June 30, 2024, forfeited nonvested accounts totaled \$85,716 and \$33,142, respectively. These accounts will be used to either reduce future employer contributions or restore prior participants’ forfeited accounts. For the year ended June 30, 2025, \$85,716 of forfeited balances will be applied to the employer contributions. For the year ended June 30, 2024, \$33,142 of forfeited balances was applied to the employer contributions.

2. Summary of Significant Accounting Policies:

The financial statements of the Plan are prepared using the accrual method of accounting.

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued):

The Plan's investments are stated at fair and contract values. Shares of regulated investment companies are valued at quoted market prices that represent the net asset value of shares held by the Plan at year-end. Collective trusts are valued at the contract value of participant units held by the Plan as of the last trading day of the period, as reported by the managers of the trust. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Benefits are recorded when paid.

The employer bears all salary related expenses for personnel administering the plan and may, at its discretion, pay some of the Plan's administrative expenses.

Investment securities are exposed to various risks, such as interest rate, market, and currency fluctuations, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for plan benefits and statement of changes in net assets available for plan benefits.

Certain accounts in the prior year financial statements have been reclassified for comparative purposes to conform to the presentation in the current year financial statements.

3. Investments:

The Plan's registered investment company investments are stated at fair value in the accompanying statement of net assets available for benefit. FASB ASC 820-10, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of quoted prices for identical or similar assets or inputs that are derived principally from or corroborated by observable market data by correlation or other means, and Level 3 inputs consist of unobservable inputs and have the lowest priority. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or level 2 inputs were not available.

Level 1 Fair Value Measurements- The fair value of mutual funds are based on quoted net asset values of the shares held by the plan at year-end. The fair value of money market funds are based on quoted prices in active markets for identical securities.

Level 2 Fair Value Measurements: The fair value of the fixed annuity is based on the unit price of shares held by the plan year end. Unit price is determined subtracting total Fund liabilities from total Fund assets and dividing the remainder by the number of units outstanding. The Fund's assets are valued at fair market value. The Fund intends to hold only those assets whose fair market value is the contract value of the investment.

Level 3 Fair Value Measurements - Level 3 inputs were not used.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The information as of and for the years ended June 30, 2025 and June 30, 2024 included in the financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the trustees in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

During the years ended June 30, 2025 and June 30, 2024, the Plan's investments (including investments bought, sold, and held during the year) appreciated in value by \$ 729,420 and \$546,916. These net changes were attributable to the Plan's fair and contract value holdings in mutual funds and the collective trust.

4. Investment in Collective Trust:

The Plan offers as one of its investment choices a fully benefit-responsive guaranteed investment contract and related wrapper contract, which collectively is known as a "synthetic GIC" arrangement, with the Empower Annuity Insurance Company ("EAICA"). The account is maintained in a collective trust fund and is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The synthetic GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the synthetic GIC is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The synthetic GIC is presented on the face of the statement of net assets available for benefits at contract value in arriving at net assets available for benefits. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than .15%. Contract value, as reported to the plan by EAICA and Empower Trust Company, N.A., represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The total contract value of investment contracts held at June 30, 2025 and 2024 was \$1,432,103 and \$2,353,239, respectively. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the Plan's ability to transact at contract value. Such events include amendments to the plan documents (including complete or partial plan termination or merger), changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the plan, or failure of the trust to qualify for exemption from federal income taxes. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. Related Party Transactions:

Participant loans, in the amount of \$382,247 and \$242,066, were outstanding as of June 30, 2025, and June 30, 2024, respectively. In addition, \$3,644,141 and \$2,353,239 of investments as of June 30, 2025 and June 30, 2024, respectively, were deemed to be held by parties-in-interest under ERISA. Exceptions to the party-in-interest prohibited transaction regulations apply to these related party transactions.

7. Plan Termination:

Although it has not expressed any interest to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

8. Tax Status:

The Plan obtained an opinion letter, dated March 31, 2008, in which the Internal Revenue Service stated that the form of the Plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal revenue Code. Therefore no provision for income taxes has been included in the Plan's financial statements. Furthermore, the Plan administrator has determined the application of ASC 740-10 did not have a material impact on its financial statements. Returns for the years ended June 30, 2021 through 2025 remain open for examination by the appropriate government agencies.

9. Subsequent Events:

Management has evaluated subsequent events through November 25, 2025, the date on which the financial statements were available to be issued.
