## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

**NOTE 1 — DESCRIPTION OF THE PLAN**

The following description of the Overland Sheepskin Co. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established to provide retirement benefits for employees of Overland Sheepskin Co. (the Company or Plan Administrator). Employees are eligible to participate in the Plan after completing one month of employment and after attaining eighteen years of age. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration**

The Company has contracted with The Vanguard Group (Vanguard), Ascensus, LLC (Ascensus), and Ascensus Trust Company (Ascensus Trust) to perform certain custodial, recordkeeping and administration services.

**Contributions**

Eligible employees may contribute up to 100% of eligible compensation, subject to certain limitations established by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans in the form of rollovers. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes a safe harbor Company matching contribution equal to 100% of employee contributions up to 5% of eligible compensation. The Company may also make discretionary profit-sharing contributions, which are allocated among eligible employees whether or not they make contributions to the Plan. There were no profit-sharing contributions during the years ended April 30, 2025 and 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

**Vesting**

Participants are immediately vested in their elective deferrals, safe harbor matching contributions, profit sharing contributions, and any earnings thereon.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five (5) years from the date of the loan, unless the loan is used to purchase a dwelling unit to be used as the principal residence of the participant. The loans are secured by the balance in the participant's account and bear interest at 2% over the U.S. Prime rate. Principal and interest are paid ratably through monthly payroll deductions.

**Payment of Benefits**

Upon retirement, death, or termination of employment, participants or their beneficiaries may elect to receive a lump-sum distribution, partial payments as requested from time to time, or equal installments over a specified period of time. If the participant's vested account balance (including rollover contributions) is less than \$7,000 upon termination of service, the participant is required to roll over the funds into another qualified plan or receive a lump-sum distribution. Active employees may also receive a distribution of all or a portion of their account balance upon reaching age 59 1/2 or for specific hardship circumstances.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. If a participant ceases to make loan repayments, the participant has until the end of the calendar quarter following the quarter in which he/she initially defaulted on the loan to make up the missed payments before the loan will be deemed distributed by the Plan as a taxable disbursement to the participant. Notes receivable from participants bear interest at rates ranging from 6% to 10.50% at April 30, 2025.

**Contributions**

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the participant's contributions are withheld from compensation.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 3 — INFORMATION CERTIFIED BY ASCENSUS TRUST**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of April 30, 2025 and 2024, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust, a qualified institution.

**NOTE 4 — FAIR VALUE MEASUREMENTS**

GAAP establishes a three-tier fair value hierarchy, which categorizes the inputs used in measuring fair value. These categories include (in descending order of priority): Level 1, defined as unadjusted quoted prices in active markets accessible at the measurement date for identical, unrestricted assets or liabilities; Level 2, defined as quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar instruments in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at April 30, 2025 and 2024.

- *Money market fund and mutual funds:* Valued based on quoted prices in active markets.

**NOTE 5 — TAX STATUS**

The Plan is using a prototype plan document developed by Ascensus. Ascensus received an opinion letter from the IRS dated June 30, 2020, which states that the prototype plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of April 30, 2025 and 2024, no such uncertain positions exist.

**NOTE 6 — PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, the accrued benefits of all participants shall be distributed to participants as provided in the Plan.

**NOTE 7 — EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan services are managed by Vanguard through its subcontractor Ascensus who provides recordkeeping services. Fees for these services are paid by the Company. UBS provides services to the Plan as a financial advisor and consultant, with fees for these services being paid by the Company. Therefore, these transactions with Vanguard, Ascensus, and UBS qualify as party-in-interest transactions. In addition, certain investment related expenses are included in net appreciation of fair value of investments. A participant who acquires a participant loan is also a party-in-interest. However, all such transactions are exempt and are not prohibited by ERISA.
