## Reasonable Cause Letter – Late Filing of Form 5500

To Whom It May Concern:

I am writing to provide the explanation for the late filing of the Form 5500 for the plan year ending December 31, 2024, originally due July 31, 2024, and to request that any associated penalties be waived due to reasonable cause.

The late filing was not the result of willful neglect, but rather an inadvertent administrative error caused by confusion within the Paychex payroll administrator's website portal. Paychex had prepared the Form 5500; however, the portal contained two separate interface screens ("classic" and "new"), which created uncertainty as to where final review and submission were required.

Because the system did not clearly indicate that formal submission was still pending, I believed the filing process was complete. While conducting year-end planning and reviewing the portal, I discovered that the Form 5500 had not actually been submitted by the July 31, 2024 deadline. As soon as I became aware of the issue, I acted promptly:

- I immediately contacted Paychex to determine why the submission had not occurred and how to resolve it.
- Paychex directed me to contact the Department of Labor for guidance.
- Upon receiving instructions from the DOL (spoke with Patty), I prepared the necessary filing, along with the reasonable cause letter as suggested.

To ensure that this does not occur again, the following steps have been taken:

- A more rigorous internal compliance review process has been implemented for all plan filings.
- All deadlines have been added to our internal compliance calendar with multiple automated reminders.
- Clarified responsibilities and communication protocols with Paychex to ensure that both preparation and submission steps are clearly confirmed going forward. This included having them correct my email address on file.

Given that the late filing resulted from an unintentional administrative oversight and not from willful neglect, and considering the prompt corrective actions taken once the issue was identified, we respectfully request waiver of any penalties associated with the late filing under reasonable cause provisions.
