Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of River Hospital, Inc. 403(B) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

1. Description of Plan:

The following description of River Hospital, Inc. 403(B) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering employees of River Hospital, Inc. (Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Each year, participants may voluntarily contribute a percentage of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Plan Sponsor contributes a discretionary matching contribution, provided the employee has completed one year of service with 1,000 hours and is at least 21 years old.

In 2024, the Plan sponsor provided discretionary matching contributions of up to 2% of the employee's qualified compensation, up to \$2,000.

Participant Accounts:

Each participant's account is credited with (a) contributions and, (b) an allocation of Plan earnings, less allowable expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts can be used to reduce future employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in all elective participant deferrals and participant rollover contributions. Participants are fully vested in employer contributions after completing five years of service.

Investment Options:

Participants direct contributions into a variety of investments offered by Benefit Plans Administrative Services, Inc., some of which are proprietary in nature.

Participant Loans:

Participants may borrow from their fund accounts amounts equal to the lesser of \$50,000 less the highest outstanding balance of loans in the past 12 months or 50% of their account balance. Loan terms range up to five years. The loans are secured by the balance in the participant's account and bear interest fixed at loan inception. Principal and interest is paid by check or other method prescribed by the Plan Administrator.

Payment of Benefits:

On termination of service for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installment payments over a period of not more than the assumed life expectancy of the participant or beneficiary, or defer the commencement of benefits until normal retirement age.

2. Summary of Significant Accounting Policies:

Basis of Accounting:

The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits:

Benefits are recorded when paid.

Investment Valuation and Income Recognition:

The Plan's mutual fund investments are stated at fair value based on quoted prices in active markets.

The pooled separate account is valued based on net asset value per share without further adjustment, as a practical expedient to determine fair value. Net asset value is based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation on investments is charged or credited to the net assets of the Plan.

Participant Loans:

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the plan document.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Subsequent Events:

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through November 10, 2025 (the date the financial statements were available to be issued).

Tax Status:

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

3. Investments (Unaudited):

The following information included in the accompanying financial statements and Schedule of Assets (Held at End of Year) as of December 31, 2024 and 2023 and for the year ended December 31, 2024 was obtained from data that has been prepared and certified to as complete and accurate by Hand Benefits & Trust Company, a division of Benefit Plans Administrative Services, Inc.:

- Statements of Net Assets Available for Benefits – Investments and participant loans.
- Statement of Changes in Net Assets Available for Benefits – net appreciation in fair value of investments, dividends and interest, and participant loan interest.
- Schedule of Assets (Held at End of Year) – all items.

4. Plan Termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

5. Administrative Expenses:

At the discretion of the Plan Administrator, investment expenses have been borne by the Plan participants. The majority of administrative expenses have been borne by the Plan Sponsor.

6. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Non-Exempt Transactions:

During 2024, the Plan Sponsor failed to timely remit certain participant contributions in accordance with Department of Labor regulations. These late remittances are considered non-exempt transactions. Accordingly, they are reported individually as ERISA-required additional information in the Plan's supplementary schedules to the financial statements. In 2025, the Plan Sponsor corrected the 2024 late remittances.
