We have performed audits of the accompanying financial statements of Southeastern Products 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

Note 1—Description of the Plan

The following plan description of Southeastern Products (the “Company”) 401(k) Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering all employees (“participants”) of the Company who have completed 90 days of service and attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Administration – The Plan sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.

Contributions – Plan entrance occurs at the beginning of each quarter at which time eligible employees can decline enrollment, be automatically enrolled at 6% of gross compensation less exclusions or enroll at a chosen deferral rate. Eligible participants may contribute any percentage of pre-tax annual compensation to the Plan, subject to the Internal Revenue Code (“IRC”) limitations for 401(k) plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Such contributions, if any, are recorded as rollover contributions in the accompanying financial statements. Matching contributions are made at the discretion of the Company’s Board of Directors. The Company made a matching contribution equal to 25% of participant contributions, up to a maximum of 6% of compensation for the year ended December 31, 2024. The discretionary-matching Company contribution is invested in the same investment options and in the same ratio as the participants have directed their own investments. Company contributions are typically funded when the employee contributions are funded. An additional amount may be contributed at the discretion of the Company’s Board of Directors. No additional discretionary contributions were made for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with (a) the participant’s contribution; (b) the Company’s contributions, if any; and (c) an allocation of the Plan’s earnings. Each participant’s account is charged with participant withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – All participant contributions made to the Plan are fully vested at all times and are not subject to forfeiture for any reason. Company contributions made to the Plan are vested according to number of years of service. The vesting schedule is as follows:

Note 1—Description of the Plan (continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the rate ranging from 4.25% to 9.5% with maturities through 2029 as of December 31, 2024. Principal and interest are paid through payroll deductions.

Payment of Benefits – Withdrawals are made on a lump-sum basis or at the participant's option as a deferred annuity upon retirement, disability, termination, or proof of hardship. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may be used to reduce employer contributions or administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10 and \$-0-, respectively. For the year ended December 31, 2024, \$2,397 in forfeitures were used to reduce employer contributions, and \$-0- were used to reduce Plan expenses.

Hardship Withdrawals – The Plan allows participants to make hardship withdrawals to satisfy certain immediate and heavy financial needs. A participant may request a hardship withdrawal for certain qualifying expenses as defined by the Plan document, and within what the Internal Revenue Service ("IRS") deems an immediate and financial need of the participant.

Note 2—Summary of significant accounting policies

Basis of Accounting – The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator and the Company to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities. Such estimates include those regarding fair value. Actual results, as determined at a later date, could differ from those estimates.

Administrative Expenses – Professional and other fees of the Plan are typically paid by the Company; however, the Plan is allowed to pay for such expenses. For the year ended December 31, 2024, the administrative expenses paid by the Plan were \$8,188. Personnel and facilities of the Company are used by the Plan for its accounting and other activities at no cost to the Plan.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value except for the fully benefit-responsive guaranteed investment contract, which is stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The guaranteed investment contract held by defined contribution plans is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive guaranteed investment contracts since contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits presents the contract value of the guaranteed investment contracts. The statement of changes in net assets available for benefits is also prepared on a contract value basis. See Note 4 for discussion of fully benefit-responsive guaranteed investment contracts.

Note 2—Summary of significant accounting policies (continued)

Management fees and operating expenses charged to the Plan for investments in guaranteed investment contracts and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are netted against the loan proceeds. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Risks and Uncertainties – Investment securities, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

Note 3—Fair value measurements

The Plan follows the fair value measurements topic of Financial Accounting Standards Board Accounting Standards Codification 820, which defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Note 3—Fair value measurements (continued)

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value:

Mutual Funds – For the year ended December 31, 2024, these funds are valued at the daily closing price as reported by the fund. The funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and thus classified within Level 1 of the valuation hierarchy.

Pooled Separate Accounts – For the year ended December 31, 2023, these investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is calculated using quoted prices in active markets and, therefore, considered to be readily determinable and classified at Level 1 of the valuation hierarchy.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan’s policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. There were no transfers between levels for the years ended December 31, 2024 and 2023.

Note 4—Guaranteed investment contract, fully Benefit-responsive

The Plan had a fully benefit-responsive investment contract with Principal Trust Company, which maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer was contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Consequently, the investment was stated at contract value on the statements of net assets available for benefits and was not included within the fair value hierarchy. Contract value, as reported to the Plan by the qualified institutions, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. This investment was no longer available upon the change in qualified institutions as described in Note 5.

The guaranteed investment contracts issuer was contractually obligated to repay the principal and a specified interest rate, generally 1.15%, that is guaranteed to the Plan. The crediting interest rate was based on a formula agreed upon with the issuer on a semi-annual basis.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures of spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 5—Information prepared and certified by the Plan's qualified institutions (unaudited)

The Plan management has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Principal Trust Company (2023 and a portion of 2024) and ADP Retirement Services (Sponsor changed to ADP during 2024), the "qualified institutions" of the Plan, have certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, and guaranteed investment contract, fully benefit-responsive, at contract value, as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

Note 6—Party-in-interest transactions

Certain Plan investments are shares of pooled separate accounts and guaranteed investment contracts managed by trustees of the Plan; therefore, those transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction in the net gain (loss) from investment activity. Notes receivable from participants qualifies as party-in-transactions.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant's contribution remains fully vested and Company contributions, if any, become fully vested. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of such termination.

Note 8—Tax status

The Plan adopted a non-standardized pre-approved profit sharing with a cash or deferred arrangement plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated that the prototype Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.
