To Whom It May Concern:

We are submitting this letter to explain the circumstances that resulted in the late filing of Form 5500 for the plan year ending 07/31/2025, and to request that any associated penalties be waived based on reasonable cause.

The late filing was due to circumstances beyond our control, specifically a miscommunication with our service provider. Last year, ADP submitted Form 5500 on our behalf, which led us to believe that the filing would be handled in the same manner this year. As a result, we were not aware of the requirement to submit it ourselves, and we were unable to file on time. ADP, our third-party administrator, did not notify us in advance, and we were only recently informed that we needed to submit Form 5500 for the current plan year.

As soon as we became aware of the issue, we took immediate corrective action by following ADP's instructions to complete and submit the overdue Form 5500. We have also implemented improved internal procedures to ensure that this does not occur again. To prevent future delays, we have taken the following steps:

- Established a compliance calendar with automated reminders for all retirement plan deadlines.
- Designated a specific employee responsible for annual filings.
- Improved communication protocols with our third-party administrator.
- Conducted an internal review of our benefits compliance processes.
