### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Brinton Woods 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. Description of Plan

The following brief description of the Brinton Woods 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### *General*

The Plan, formerly known as the Frankford Nursing & Rehabilitation Center Employees Savings Trust, is a defined contribution 401(k) plan established effective July 1, 2007, covering substantially all employees of the sponsor companies within a controlled group who have completed six consecutive calendar months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During August 2018, the Plan assets and records for the participants who were previously under: Brinton Woods of Rock Creek, LLC; Brinton Woods of Washington D.C. LLC; Brinton Woods of Denton, LLC; and Brinton Woods of Pikesville, LLC were transitioned from the Plan to the newly established Serenity and Inspire Rehabilitation and Health Centers 401(k) Plan.

Effective February 1, 2019, the following companies were removed from the Plan as sponsors: Brinton Woods of Frankford, LLC and Haven Nursing Home, Inc. Participants under the above sponsors were terminated from the Plan and given the opportunity to take distributions. As a result of the terminations of these participants, the Plan had a partial plan termination. Upon the occurrence of the partial plan termination, all affected Plan participants became fully vested in the employer discretionary matching and profit-sharing contributions.

According to the acquisition agreement dated November 21, 2017, and its amendment on December 27, 2019, LBH Carroll County Nursing and Rehabilitation, LLC became the sole member of Brinton Woods Health Care Center, LLC (the Company) in April 2020. Additionally, the Company terminated its management agreement with Brinton Woods Management Company, LLC and became the sole plan sponsor.

#### *Administration of the Plan*

A third-party administrator processes and maintains the records of participant data. MG Trust Company d.b.a. Matrix Trust Company has been engaged to serve as the custodian. Brinton Woods Health Care Center, LLC serves as the Plan Administrator and is responsible for the day-to-day operations and oversight of the Plan.

#### *Investments*

All investments are fully participant directed. Participants have the right to individually select the percentage of their accounts to be invested among different classifications of investments made available to them through registered investment companies.

#### *Contributions*

Participants may elect to contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Roth contributions are also permitted. A Roth deferral is an elective deferral the participant irrevocably designates as a Roth deferral and is

subject to income tax when contributed to the Plan. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The maximum allowable contribution totaled \$23,000 for the year ended December 31, 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to the limitations imposed by the Internal Revenue Code.

The Company may make discretionary matching and profit-sharing contributions annually. During 2024, the Company elected to match 25% of participants' contributions on the first 3% of compensation per pay period. Company matching contributions totaled \$12,559 for the year ended December 31, 2024. No profit-sharing contributions were provided in 2024.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contribution, and allocations of the Company's discretionary profit-sharing contribution, if any, and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their elective deferral, rollover contributions, and the allocated earnings thereon. A participant's vested interest in the discretionary nonelective and matching contributions is based upon the participant's years of continuous service. A participant will be vested 25% per year, starting in year one, and is therefore 100% vested after four years of service.

### ***Payment of Benefits***

Benefit payments are available to participants upon retirement (age 65), termination of employment, death, attainment of age 59 ½, or disability. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed by the participant may be withdrawn for a hardship purpose.

Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, or delay receipt of benefits if the vested account balance is greater than \$5,000. Account balances under \$5,000 are rolled directly into an IRA while amounts under \$1,000 are distributed by check with a 20% federal income tax withholding. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Distributions are subject to the applicable provisions of the Plan document. Certain income taxes and penalties may apply to withdrawals or distributions prior to age 59 ½.

### ***Forfeitures***

Forfeitures of non-vested participants' accounts shall serve to pay administrative expenses or reduce the Company contributions. As of December 31, 2024 and 2023, there were unallocated forfeited balances of \$0 and \$1,542, respectively. During the year ended December 31, 2024, no forfeitures were used to reduce Company contributions and \$3,935 were used to pay plan administrative expenses.

### ***Notes Receivable from Participants***

Participant loans are not permitted by the Plan.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determine the Plan's valuation policies utilizing information provided by Matrix Trust Company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### ***Contributions Receivable***

Participant contributions and any related employer discretionary matching and profit-sharing contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Company discretionary matching and profit-sharing contributions are recorded in the relevant period in accordance with the terms in the Plan document.

### ***Payment of Benefits***

Benefits are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to specific participant transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through October 10, 2025, the date at which the accompanying financial statements were available to be issued.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by MG Trust Company d.b.a. Matrix Trust Company, a qualified institution.

### **4. Fair Value Measurements**

Accounting standards establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to measurements involving significant unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The level in the fair value hierarchy within which a fair measurement falls is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are registered investments with various investment managers. The fair value of these investments are determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds held by the Plan are traded on national securities exchanges. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Related Party and Party-in-Interest Transactions

Fees incurred by the Plan for investment management and administration services are included in net appreciation in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. During the year ended December 31, 2024, the Plan made direct payments to Harbor Investment Advisory, LLC of \$7,613 for investment advisory services, which was not covered by revenue sharing. During the year ended December 31, 2024, the Plan also made direct payments to Northwest Plan Services, Inc., the third-party administrator, in the amount of \$14,279. The Company directly pays any other fees related to the Plan's operations. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 6. Tax Status

The Plan uses a pre-approved plan document sponsored by CCH Incorporated DBA FTWILLIAM COM (FTWILLIAM). FTWILLIAM received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Delinquent Participant Transactions

During the Plan years ended December 31, 2024, 2023, 2022 and 2021, participant contributions totaling \$248,104 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The related lost earnings for these delinquent contributions were remitted to the Plan during 2025.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of Plan termination, participant accounts will become fully vested and non-forfeitable.

### 9. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.
