NOTE A - DESCRIPTION OF THE PLAN

The following description of the Kinective 401k Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan, formerly known as CFM, Inc. 401(k) Plan was originally effective January 1, 2022 and was amended and restated effective August 31, 2023. The Plan was further amended effective April 1, 2024 by adopting a Fidelity pre-approved defined contribution basic plan document, however, Plan provisions generally stayed the same. The Plan is sponsored by Cash Flow Management, LLC dba Kinective (the “Company”).

General

The Plan is a defined contribution plan. All employees (except residents of Puerto Rico or leased employees) are eligible to participate on the first day following one month of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Effective April 1, 2024, Fidelity Management Trust Company (Fidelity) became the trustee and recordkeeper of the Plan. Bankers Trust served as trustee and recordkeeper prior to Fidelity. During 2023, IMM, LLC 401(k) Plan merged into the Plan.

Contributions

Participants may make pretax contributions to the Plan in flat dollar amounts or a percentage of their eligible compensation subject to certain Internal Revenue Service (IRS) limitations. The Company will make a safe harbor matching contribution equal to 100% of participant’s elective deferrals that do not exceed 4% of their eligible compensation. Participants may also make voluntary after-tax, non-deductible contributions to the Plan. The Company may also make a discretionary non-elective contribution to eligible participants to be determined by the board of directors. There was no discretionary non-elective contribution made to the Plan for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s and the Company’s matching contributions and an allocation of the Company’s discretionary non-elective contribution and Plan earnings. Earnings are allocated by fund based on the ratio of a participant’s account invested in a particular fund to all participants’ investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants may change their investment options at any time.

Vesting

Participants are immediately vested in their elective deferral, after-tax contributions, rollover, and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary non-elective contribution portion of the participants’ accounts is based on years of service.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balances, subject to certain restrictions, and may only have two loans outstanding at any given time. Loan terms range from one to five years, or longer if used for the purchase of a primary residence. The loan is secured by the balance in the participant's account and bears interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other termination, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in his or her account or annual installments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and spouse. In addition, participants may elect in-service withdrawals after reaching age 59½ or for hardship purposes, subject to a minimum of \$500.

Forfeitures

At December 31, 2024 and 2023, there were no forfeited non-vested accounts and there were no forfeitures used to reduce Company contributions or pay for administrative expenses.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Except for the Plan's investments in the Lincoln Stable Value guaranteed investment contract, investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Fully Benefit-Responsive Investment Contract

The Plan's investment contract held with Lincoln Financial National Insurance Company is a fully benefit-responsive investment contract and is required to be reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. See Note E for discussion of fully benefit-responsive investment contract.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Company unless the Plan Administrator directs payment from the Plan's assets.

NOTE C - FAIR VALUE MEASUREMENTS

Under Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, there exists a formal hierarchy and framework for measuring fair value and making disclosures about fair value measurements and the reliability of valuation inputs. Measurement assumes the transaction to sell an asset or transfer a liability occurs in the principal or at least the most advantageous market for that asset or liability. Within the hierarchy, Level 1 instruments use observable market prices for the identical item in active markets and have the most reliable valuations. Level 2 instruments are valued through broker/dealer quotation or through market-observable inputs for similar items in active markets, including forward and spot prices, interest rates and volatilities. Level 3 instruments are valued using inputs not observable in an active market, such as entity-developed future cash flow estimates, and are considered the least reliable.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Money market and mutual funds - Valued at the quoted net asset value of shares held by the Plan at year-end as reported on an active market.

Collective trust fund - The Plan's interest in the Goldman Sachs Stable Value Fund is a collective trust fund and is valued by the trustee based on the Net Asset Value (NAV) of shares held by the Plan at year-end as practical expedient fair value. The fund allows for daily liquidity with no additional days' notice required for redemption for participant-directed transactions at the constant NAV of \$1 per unit. Were the Plan to initiate a full redemption of the fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust for up to 12 months in order to ensure that securities liquidations will be carried out in an orderly manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- Investments and notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2024.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE E - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides the Lincoln Stable Value guaranteed investment contract with Lincoln National Life Insurance Company. Because this account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this account. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses, and is the amount the Plan participant will receive if he or she transfers or surrenders his or her funds out of the guaranteed investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include (1) transfers of assets from the fund into a competing investment option and (2) when total distributions and transfers in the fund exceed certain levels. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by affiliates of Fidelity Management Trust Company, the trustee; therefore, these transactions qualify as party-in-interest transactions. Additionally, notes receivable from participants qualifies as party-in-interest transactions.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Company contributions.

NOTE H - TAX STATUS

The Plan is a Nonstandardized 401(k) Profit Sharing Prototype Plan (Prototype Plan) sponsored by Fidelity Management & Research Company and adopted by the Company. The Prototype Plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Previously, as noted in Note A, the Plan was a Nonstandardized 401(k) Profit Sharing Prototype Plan (Prototype Plan) sponsored by Bankers Trust and adopted by the Company. The Prototype Plan obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in all material respects in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified and that the related trust was tax-exempt as of the financial statement dates.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J – COMPLIANCE MATTERS

As reported on the Schedule H, line 4a - schedule of delinquent participant contributions, certain Plan contributions were not remitted to the trust within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company. The Plan sponsor is in the process of correcting lost earnings and funding into the Plan as soon as administratively possible. In addition, as shown as Other in the Statement of Changes in Net Assets for Benefits for the year ended December 31, 2024, the Company overfunded the Plan for approximately \$329,000, which the Company is in the process of correcting. Once corrected, the overfunding will be transferred to the forfeiture account for future use to reduce Company contributions, in accordance with the Plan document.

NOTE K - SUBSEQUENT EVENTS

Plan management has determined that no events or transactions occurred subsequent to December 31, 2024, and through November 25, 2025, the date the Plan's financial statements were available for issuance, that would require adjustments and/or additional disclosures in the Plan's financial statements, other than as noted below.

During 2025, Nexus Software LLC and Datava Inc. became participating employers in the Plan. The assets of the Nexus 401k Plan were merged into the Plan in February 2025 for approximately \$1,267,000 and the assets of affected Datava Inc. participants were spun off and transferred into the Plan from the Trinet Select 401k Plan for approximately \$738,000.
