### **1. DESCRIPTION OF THE PLAN**

The following description of Inogen, Inc. 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **a. General**

The Plan is a defined contribution 401(k) plan covering all eligible employees of Inogen, Inc. (the Plan Sponsor) (the Company), as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### **b. Eligibility**

All eligible employees may participate in the Plan and receive the Plan Sponsor's discretionary matching contributions and discretionary non-elective contributions upon working one month of service and attaining the age of twenty-one. Union employees and leased employees are excluded from participating in the Plan.

#### **c. Contributions**

Participants may elect to defer up to 80% of their pre-tax annual compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have reached the age of fifty before the end of the plan year are eligible to make catch-up contributions. Effective July 1, 2025, the Plan was amended to allow post-tax (Roth) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company contributes discretionary matching contributions of 40% up to 5% of eligible compensation during the plan year, subject to certain statutory limitations. Participants must be actively participating in order to receive the Company matching contributions. There were \$792,889 of discretionary matching contributions for the year ended December 31, 2024.

The Company may also fund a discretionary non-elective contribution at the discretion of the Company on an annual basis. There was no discretionary non-elective contribution made for the year ended December 31, 2024.

#### **d. Participant Accounts**

Each participant's account is credited with the participant's contributions, an allocation of the Company's contributions, if any, plus earnings or losses thereon, and is charged with an allocation of administrative fees that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are vested in the discretionary employer matching and discretionary non-elective contributions plus actual earnings based on the schedule below:

#### f. Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan allowed is \$1,000. The loans are secured by the balance in the participant's account. Participants may not have more than one loan outstanding at any time. Loan terms range from one to five years, unless for the purchase of a primary residence, in which case the term is thirty years. The interest rate is set at a commercially reasonable rate determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the normal retirement age of 65, with no option for early retirement. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account, installment payments or partial withdrawals. There are also retirement benefits available upon disability or death. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan Administrator will authorize the benefit payment without the participant's consent. Effective January 1, 2024, the involuntary force-out distribution amount was increased to \$7,000 per SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they were suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeitures

Forfeitures represent non-vested Company contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures of terminated participants' non-vested accounts are used to reduce Company contributions or pay plan expenses. There were \$11,799 and \$236,164 of unallocated forfeitures as of December 31, 2024 and 2023, respectively. During 2024, the Plan Sponsor used \$395,181 of forfeitures to reduce discretionary employer matching contributions and pay plan expenses.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

The assets of the Plan are invested in mutual funds and a common collective trust. Mutual fund investments are stated at fair market value as determined by the qualified institution based upon the last reported sales price on the last business day of the plan year. The Plan's interest in the common collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. Gains and losses are recognized as incurred upon sale or maturity of investments or based on market value changes during the period.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$87,486 of defaulted loans that were deemed distributed and included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

#### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions of \$41,351 as of December 31, 2023, to applicable participants during 2024. The Plan had no excess contributions payable as of December 31, 2024.

#### **Contributions**

Contributions from plan participants and the discretionary matching contributions from the Plan Sponsor are recorded in the year which the contributions are withheld from compensation. The Plan Sponsor discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor.

#### **Payment of Benefits**

Benefits paid to participants are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of participant loans and processing of distributions are charged directly to participant accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### **Subsequent Events**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued. Except as noted in Note 1c and Note 1e, there were no other events that met the criteria for recognition or disclosure in the financial statements.

### **3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of units of a common collective trust (CCT). The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the CCT will be sold for an amount different from NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the CCT at an amount different from NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. COMMON COLLECTIVE TRUST

The Plan's investment in the CCT is represented by the CCT's underlying investment in the NYL Anchor Account, as of December 31, 2024 and 2023, which invests in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT is not considered a fully benefit-responsive investment contract and is reported at fair value (see Note 4).

### 6. TAX STATUS

The Plan Sponsor has obtained an opinion letter dated October 6, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. The Plan has a service agreement with ADP Retirement Services who has retained Reliance Trust Company as a subcontractor to provide recordkeeping and trust services. Both ADP Retirement Services and Reliance Trust Company are considered parties-in-interest. Accordingly, transactions with investment funds managed and held by the qualified institution, expenses paid to the Plan's qualified institution out of plan assets, and notes receivable from participants are considered party-in-interest transactions. During the plan year 2024, there were \$54,440 of administrative expenses paid by the Plan to the qualified institution.

### 9. RISKS AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that these changes could materially affect the amounts reported in the statements of net assets available for benefits.

### 10. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2021, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) and loan repayments from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions and loan repayments within the specified time period is a prohibited transaction. The Plan Sponsor intends to take corrective action in 2025.
