## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of AdventHealth Consolidated ERISA 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ## 1. Description of Plan

The following description of the AdventHealth Consolidated ERISA 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### **General**

The Plan is a tax sheltered annuity plan covering eligible employees of AdventHealth Sunbelt Healthcare Corporation (the “Employer”) and other participating employers. During 2023 AIG Federal Savings Bank (“AIG”), Variable Annuity Life Insurance Company (“VALIC”) and Voya Retirement Insurance and Annuity Company (“VOYA”) served as the custodians of the Plan and Fidelity Management Trust Company (“Fidelity”) served as the trustee of the Plan. During 2023 the plan held two separate contracts at Fidelity, the (“old Fidelity contract”) and (“new Fidelity contract”). During 2024 Fidelity held all assets of the Plan and served as the trustee of the Plan.

The Plan was adopted on January 1, 2015 and constitutes a consolidation of the Memorial Health Systems, Inc. Retirement Plan effective January 1, 2015, Helen Ellis Memorial Hospital 403(b) Plan effective January 1, 2015, University Community Hospital Thrift Plan effective January 1, 2015 and West Florida Health, Inc. 403(b) Plan (“West Florida”), effective January 1, 2019. Although the Plan continues to be eligible to qualify as a church plan for periods prior to January 1, 2016, effective January 1, 2016, the trustees of the Plan have elected to have the Plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”) and those provisions of the Internal Revenue Code (“IRC”) to which the Plan would otherwise be exempt as a church plan.

Effective February 7, 2024, a portion of the CommonSpirit Health 403(b) Plan (“CommonSpirit”) was spun off and merged into this Plan on a frozen basis. Individuals with accounts transferred in this transaction became participants of this Plan as of that date. The Plan remains closed to new contributions.

In addition, CommonSpirit Participants’ became participants on February 7, 2024 in connection with the spin-off/merger

CommonSpirit and AdventHealth had a joint venture referred to as Centura. In 2024 that joint venture was dissolved and as a result an additional \$50,976,352 was transferred into the Plan from the CommonSpirit.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

### **Eligibility**

Employees who were previously participants in the Memorial Health Systems, Inc. Retirement Plan, Helen Ellis Memorial Hospital 403(b) Plan, University Community Hospital Thrift Plan and West Florida Plan, are covered by this Plan. Other than the individuals described above, no additional individuals shall be eligible to become participants in the Plan. There are no new participants in the Plan. The Plan is frozen with respect to new participants.

### **Contributions**

No contributions shall be made under this Plan on or after January 1, 2015.

#### ***Vesting***

Participants are 100% vested in their contributions plus allocated earnings thereon.

As of November 1, 2020, participants are 100% vested in employer contributions plus allocated earnings thereon.

There are special vesting schedules for certain prior plans that have been merged into this Plan.

#### ***Forfeited Accounts***

Forfeited accounts are amounts forfeited by employees with a non-vested portion in their account that have terminated their employment and who have withdrawn from the Plan. Forfeited contributions will be used to reduce future Plan expenses. At December 31, 2024 and 2023 forfeited non-vested amounts totaled \$11,772 and \$4,149, respectively. During 2024, Plan expenses were reduced by \$23,687 from the forfeited non-vested accounts and no amounts were allocated back to participant accounts. The increase in forfeitures from 2023 to 2024 is associated with the transfer-in of balances of participants of CommonSpirit.

#### ***Participant's Accounts***

A participant's account is credited with the allocation of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Administrator maintains separate accounting for Roth elective deferral amounts, including those transferred with the CommonSpirit spin-off/merger.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear a reasonable interest rate which is established by the plan administrator. Loan repayments must be made by participants over a term not to exceed five years unless the proceeds of the loan are used to purchase the participant's principal residence. Participants may have a maximum of two loans outstanding at any time.

#### ***Collateral Loans***

In addition to account reduction loans, the Plan offers collateral loans to participants. Such loans do not reduce a participants' account balance; instead that account balance serves as collateral for such loans. At December 31, 2024 and 2023, collateral loans amounted to \$0 and \$11,130, respectively. At December 31, 2024 and 2023, \$0 and \$8,945, respectively, were in default. The collateral loans are secured by the balance in the participants' accounts, and bear interest at 3% per annum.

#### ***Payment of Benefits***

Upon retirement, death, disability, or resignation of a participant, or upon termination of the Plan, a participant or beneficiary may receive a distribution in the form of a lump sum payment. In-service withdrawals of employee contributions are allowed once participants attain age 59½.

#### ***Payment of Benefits (continued)***

Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need. Effective May 2, 2024 the Plan may rely on participant certification and uses the deemed immediate and heavy need standards.

For terminated participants with vested balances less than or equal to \$7,000, the Plan may distribute the account without consent. Unless the participant elects otherwise, such distributions are automatically rolled over to an IRA in the participant's name. For balances less than \$7,000, distributions require participant election. The Plan's cash-out limit will adjust to reflect any future statutory increases when administratively feasible.

Required minimum distributions ("RMD") are administered consistent with SECURE and SECURE 2.0. 5% owners commence by April 1 of the year after reaching the applicable age; non-5% owners may defer to the later of retirement or the applicable age. The Administrator may implement RMD administration through a written policy, which will control to the extent it supplements the Plan's terms.

The Plan permits Qualified Birth or Adoption Distributions ("QBADs") up to \$5,000 per birth/adoption, available within one year of the event. To the extent permitted by law, participants may recontribute prior QBADs within three years.

Participants ordered to active duty for more than 179 days (or indefinitely) may take Qualified Reservist Distributions from elective deferral sources. Under the HEART Act, certain uniformed-service leaves are treated as severance from employment for distribution purposes.

For CommonSpirit Participants, the Plan will continue any installment/annuity elections (including death-benefit elections) that were in effect prior to February 7, 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### ***Use of Estimates***

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the fixed accounts, which are stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Self-directed Brokerage account on the statement of net assets available for benefits consists of money market and mutual funds. The fully benefit responsive insurance company investment contracts are reported at contract value, which represents the beginning balance plus any deposits and credited interest, less any withdrawals, charges, or expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, qualified institution.

### 4. Insurance Company Investment Contracts

#### ***VALIC Fixed Interest Option***

The VALIC Fixed Interest Option, VALIC Fixed Account Plus, and VALIC Short Term Fixed Account (the “Options”) are fully benefit-responsive investment contracts with VALIC. The Options guarantee principal and a rate of return, which is backed by the claims-paying ability of VALIC. Amounts allocated to the Options are placed in the VALIC General Account, where assets are invested to maximize return subject to the constraints of safety, liquidity and diversification.

Generally, participants may transfer assets from the Options into equity options at any time and, after 90 days, from equity options into another fixed-income option such as a money market fund, a stable value fund or certain short-term bond funds, if such “competing options” are allowed in the Plan. The Options are subject to a market value adjustment if the Plan sponsor ever withdraws funds. However, in no event can any amount withdrawn be less than the total amount of contributions accumulated at the contract minimum interest rate less withdrawals.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. The Options are presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

VALIC is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer, VALIC, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A2 as of January 2024), Standard and Poor's (A+ as of January 2024), A.M. Best (A as of January 2024), and Fitch (A+ as of January 2024).

The Options represent approximately 6% and 15% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

### 5. Party-in-Interest Transactions

Certain Plan investments are managed by the record-keeper, custodians and the trustee of the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

### 6. Plan Termination

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to provisions of ERISA.

### 7. Tax Status

The Plan, effective January 1, 2015, represents a consolidation of existing 403(b) tax sheltered annuity and custodial account plans. The Plan is intended to meet the Internal Revenue Service final 403(b) regulations. The Employer believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examination by taxing jurisdictions for periods since 2021.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
