Note 1. Description of the Plan

The following description of the Marietta Dermatology Associates, P.A. 401-K Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Marietta Dermatology Associates, P.A. (the "Practice") who have completed 90 days of service and are age eighteen or older. Employees are also eligible for the Practice's safe harbor contribution at that time. Employees must complete one year of service, defined as 1,000 hours, to be eligible to receive the Practice's discretionary profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

As of December 31, 2024, John Hancock Life Insurance Company (U.S.A) held the plan's certified investment assets and executed the certified investment transactions from August 22, 2024 to December 31, 2024, and Matrix Trust Company held the plan's certified investment assets as of December 31, 2023, and executed certified investment transactions from January 1, 2024 to August 21, 2024 (collectively, the "custodians"). The custodians both meet the definition of a qualified institution as defined in 29 CFR 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA.

Contributions:

Each year, participants may contribute up to the maximum amount allowed by law, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Practice contributes a safe harbor contribution of the first 3 percent of base compensation, as defined. Additional profit sharing amounts may be contributed at the option of the Practice's board of directors. During the year ended December 31, 2024, the Practice made \$873,036 in contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts:

Each participant's account is credited with the participant's contributions, Practice contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their voluntary contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Practice's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after five years of credited service.

Note 1. Description of the Plan, Continued

Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance incurred by the participant during the 12 month period ending on the day before the date on which the loan was made, or 50 percent of their vested account balance. The loan interest rate is equal to the prime rate plus 2 percent, as defined by the Plan. Principal and interest are paid ratably through payroll deductions.

Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump-sum amount as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,075 and \$2,591, respectively. These accounts will be used to reduce future Practice contributions or to reduce Plan expenses. During 2024, no forfeited nonvested accounts were used to reduce Practice contributions or administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Contributions:

Contributions from Plan participants and any contributions from the Practice are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Summary of Significant Accounting Policies, Continued

Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits:

Benefits are recorded when paid.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Practice and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

The Plan has evaluated subsequent events through November 25, 2025, the date the financial statements were available to be issued.

Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

The custodians also certified to the completeness and accuracy of \$899,565 of net appreciation in fair value of investments and \$108,122 of interest and dividends, as well as \$1,621 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Money market fund: The money market fund was invested in the Vanguard Federal Money Market Fund. Fair value is based on the NAV that can be validated with a sufficient level of observable activity (i.e., purchases and sales at NAV).

Pooled separate accounts and stable value guaranteed income fund: Valued at NAV. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a fund, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidation will be carried out in an orderly business manner.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds, common stocks, and exchange traded funds that are valued on the basis of readily determinable market prices. Accounts also consist of money market funds that are valued at NAV based on observable activity (i.e., purchases and sales at NAV) and cash.

Note 5. Non-Fully Benefit-Responsive Investment Contract

The Plan invests in a traditional non-fully benefit-responsive guaranteed income contract with John Hancock Life Insurance Company (U.S.A) ("John Hancock") totaling \$1,688,565 at December 31, 2024. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed income contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed income contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract does not meet the fully benefit-responsive investment contract criteria and therefore is reported at fair value.

The Plan's ability to receive amounts due in accordance with investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Note 6. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the custodians as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan incurs expenses for recordkeeping, contract administration, and investment advisory services. As described in Note 2, the Plan made direct payments for these expenses totaling \$120,864 for the year ended December 31, 2024, which were not covered by revenue sharing. The Practice pays directly any other fees related to the Plan's operations.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Practice has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in the Practice's profit sharing contributions.

Note 8. Tax Status

The Practice has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believed the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

Note 10. Plan Errors and Prohibited Transactions

During the years ended December 31, 2022 through December 31, 2024, the Practice inadvertently failed to make deposits of \$542,793 of participant deferrals and loan repayments within the timeframe as required by the DOL. The DOL considers late deposits, without regard to materiality, to be prohibited transactions. The general rule for deposits of 401(k) withholdings requires that the Practice remit withheld employee 401(k) deferrals and loan repayments to the Plan as of the earliest date on which such amounts can be reasonably segregated from the Practice's general assets, but in no event later than 15 business days after the end of the month in which the contributions were withheld. The Practice made late deposits ranging from 6 to 38 days after the date on which the contribution and loan repayments were withheld for the years ended December 31, 2024, 2023, and 2022.

Note 10. Plan Errors and Prohibited Transactions, Continued

During 2024, the Practice has filed a Form 5330 and paid applicable excise tax for the years ended December 31, 2013 through December 31, 2022. Subsequent to December 31, 2024, the Practice has filed a Form 5330 and paid applicable excise tax for the year ended December 31, 2023. In addition, participant accounts were credited with the amount of investment income which would have been earned had participant contributions and loan repayments been remitted on a timely basis for all late deposits related to the years ended December 31, 2022 and December 31, 2023.

For the late deposits related to the year ended December 31, 2024, the Practice plans to file a Form 5330 and pay applicable excise tax. Participant accounts will be credited with the amount of investment income which would have been earned had participant contributions and loan repayments been remitted on a timely basis.

All excise tax payments and lost earnings credited to participant accounts were made from the Practice's assets and not from the assets of the Plan.


