In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i—schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of The Cramer-Krasselt Profit Sharing/401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of The Cramer-Krasselt Company (the Company) except for employees covered by a collective bargaining agreement, or considered a nonresident alien, intern, or freelancer. Temporary employees are eligible to enroll after completing 1,000 hours of service in a 12-month period from date of hire or in any Plan year thereafter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Company's 401(k) Administrative Committee. The 401(k) Administrative Committee has overall responsibility for the operation and administration of the Plan. The 401(k) Administrative Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Contributions: Each year, participants may elect to make pretax contributions in amounts ranging from 1% to 100% of their compensation up to the maximum amount allowable by the Internal Revenue Service (IRS), provided these contributions will not cause the Plan to exceed the discrimination limits. Additionally, Roth contributions are allowed by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company makes a discretionary matching contribution in an amount equal to that percentage of each participant's elective deferral as determined by the Company from year to year. In 2024, the Company contributed 50% of the first 5% of eligible compensation that a participant elected to contribute to the Plan. For 2024, matching contributions totaled \$345,991. The Company may also make a discretionary profit sharing contribution to the Plan, which will be allocated to participants in accordance with the Plan agreement. The Company's profit sharing contribution was 1% of eligible compensation in 2024. For 2024, profit sharing contributions totaled \$180,119. Contributions are subject to certain limitations.

Vesting: Participants are vested immediately in their elective contributions plus actual earnings thereon. Vesting in the Company's contributions are based on continuous years of service. A participant is 20% vested after one year of service, 40% vested after two years of service, 60% vested after three years of service and 80% vested after four years. A participant is fully vested after five years of credited service.

Participant accounts: Participant accounts are credited with participant contributions and Company matching contributions and allocations of: (a) the Company's profit sharing contribution, if any, and (b) Plan earnings, and are charged with an allocation of administrative expenses. Allocations are based on the participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account, as defined.

Investment options: Upon enrollment in the Plan, a participant may direct Company and participant contributions into any of the investment options offered by the Plan, as more fully described in the Plan's literature. A participant may also choose to have a professional investment manager direct his or her contributions in the same investment options. A self-managed account (PCRA) is offered whereby participants can invest self-directed contributions in various types of investments as described in the Plan's literature. Participants may transfer monies between investments and change investment options daily.

Notes to Financial Statements

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from the vested balance of their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant is limited to one outstanding note at any time. Note terms range from one to five years, however, longer repayment periods, from one to 10 years, are permitted when the note is used for the purchase of a primary residence. The notes are secured by the balance in the participant's account. The applicable rate of interest is the prime interest rate plus 1% per *The Wall Street Journal* as of the beginning of the month of the note. Principal and interest payments are paid through payroll deductions.

Payments of benefits: On termination of service, for any reason, participants may elect to receive either a lump-sum amount equal to the value of their vested accounts or receive regular installments over a period not to exceed their life expectancy. Participants that have attained age 59½ may take in-service withdrawals from vested balances in their accounts. In addition, hardship distributions are permitted if certain criteria are met.

Forfeitures: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$110,000 and \$86,200, respectively. These accounts will be used to reduce future Company contributions or pay administrative expenses. In 2024, approximately \$42,500 of forfeited nonvested accounts was used to pay administrative expenses and approximately \$115,000 was used to reduce Company contributions.

Other income: The Plan receives revenue-sharing income from the Plan's recordkeeper that is generated from the administrative fees that are charged by mutual funds offered under the Plan and is allocated proportionately to participants that hold the funds generating the income. During 2024, the Plan was allocated approximately \$2,800 in revenue-sharing income, which was allocated to participants based on their average daily balance at the end of each quarter.

Note 2. Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded at December 31, 2024 or 2023.

Note 2. Significant Accounting Policies (Continued)

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Administrative expenses can be paid by either the Company or the Plan. Expenses paid directly by the Company are excluded from these financial statements.

Subsequent events: The Plan's management has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified or Provided by Charles Schwab Trust Bank, the Plan Trustee

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of fair value hierarchy under the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Shares of registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Units of collective investment trust: Units of collective investment trusts are valued based on the NAV per unit of the collective investment trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Common stock: Valued at the daily closing price reported on the active market on which the individual securities are traded.

Exchange-traded funds: Valued at the daily closing price reported on the active market on which the individual securities are traded.

Note 5. Related-Party and Party-in-Interest Transactions

Plan investments consist of shares of registered investment companies held, invested and maintained by Charles Schwab Trust Bank, the trustee of the Plan, and an affiliated company and, therefore, these transactions qualify as party-in-interest transactions. Schwab Retirement Plan Services, Inc., an affiliated company, performs administration and recordkeeping services for the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan to Charles Schwab Trust Bank and affiliates for these services were approximately \$50,300 for the year ended December 31, 2024.

Certain administrative functions are performed by officers or employees of the Company for which no compensation was received from the Plan.

Note 6. Income Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated September 21, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.
