INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor and Management Committee of the
Irongate Waikiki LLC 401(K) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Irongate Waikiki LLC 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits – modified cash basis for the year ended December 31, 2023, and the related notes to the financial statements.

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE A – DESCRIPTION OF PLAN

The Irongate Waikiki LLC 401(K) Plan was established on December 21, 2009 to enable eligible employees to save for retirement. The Plan is for the exclusive benefit of eligible employees of Ka La'i Waikiki Beach, LXR Hotels & Resorts, the plan sponsor. The following is a description of the Plan that provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan sponsor operates on the Island of Oahu in the State of Hawaii.

General – The Plan is a salary deferral plan covering employees from the date of hire and does not have a service requirement. Plan participants must be at least 21 years of age to participate, and the plan entry date is a monthly date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may make pre-tax salary deferral contributions to the Plan up to the lesser of 90% of their eligible compensation or \$22,500 in 2023, adjusted annually for the cost of living. Plan participants over age 50 may defer additional catch-up contributions of \$7,500 in 2023. Employees may make rollover and transfer contributions. The Plan also accepts after-tax contributions. Participants are eligible for matching contributions only if they make deferral contributions. For purposes of determining participants matching contributions under the plan, contributions do not include age 50 and over catch-up contributions. For the year ended December 31, 2023 the plan sponsor's funding match was 50% of a participant's first 6% of contributions to the Plan. The Company may also make contributions designated as qualified non-elective contributions (none for the years ended December 31, 2023 and 2022) and allocate them to non-highly compensated employees to help the plan pass one or more annually required Internal Revenue Code nondiscrimination test(s). If made, these contributions are 100% vested.

Participant accounts – Each participant's account is credited with the participant's contribution and the Company's contributions, plus an allocation based on participant earnings, administrative expenses and the Plan's net earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting – Employer contributions made to participant accounts vest 20% after one year of full service, 40% after two years, 60% after three years, 80% after four years, and 100% after five years or more. Vesting is based on the elapse time method and is the total of an employee's countable periods of service without regard to hours of service. Participant voluntary contributions and safe harbor contributions are always 100% vested.

Payment of benefits – The vested amount in each Participant's account is payable upon normal retirement, disability, death, or termination of the Plan by the plan sponsor. Participants may receive the entire value of their accounts in a single lump-sum payment or in periodic payments over their life expectancy. Participants may withdraw all or a portion of their contributions upon a showing of financial hardship and compliance with other restrictions in the Plan. At December 31, 2023 and 2022, net assets included vested benefits available for retired or terminated participants of \$1,766,675 and \$2,035,315, respectively.

Forfeitures – Forfeitures may first be used to pay plan administrative expenses. Forfeitures remaining after paying plan expenses can be used to offset employer contributions. During the years ended December 31, 2023 and 2022, \$27,619 and \$10,530 in forfeitures were applied to offset plan expenses and employer contributions. As of December 31, 2023 and 2022, the Plan had unapplied forfeitures of \$26,816 and \$30,431, respectively.

Notes receivable from participants – Participants may borrow a minimum of \$500 up to 50% of the vested portion of their account balance but not to exceed \$50,000. The loans must be repaid within five years, unless it is for the purchase of a participant's principal residence in which case the loan repayment may not extend beyond 30 years from the date of the loan. Loans are collateralized by the participant's account balance and bear interest at prevailing rates. Principal and interest is paid ratably through payroll deductions.

In-service withdrawals – The following types of withdrawals are available under the Plan: withdrawals after the age of 59 ½; withdrawals of after-tax contributions; hardship withdrawals; withdrawals of rollover contributions; and withdrawals for participants performing qualified military service.

Expenses – Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net change in investments.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements have been prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, certain additions to net assets and the related assets are recognized when received rather than when earned, and certain deductions from net assets are recognized when paid rather than when the obligation is incurred. This basis differs from generally accepted accounting principles primarily because the Plan has not recognized employee and employer contributions receivable and accounts payable to vendors, and their related effects on net assets in the accompanying financial statements.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Unrealized gains and losses are recognized as the fair value of the investments change. Benefits are recorded when paid. Financial instruments that potentially subject the Plan to credit risk include investments, which are fully insured. Future changes in market prices may make investments less valuable. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants are collateralized by vested accrued benefits, and accordingly, no allowance for uncollectible notes receivable from participants is deemed necessary. Interest from notes receivable from participants is recognized under the modified cash basis of accounting.

Use of estimates – The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates, and it is at least reasonably possible that such differences will occur in the near-term.

Risks and uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE D – FAIR VALUE MEASUREMENTS (UNAUDITED)

The Plan records certain of its assets and liabilities at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is measured using valuation techniques consistent with the market approach, income approach, and/or cost approach using observable and unobservable inputs that fall into three broad categories: Level 1 inputs are quoted market prices in active markets for identical assets or liabilities that the Plan has the ability to access at the valuation date; Level 2 inputs are other than quoted market prices included within Level 1 that are observable for the assets or liabilities either directly or indirectly; Level 3 inputs are unobservable inputs for the assets or liabilities and are used to the extent that observable inputs are not available. Observable inputs reflect assumptions market participants would use based on market data from sources independent of the Plan. Unobservable inputs reflect the Plan’s own assumptions about the assumptions that market participants would use in pricing an asset or liability developed based on the best information available in the circumstances.

Registered investment companies (mutual funds) – valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E – ADMINISTRATION OF PLAN ASSETS

Reliance Trust Company serves as the Plan trustee and custodian. ADP LLC serves as the record-keeper of the plan. The determination of the amount, timing, and type of contributions made to the trust fund is made by the plan sponsor. Certain administrative functions are performed by officers or employees of the plan sponsor, who receive no compensation from the plan.

NOTE F – TAX STATUS

In a letter dated October 6, 2020, the Internal Revenue Service issued a favorable determination to ADP, LLC indicating the Plan met the qualification requirements established by Section 401(a) of the Internal Revenue Code. The Plan adopted Cares Act and Secure Act provisions and placed them into operation during the year ended December 31, 2020. The Plan Sponsor amended the plan on March 30, 2022 to bring the Plan into compliance with the legislative and regulatory changes set forth in Internal Revenue Service Notice 2017-37 (i.e., the 6-year pre-approved plan restatement cycle).

Generally accepted accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain tax position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service, the U.S. Department of Labor, or other authorities. Management is not aware of uncertain tax positions required to be recognized and disclosed in the financial statements in accordance with generally accepted accounting principles. Interest and penalties, if any, are classified as income tax expense. The Plan’s tax filings open for examination by the taxing authorities, usually three years after a return has been filed.

NOTE G – TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, all participants will become 100% vested in their accounts.

NOTE H – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan did not pay Reliance Trust Company investment management fees for the year ended December 31, 2023. The Plan paid ADP LLC fees of \$5,551 during the year ended December 31, 2023.
