### NOTE 1: DESCRIPTION OF PLAN

The following description of the SDI Innovations, Inc. (the Company) Retirement Readiness 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A) **General**--The Plan is a defined contribution plan covering all employees of the Company who have one month of service and are age 21 or older, with no minimum hour's requirement. During 2023, there was a six-month service requirement. Effective January 1, 2024, the Plan was amended to require a three-month service requirement. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.
- B) **Contributions**--Each year, participants may contribute up to 100% of their pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company matches 100% of the first 4% of employee contributions. Additional amounts may be contributed at the option of the Company's Board of Directors. Contributions are subject to certain limitations.
- C) **Participant Accounts**--Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D) **Vesting**--Participants are immediately vested in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's discretionary and profit-sharing contribution portion of their accounts plus actual earnings thereon was based on years of continuous service. Participants become vested in these contributions at a rate of 20% per year, beginning after the second year of service, and are fully vested after six years of service.

#### NOTE 1: DESCRIPTION OF PLAN (Continued)

- E) Payment of Benefits--On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum or in annual installments over a specified period of time. The plan does not permit participants whose vested balance does not exceed \$5,000 to receive distributions in any form other than lump sum. Effective January 1, 2024, the Plan was amended to increase this force-out threshold to \$7,000.
- F) Forfeited Account--As of December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$-0-. This account will be used to reduce future employer contributions or to pay Plan expenses. Also, in 2024, neither employer contributions nor Plan expenses were reduced from forfeited nonvested accounts.

#### NOTE 2: SUMMARY OF ACCOUNTING POLICIES

- A) Basis of Accounting--The financial statements of the Plan are prepared on the accrual basis of accounting.
- B) Expenses--Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.
- C) Use of Estimates--The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- D) Investment Valuation and Income Recognition--Investments are reported at fair value. Daily unit values are used to value the interest in pooled separate accounts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies. See Note 3 for discussion of fair value measurements.

#### NOTE 2: SUMMARY OF ACCOUNTING POLICIES (Continued)

D) Investment Valuation and Income Recognition (Continued)--Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

E) Payment of Benefits--Benefits are recorded when paid.

#### NOTE 3: FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 1 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

##### *Level 2 Fair Value Measurements*

The fair value of the Plan's investments pooled in separate accounts is based on the unit value of the units held by the Plan at year-end, as certified by the custodian.

#### **NOTE 5: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are pooled separate funds managed by John Hancock USA. John Hancock USA is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$26,926 for the year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **NOTE 6: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE 7: TAX STATUS**

A new Plan document was adopted, effective January 1, 2021. This plan relies on a non-standardized pre-approved profit-sharing plan opinion letter dated November 30, 2020, in which the Internal Revenues Service (IRS) states that the non-standardized pre-approved profit-sharing plan is acceptable under section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### **NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
