We have audited the financial statements of Westates Construction 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) for the year ended December 31, 2024, and we will issue our report thereon dated October 14, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus, LLC, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated April 2, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### Significant Audit Matters

#### *Qualitative Aspects of Accounting Practices*

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by Westates Construction 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was :

Management's estimate of fair value of investments is based on information provided by the asset custodian.

The financial statement disclosures are neutral, consistent, and clear.

### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. Management has corrected all such misstatements. In addition, none of the misstatements detected as a result of audit procedures and corrected by management were material, either individually or in the aggregate, to the financial statements taken as a whole.

### *Reportable Findings*

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention. We identified the following reportable findings:

During our audit, we noted that some participants under the age of 21 were allowed to contribute to the plan which does not follow the plan adoption agreement. We recommend that management either distribute the ineligible employee deferrals to the employees or retroactively amend the plan to remove the age restriction.

During the audit, we noted that due to timing of moving to a PEO and collecting withholding documents, some employees did not have deferral withheld from their payroll for the first payroll of the year. The withholding amounts for these employees should have been carried over from the old payroll system or the employees should have been auto enrolled in accordance with the plan adoption agreement. We recommend that management work with the plan trustee to determine if any voluntary fiduciary corrections need to be made.

During the course of our audit, we noted certain participant remittances that were remitted to the Plan later than normal. While none of these instances were after the fifteenth day of the following month, the DOL could still deem these as late remittances because you have demonstrated the ability to remit contributions within 3 – 6 business days of participants receiving compensation. We recommend that management implement procedures to ensure that all participant contributions are remitted on a timely basis.

### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated October 14, 2025.

### *Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### *Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

### *Other Matters*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of management and plan administrator of Westates Construction 401(k) Plan and is not intended to be, and should not be, used by anyone other than these specified parties.

## Notes to Financial Statements

### Note 1 – Description of Plan

The following description of the Westates Construction 401(k) Plan (the Plan) provides only general information. Westates Construction, LLC is the Sponsor. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering all full-time employees of the Sponsor who have completed 1 year of service and have attained age 21. The Plan entry dates fall on the first day of the month subsequent to achieving eligibility. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants are auto enrolled at 3% of eligible compensation increasing annually by 1% until participant deferrals reach 6%.

#### Contributions

Each eligible participant may elect to make pre-tax deferred contributions or post-tax Roth contributions. Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also make contributions by rollover of distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor makes safe harbor matching contributions to the Plan for the benefit of each eligible participant up to 3.5% of the participant's eligible compensation.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Sponsor's contributions, and (b) Plan earnings (losses), and charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant compensation or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their deferral contributions plus actual earnings thereon. Vesting for the remainder of their accounts is as follows:

<u>Years of service</u>	<u>Vested</u>
Less than 2 years	0%
At least 2 years	100%

#### Payment of Benefits

On termination of service, attaining age 59.5 or reaching normal retirement age, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In case of hardship, disability or withdrawal of rollover contributions, distributions are available for in-service withdrawal.

#### Forfeited Accounts

The forfeited accounts of non-vested terminated participants may be used to reduce employer contributions. For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions.

## **Notes to Financial Statements**

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of the present value of the participant's vested account balance for one loan. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%.

### **Administrative Expenses**

Plan administrative expenses may be charged directly to the Plan or paid by the Sponsor. During the year ended December 31, 2024, the Plan incurred \$7,219 of administrative expenses. Investment-related expenses are included in net appreciation of the fair value of investments.

## **Note 2 – Summary of Significant Accounting Policies**

### **Basis of Accounting**

The Plan's financial statements are presented on the accrual basis of accounting in accordance with generally accepted accounting principles.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates. On an ongoing basis, the Sponsor evaluates its estimates, including those related to the determination of investment fair value.

### **Investment Valuation**

Investments are reported at fair value. Fair value is based on quoted prices for identical assets in active markets. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

### **Payment of Benefits**

Benefits are recorded when paid by the Plan.

### **Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant notes receivable is recorded as a benefit payment based on the terms of the Plan document.

### **Subsequent Events**

The plan administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

## **Westates Construction 401(k) Plan Notes to Financial Statements**

### **Note 3 – Fair Value Measurements**

The Plan discloses and recognizes the fair value of its assets and liabilities in accordance with Accounting Standards Codification (ASC) 820, Fair Value measurement and Disclosures which among other things, defines fair value and provides enhanced disclosures about investments that are measured and reported at fair value. ASC 820 establishes a hierarchal disclosure framework, which prioritizes and ranks the level of market price observability used in measuring investments at fair value. A number of factors, including the type of investment and the characteristics specific to the investment, impact market price observability. Investments with readily available active quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value.

Investments measured and reported at fair value are classified and disclosed in one of the following categories:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted market prices included in level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk. Inputs may include price information, volatility statistics, specific and broad credit data, liquidity statistics, and other factors. An investment's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual funds – These investments are valued at the net asset value (NAV) of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investments can be redeemed on a daily basis and there is no restriction on redemption.

Money market fund - This fund is a fixed income mutual fund that invests in debt securities characterized by short maturities and minimal credit risk. The investment is valued at the NAV of shares held by the fund based on closing prices reported in an active market and classified within Level 1 of the valuation hierarchy. The investment can be redeemed on a daily basis and there is no restriction on redemption.

Collective investment trust – These investments are valued at NAV based on the collective trust's underlying investments as determined by the fund's issuer. Redemption from these collective trust funds generally can be made daily.

### **Note 7 – Income Tax Status**

Ascensus, LLC obtained an opinion letter dated June 30, 2020, in which the IRS stated that the volume submitter plan document was in compliance with applicable requirements of the Internal Revenue Code. The plan sponsor has adopted the volume submitter document and is relying on this plan opinion letter. Although the Plan has been amended since the date of the determination letter received by Ascensus, LLC, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in accordance with the requirements to qualify for tax-exempt status.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has evaluated its tax position and has determined that it has no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### **Note 8 – Risks and Uncertainties**

The Plan invests in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9 – Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds and managed by Vanguard. Vanguard is the record keeper defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The notes receivable from participants are also party-in-interest transactions. The above party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
