**Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). ### Note 1 Description of Plan

The following description of The Contractors Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan was established on January 1, 2002. The Plan is a defined contribution plan under the provision of Section 401(k) of the Internal Revenue Code (“IRC”) and was established to provide retirement benefits for employees of JPI Development Group, Inc. (the “Company”). Employees become eligible to participate in the Plan following one year of continuous service and are 21 years or older, as defined in the plan agreement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan investments are in the Contractors Retirement Plan Master Trust (“Master Trust”), which was established for the investment of assets of the Plan and several other Contractors Retirement Plan sponsored retirement plans. The Board of Trustees, which is made up of key officers of the Company, is responsible for oversight of the Plan.

Employer Prevailing Wage Contributions - The Company makes prevailing wage contributions for employees eligible to receive wages under “prevailing wages” or “service contract” law. The prevailing wage contributions are based on the hourly contribution rate required under the applicable prevailing wage law, for the participant’s employment classification for the construction project at which the participant performs prevailing wage services. Such contributions cannot exceed the lesser of 100% of the employees’ compensation or \$69,000 during the year ended December 31, 2024.

Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document and subject to limitations by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may annually elect to make a discretionary employer profit sharing contribution. There were no profit-sharing contributions for the year ended December 31, 2024. The Company may elect to make a discretionary safe harbor matching contribution. During 2024, the Company made a safe harbor matching contribution equal to 100% of deferrals on the participants first 3% of compensation, and 50% of participant deferrals over 3% (up to 5%) of eligible compensation. Safe harbor matching contributions were \$62,710 for the year ended December 31, 2024.

### Note 1 Description of Plan (continued)

Participant Accounts and Vesting - Each participant's account is credited with the employer prevailing wage contribution and allocation of (a) the employer profit sharing contribution, (b) plan earnings (losses), and (c) administrative expenses. Allocations are based on participant's earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in employer prevailing wage contributions and safe harbor contributions plus actual earnings thereon. Vesting in the Company's profit sharing is based on the years of continuous service and a participant becomes 100% vested after 6 years of credited service.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to 30 years for the purchase of a principal residence for loans transferred into the Plan. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with rates charged by commercial lenders for loans made under similar circumstances. The interest rate on loans with balances at December 31, 2024 was between 3.25% and 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, retirement or other reasons a participant may elect to receive either a lump-sum amount, substantially equal installments or partial withdrawals equal to the value of the participant's vested interest in his or her account.

Forfeitures - The non-vested portions of participants' employer-derived account balances are treated as forfeitures. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$347, respectively. Forfeited accounts are used either to reduce future employer contributions or to reduce administrative expenses relating to the maintenance of the Plan.

### Note 2 Summary of Significant Accounting Policies

Basis of Accounting - The financial statements have been prepared on the modified cash basis of accounting and presents net assets available for benefits and changes in those net assets. Under the modified cash basis of accounting utilized, employer and employee contributions are recognized when received rather than when accrued by the employer. Additionally, benefit payments to participants are recorded when paid.

### **Note 2**      **Summary of Significant Accounting Policies** (continued)

Use of Estimates - The preparation of financial statements requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and change therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net depreciation in fair value of investments.

Date of Management's Review - The Plan has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.

### **Note 3**      **Party-in-Interest Transactions**

Certain plan investments are shares of Mutual Funds managed by the custodian, therefore, these transactions qualify as party-in-interest transactions under the Department of Labor's ("DOL") Rules and Regulations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### Note 4 Certified Investments

Certain information related to investments and notes receivable disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Transamerica Trust Company, the trustee of the Plan.

### Note 5 Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

LEVEL 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

LEVEL 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

LEVEL 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### Note 5 Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Pooled Separate Accounts*** - Valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities.

***Insurance Company General Account*** - Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable duration considering the credit-worthiness of the issuer.

### **Note 6 Fully Benefit-Responsive Investment Contracts**

The Plan entered into a fully benefit-responsive guaranteed investment contract with Transamerica Life Insurance Company (“TLIC”). TLIC maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Trust. The crediting rate is based on a formula established by the contract issuer but may not be less than 3.5%. Such interest rates are reviewed on a semi-annual basis for resetting. There are no unfunded commitments, and the redemption frequency and notice period is daily.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Trust by TLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Trust's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### Note 7 Investment in Retirement Plan Master Trust

Fringe Benefit Group, Inc. sponsors the master plan and trust documents. A master profit-sharing plan in the form of the Contractors and Employees 401(k) Profit Sharing Plan (the “401(k) Plan”) was established in 1993. A trust in the form of the Contractors and Employees Retirement Plan Master Trust (the “Trust”) was established in 1987. Under the terms of the 401(k) Plan, all assets of the Plan are maintained in the Trust.

The Plan’s interest in the assets of the Trust is included in the accompanying statements of net assets available for benefits (modified cash basis). The Trust has 1,361 and 1,430 participating plan sponsors as of December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the Plan had an approximately 0.71% and 0.62% interest in the Trust’s 103-12 investment entity fund in each of the respective years. The Plan’s interest in the 103-12 investment entity fund will fluctuate based on the investment elections made by the Plan’s participants, and the fair value of the investments held by the Plan’s participants in relation to the fair value of all investments held by the 103-12 investment entity fund.

### Note 8 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 9 Tax Status

The Plan adopted a volume submitter plan offered by Fringe Benefit Group, Inc. The volume submitter plan received an IRS Opinion Letter, dated August 24, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax council believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 10 Risks and Uncertainties**
