

I received notification from the IRS of a substantial penalty for a late filing of the Form 5500 for 2022. In 2022 we changed PEO providers from ADP to Justworks. We initiated a change of 401k providers in the 3rd quarter of 2022 moving from ADP to Slavic who was the preferred provider of our new PEO, however the assets did not get transferred until early in 2023. After the change there was confusion on my part as to who was responsible for the 5500 filing. I was under the mistaken impression that Slavic would file for 2022. In the meantime, my login credentials with ADP had expired and I had no access. I was not aware of the delinquency until notified by the IRS but have taken action to address the situation. Please note that all previous filings were on time as were the 2023 and 2024 filings. The 2023 and 2024 were filed under the EIN of our PEO, Justworks.

The 2022 filing has now been updated. I am requesting a waiver of the penalty from the IRS as well as the DOL for the 2022 late filing. Please advise.
