NOTE A – DESCRIPTION OF PLAN

The following brief description of Johns Eastern Company, Inc. 401(k) Plan Twelfth Amendment and Restatement (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a 401(k) feature and a profit sharing feature, covering all eligible employees of Johns Eastern Company, Inc. (the Company). The Plan started June 1, 1976 and was amended and restated effective May 1, 2009. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan terminated on June 28, 2024 (Note H).

Eligibility

401(k) Feature – All employees of the Company are eligible to participate after completing 90 days of service. Employees must be 19 years of age to be eligible to participate in the 401(k) feature of the Plan. Employees who become eligible will automatically be enrolled in the Plan and make contributions at 3% of eligible compensation on the first day of the month coinciding with or following eligibility. The employees may elect to decline enrollment or to contribute a different investment election percentage. Participants may change their deferral percentages on the first day of any month.

Profit Sharing Feature – All employees of the Company are eligible to participate after completing one year of service. Employees must be 21 years of age to be eligible to participate in the profit sharing feature of the Plan.

Contributions

401(k) Feature – Each active participant in the Plan may enter into a written Salary Deferral Agreement with the Company in which compensation is reduced by an amount of not more than 50% of his or her compensation for the Plan year. The Company also contributes a matching amount of 100% of such contributing participant's deferrals up to 4% of the contributing participant's compensation plus 50% of the participant's salary deferrals between 4% and 6% of compensation. The participant must be employed as of the last day of the Plan year to receive the Company match contribution.

Profit Sharing Feature – Each year the Company may make a discretionary contribution. Profit sharing contributions are allocated to participant accounts based on a tiered formula using employee compensation. The participant must be employed as of the last day of the Plan year to receive the profit sharing contribution.

Participants direct the investment of their contributions into various investment options offered by the Plan. The participants may change their investment allocations at any time.

Vesting

Participants are immediately 100% vested in their voluntary pre-tax contributions plus earnings thereon.

The Company's matching contribution and profit sharing contribution become 100% vested after six years of service on a graded vesting schedule.

Additionally, participants become fully vested in all of their accounts in the event of disability, death or attaining normal retirement age while employed with the Company.

Forfeitures

Forfeitures may be used to pay Plan administrative expenses or to reduce the Company's matching contribution. The forfeitures for the non-vested portion of the discretionary profit sharing contribution can also be allocated to participants.

During the period ended June 28, 2024, forfeitures of \$31,829 were used to reduce the employer contributions. At June 28, 2024, the forfeited non-vested accounts totaled \$0. At December 31, 2023, the forfeited non-vested accounts totaled \$31,829.

Notes Receivable from Participants

Participants are able to obtain loans from the assets of the Plan, using their individual account balances as collateral. Loan amounts cannot exceed the lesser of \$50,000 or 50% of the participant's vested account balance. Each loan shall bear interest at a rate determined by the Company in accordance with current appropriate standards. Principal and interest is paid ratably through payroll deductions.

Distribution of Benefits

Upon termination of service, (due to termination, retirement, death or disability or reaching age 59 ½) a participant may elect to receive a distribution equal to the value of his or her vested account balance, as described in the Plan.

Upon reaching normal retirement age of 65, participants are entitled to all of their accounts under the Plan. For terminated participants with account balances less than or equal to \$1,000, the plan administrator may make a mandatory distribution in a single cash lump sum payment. The Plan requires that certain minimum distributions be made from the Plan. If a participant is a 5% owner, distributions are required to begin no later than the April 1st following the end of the year in which the participant reached the age of 70 ½. If the participant is not a 5% owner, the distributions are required to begin no later than the April 1st following the later of the end of the year in which the participant reached age 70 ½ or retired.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated by the employer, each participant's benefits become fully vested. See Note H related to the transfer of net assets available for benefits to successor plan.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Date of Management's Review

Subsequent events were evaluated through November 7, 2025 which is the date the financial statements were available to be issued.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Change in Legislation

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act. Most of the provisions became effective in 2024 and forward. Since the provisions include both required and optional elements, the Plan Administrator will determine the optional provisions to elect.

NOTE C – INVESTMENTS

During the period ended June 28, 2024, the Plan's mutual funds (including gains and losses on investments bought and sold) appreciated in value by \$2,737,749.

NOTE D – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820 *Fair Value Measurements and Disclosures* provides the framework for measuring fair value.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 28, 2024 and December 31, 2023. The Plan recognizes transfers of assets into and out of levels as of the date an event or change in circumstances causes the transfer.

NOTE D – FAIR VALUE MEASUREMENTS – CONTINUED

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan include open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds may also be valued as determined by an independent pricing service, based on methods which include consideration of: yields or prices of securities of comparable quality, coupon, maturity and type; indications as to values from dealers; and general market conditions.

The common collective trust seeks to earn current income and preserve capital and stability of principal. These funds seek to maintain a value of \$1.00 per unit. The fair value of the fund is based upon the value of the underlying securities and allocated on a pro rata basis based on units in the collective trust. Management’s estimate of the fair value of these investments is based on estimates provided by the Trustee. The investments of the underlying collective trust funds, which are valued at fair value, included stable value investment contracts, fixed income instruments, money market instruments, common stock, and depositary receipts. There are no restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E – TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 31, 2008, that the Plan, is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

NOTE E – TAX STATUS – CONTINUED

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the positions taken by the Plan, and has concluded that as of June 28, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's three previous years remain open to inspection by the Internal Revenue Service.

NOTE F – PARTIES-IN-INTEREST TRANSACTIONS

Merrill Lynch was the custodian as defined by the Plan through June 28, 2024, and certain transactions qualify as party-in-interest transactions. The Company provides accounting and administrative services to the Plan at no charge. The Company also absorbs significant Plan expenses.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – TRANSFER OF NET ASSETS AVAILABLE FOR BENEFITS TO SUCCESSOR PLAN

Effective June 28, 2024, the plan sponsor transferred the net assets available for benefits of the Plan to a successor plan as a result of a previous business acquisition. Assets, including investments, in the amount of \$38,205,191 and loans from participants of \$205,520 were transferred to the successor plan. This resulted in net assets available for benefits of the Plan as of June 28, 2024 totaling \$0.
