Reasonable cause letter for late 5500 for filing year 2024; Professional Climate Control

Whom it may concern,

PCC HVAC LLC acknowledges that we are late filing our form 5500 for 401(k) compliance. Unfortunately, our principals have had several health issues that caused delays in our office, which led to the delay in filing the 5500.

Jillian Havemann, our main principal and WBE certified owner, had to split her time from August through September to care for her mother and stepfather. First, her stepfather was diagnosed with lung cancer, and she had to assist her mother in his care and settle him into receiving care at home. Then her mother fell ill with symptoms relating to an existing chronic illness, and she had to spend time with her in the hospital and then help her settle back at home.

Secondly, Lee Havemann, our VP and Jill's father, was diagnosed with Cystic Fibrosis in late September. He was out simultaneously for a few weeks with Jill. She was also caring for her father while he was beginning to set up his care going forward.

These extenuating circumstances led us to be short staffed in the office and led to delays in many areas, including filing compliance for the 5500. We respectfully request that the late filing penalty be waived for filing year 2024 due to these circumstances. We have ensured that future filings will be made on time via reminders on our calendars and from our 401(k) broker.
