Opinion

We have audited the accompanying financial statements of TVS Companies Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1: DESCRIPTION OF PLAN

The following description of the TVS Companies Employee Stock Ownership Plan (the Plan) provides only general information. Reference should be made to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is sponsored by TVS Design Companies, Inc. and its affiliate, TVS International, Inc., which adopted the Plan as an affiliate of TVS Design Companies, Inc. Collectively, these entities are hereinafter referred to as TVS Companies or Employer. At December 31, 2024 and 2023, the Plan owned 100% of the outstanding common stock of TVS Companies, consisting of 229,216 and 230,024 shares, respectively. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan assets are held and managed by Blue Ridge ESOP Associates (Blue Ridge), which invests contributions and Plan earnings, makes investment transactions as directed by the Investment Committee and provides certain recordkeeping services. The Plan's trustee is GreatBanc Trust Company.

Eligibility

All employees who have attained the age of 21, had no less than 1,000 hours of service during the Plan year or twelve-month period following their employment date, and were employed on the anniversary date (December 31) are eligible to participate in the Plan.

Contributions

Contributions to the Plan are made at the discretion of the Board of Directors of TVS Design Companies, Inc. and its affiliate TVS International, Inc. and may be paid in cash, shares of the Employer's stock, or other property.

Participant contributions are not permitted.

Participant Accounts

Each participant's account is credited with an allocation of the Employer contribution, interest and dividend income, forfeitures, purchases of Employer stock and net increase/decrease in fair value of investments. Allocations are based on eligible compensation, certain account balances, and/or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants become 100% vested after three years of service.

Benefit Payments

Participants may receive distributions of benefits in the event of retirement, termination, disability or death, in accordance with the Plan. Participants may also receive in-service distributions once the participant reaches age 55 and has ten years of participation in the Plan.

TVS Companies Employee Stock Ownership Plan Notes to Financial Statements

Note 1: DESCRIPTION OF PLAN (Continued)

Diversification of Benefits

Upon reaching age 55 and ten years of service, the participant has the right to diversify 25% of his/her account value attributable to TVS Companies stock acquired by the Plan after December 31, 1986. This diversification, when requested, is accomplished through a distribution to the Plan participant.

Put Option

Under federal income tax regulations, the Employer common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Forfeitures

Forfeitures are used to reduce the future employer contributions or are reallocated to participant accounts, in accordance with the Plan's documents. At December 31, 2024 and 2023, there were no unallocated forfeitures.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are recorded at fair value, which is determined by an independent appraisal (Note 5). Increases or decreases in the appraised fair value of investments held at the end of the year are reflected in the statements of changes in net assets available for benefits as appreciation in the fair value of investments. Realized gains or losses on the sale of investments are recorded based on the difference between the proceeds and the fair value of investments at the beginning of the Plan year. The basis of the investment is determined by the specific-identification method. Investment income is recognized when earned.

Payment of Benefits

Distributions to participants are recorded when paid.

Risks and Uncertainties

The Plan is designed to invest primarily in the Plan Sponsor's common stock; however, investments can be made in other property or in life insurance policies, as permitted in the investment policy. All investments at December 31, 2024 and 2023 are in shares of the Plan Sponsor's common stock. The Plan's investments are exposed to various risks, including interest rate, market, and credit risks, as well as valuation assumptions based on earnings and cash flows of the Plan Sponsor. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

From time to time, the Plan may have cash deposits with a financial institution in excess of federally insured limits of \$250,000. If this financial institution were not to honor its contractual liability, the Plan could incur losses. The Plan Administrator is of the opinion that the risk of loss is minimal due to the financial strength of this financial institution.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, November 18, 2025, and determined there were no events that occurred that required disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: TRUSTEE AND PLAN ADMINISTRATOR RESPONSIBILITIES

The Plan is administered by a committee (the Plan Administrator) appointed by the Board of Directors of the Employer. The Trustee is also appointed by the Employer's Board of Directors. Authority for control, management and administration of the Plan is vested in the Plan Administrator. The Trustee, another one of the Plan's fiduciaries, has the responsibility of maintaining the Plan's assets and, as instructed by the Plan Administrator, to acquire, invest and dispose of the Plan's assets.

Note 5: FAIR VALUE OF THE COMPANY STOCK FUND

The fair value of the company stock fund is based on an annual appraisal by an independent professional valuation firm. This appraisal was based on a combination of the discounted cash flow, market and income valuation approaches consistent with prior years. The appraiser took into account historical and projected cash flow and net earnings, weighted average cost of capital, market comparables, and applicable discounts and premiums.

The independent valuation consultants valued the Employer's common stock by: analyzing the financial statements of the Employer for the six years ended December 31, 2024; conducting discussions with management regarding the history and nature of the business; reviewing financial data bearing upon recent and proposed operations; reviewing industry prospects; reviewing the market value of publicly traded stock of similar companies; considering contracts for future revenues to be earned by the Employer; and considering other relevant factors.

It was the opinion of the independent valuation consultants that the fair value per share of the common stock of the Employer was \$88.01 and \$86.30 per share at December 31, 2024 and 2023, respectively.

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Changes in Fair Value of Level 3 Assets

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Management evaluated the significance of transfer between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

Note 6: TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated July 14, 2015, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Certain expenses of the Plan, including legal and accounting fees, are paid by the Employer. In addition, certain services to the Plan by the Employer were performed at no charge.

Note 8: PLAN TERMINATION

Although it has not expressed any intent to do so, if the Plan is terminated by the Employer or its contributions to the trust are discontinued, the participants' individual accounts become fully vested and non-forfeitable. The equity of each participant's account may be distributed in a lump-sum payment or may be deferred until otherwise distributable in accordance with the Plan.
