The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of the Plan

The following description of AdventHealth Consolidated ERISA 401(a) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of AdventHealth System Sunbelt Healthcare Corporation (the “Employer”) and other participating employers. The Plan holds assets with Fidelity Management Trust Company (“Fidelity”), which serves as the Custodian of the Plan.

The Plan was adopted on January 1, 2015 and constitutes a consolidation of the Hospice of the Comforter (“HOTC”) 401(k) Retirement Plan effective January 1, 2015, Shawnee Mission Medical Center (“Shawnee”) Tax-Deferred Annuity Matching Plan effective January 1, 2016 and West Florida Health, Inc. 401(k) Plan (“West Florida”) effective January 1, 2019.

During October of 2023 the assets held by AIG and VALIC were transferred to Fidelity.

Effective February 7, 2024, a portion of the CommonSpirit Health 401(k) Retirement Savings Plan was spun off and merged into this Plan on a frozen basis. Individuals with accounts transferred in this transaction became participants of this Plan as of that date. The Plan remains closed to new contributions.

In addition, CommonSpirit Participants’ became participants on February 7, 2024 in connection with the spin-off/merger

CommonSpirit Health 401(k) Retirement Savings Plan (“CommonSpirit”) and AdventHealth Consolidated ERISA 401(a) Plan had a joint venture referred to as Centura. In 2024 that joint venture was dissolved and as a result an additional \$320,990,975 was transferred into the Plan from CommonSpirit.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees who were previously participants in the HOTC Plan, Shawnee Plan, and West Florida Plan are covered by this Plan. Other than the individuals described above, no additional individuals shall be eligible to become participants in the Plan.

Contributions

No contributions shall be made under this Plan.

Participant Accounts

A participant's account is credited with the allocations of Plan earnings and charged for allocations of expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan may maintain subaccounts by source and separately tracks any Roth elective deferrals transferred from prior plans.

Vesting

Participants are vested immediately in their contributions made to the previous plans plus actual earnings thereon. Participants who were formerly in the HOTC Plan and terminated prior to January 1, 2015, are vested in the employer matching and profit sharing contributions made to the previous plans at the rate of 20% per year of service with full vesting occurring after the fifth year of service. Participants who were formerly in the HOTC Plan and terminated on or after January 1, 2015 are vested in the employer matching and profit sharing contributions made to the previous plans on a three-year cliff vesting schedule where they are 0% vested until the completion of their third year of service, after which they become fully vested. Participants who were formerly in the Shawnee Tax-Deferred Annuity Matching Plan are vested in the employer matching and profit sharing contributions made to the previous plans with full vesting occurring after the third year of service. Participants who were formerly in the West Florida Plan are 100% vested in all contributions plus any earnings thereon. CommonSpirit participants vest in employer contributions based on a 5-year cliff.

Forfeitures

Forfeitures may be used to pay administrative fees and recordkeeping expenses incurred as a result of offering the Plan. At d and 2023, forfeited non-vested accounts totaled \$876,410 and \$3,755. In 2024, \$44,465 forfeitures were used to reduce administrative expenses and no Employer contributions were reduced from forfeited non-vested accounts. Increase in forfeitures during the Plan year is associated with the transfer-in of balances of participants of CommonSpirit.

Plan Credit Account

The Plan entered into a revenue sharing arrangement with Fidelity Management Trust Company whereby a portion of the revenue earned by the trustee from certain funds is passed through to the Plan for payment of permitted plan expenses. In order for the Plan to receive credits as a result of these arrangements, and to use this credit to pay Plan expenses, the Company created the Plan Credit Account under the Plan. The Plan Credit Account is a nonparticipant directed account within the Plan, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with plan administration. The Plan Credit Account balance was \$20,526 and \$0 at December 31, 2024 and 2023. In 2024, no funds from the Plan Credit Account were used.

Payment of Benefits and Withdrawals

Upon retirement, death, disability, or resignation of a participant, or upon termination of the Plan, a participant or beneficiary may receive a distribution in the form of a lump sum payment. In-service withdrawals of employee contributions for reasons of hardship (as defined in the Plan agreement) or attaining age 59½ are allowed. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent.

However, installment or annuity elections already in effect before February 7, 2024 for CommonSpirit Participants continue to be honored, including any death-benefit forms already being paid.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Loans are to be repaid within five years for a general purpose loan or ten years for a principal residence loan from the date of execution or earlier. A participant may have no more than one outstanding loan from the Plan in a twelve-month period. If a participant fails to make payments when they are due under the loan terms, they will be considered to be in default.

Loan balances of CommonSpirit Participants transferred as part of the merger; loans are administered under a plan loan policy adopted by the Administrator.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions of net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. As of December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All the Plan's investments are stated at fair value except for the fixed account, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Self-directed Brokerage account on the statement of net assets available for benefits consists of money market funds, mutual funds, common stock and certificates of deposit. The fixed account is reported at contract value, which represents the beginning balance plus any deposit and credited interest, less any withdrawals, charges, or expenses.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses paid by the Plan are included in administrative expenses on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 15, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation in fair value of investments, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and Metropolitan Life Insurance Company, qualified institutions.

4. VALIC Fixed Interest Option

The VALIC Fixed Interest Option (the “Option”) is a fully benefit-responsive investment contract with VALIC. The Option guarantees principal and a rate of return, which is backed by the claims-paying ability of VALIC. Amounts allocated to the Option are placed in the VALIC General Account, where assets are invested to maximize return subject to the constraints of safety, liquidity and diversification.

Generally, participants may transfer assets from the Option into equity options at any time and, after 90 days, from equity options into another fixed-income option such as a money market fund, a stable value fund or certain short-term bond funds, if such “competing options” are allowed in the Plan. The Option is subject to a market value adjustment if the Plan sponsor ever withdraws funds.

However, in no event can any amount withdrawn be less than the total amount of contributions accumulated at the contract minimum interest rate less withdrawals.

The Option represents approximately 2% and 22% of net assets available for benefits as of December 31, 2024 and 2023.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The Option is presented on the face of the statements of net assets available for benefits at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

4. VALIC Fixed Interest Option (*continued*)

VALIC is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. The credit risk of the issuer, VALIC, was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Service (A2 as of January 2024), Standard and Poor's (A+ as of January 2024), A.M. Best (A as of January 2024), and Fitch (A+ as of January 2024).

5. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

6. Plan Termination

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to provisions of ERISA.

7. Tax Status

The Plan, effective January 1, 2015, represents a consolidation of existing qualified retirement Plans. The Employer believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examination by taxing jurisdictions for periods since 2021.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
