As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following is a description of the University of Maryland Surgical Associates, P.A. Pension Plan (the “Plan”) that provides only general information. Participants should refer to the Plan’s document for a more complete description of the Plan’s provisions. University of Maryland Surgical Associates, P.A. is the sponsor of the Plan (“Plan Sponsor”).

General

The University of Maryland Surgical Associates, P.A. Pension Plan is a defined contribution pension plan which provides an individual account for each participant and provides benefits upon retirement that are based on amounts contributed by the employer plus earnings on those contributions less any Plan administrative expenses. The Plan was established on October 13, 1971. The Plan does not allow for employee contributions.

The plan was amended and restated as of July 1, 2023 to incorporate all amendments and changes required by law.

Participation

Effective July 1, 2023, all employees of the Plan sponsor are eligible to participate in the plan immediately upon hire. Part-time contractual faculty and collective bargaining employees are excluded from participation in the plan.

Contributions

The Plan Sponsor contributes to the Plan an amount equal to 7.25% of participants’ compensation paid for the Plan year.

Participant Accounts

Each participant’s account is credited with the allocation of (a) the Plan Sponsor’s contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. The participant can direct contributions to any of the available funds in the Plan. For those participants who do not make an investment selection, contributions are automatically invested in the Plan’s default investment account.

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

For the years ended June 30, 2025 and 2024

1. Description of Plan (continued)

Vesting

Participant accounts are vested based on years of service as defined in the Plan. Vesting begins upon the completion of the first year of service. The standard measure for one year of service is completion of 250 hours during the Plan year. Failure to meet the requirement means that no vesting credit is given to the participant.

Participants are 20% vested in the Company's contribution after the completion of one year of credited service, 60% vested after the completion of two years of credited service and 100% vested after the completion of three years of credited service.

Notwithstanding the above, a participant shall be fully vested in the entire account upon the later of the date the participant attains age 55 or the fifth anniversary of the first day of the Plan Year in which the participant commenced participation in the plan, death, disability or if the Plan is terminated.

Payment of Benefits

Upon termination of service due to death, disability, normal retirement (attainment of the later of age 55 or reaching the 5th anniversary of the first day of the Plan year in which the participant commenced participation in the Plan), a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly installments. Upon termination of service resulting from death of a married participant, payment is required to be in the form of a survivor annuity, unless another payment form is approved by the surviving spouse. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Upon a participant's termination of service prior to attainment of the later of age 62 or the normal retirement age, mandatory distributions in the form of a rollover can be made by the Company if the vested balance is greater than \$1,000 and less than \$5,000. Mandatory distributions can be made by the Company if a participant's vested balance is less than \$1,000; however, these distributions will be paid in a lump-sum.

A terminated or retired participant may elect to receive payment from their account soon after it is valued or postpone payment until a later date. If payment is postponed, the account will continue to share in investment earnings. However, distributions are required to begin not later than the April 1st following the later of the end of the year in which a participant reaches age 73 or terminates employment.

In addition, in-service withdrawals and hardship withdrawals are permitted if certain criteria are met.

Forfeited Accounts

Forfeited non-vested accounts totaled \$14,140 and \$13,721 as of June 30, 2025 and 2024, respectively. There were no forfeitures used to reduce the Employer's 2025 and 2024 contributions.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting standards generally accepted in the United States of America.

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and Empower Trust Company, LLC. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the ex-dividend date. Realized gains and losses from security transactions and unrealized appreciation and depreciation of investments are determined using an average cost basis.

Investment Valuation and Income Recognition (continued)

Individual participant accounts for the common/collective trust fund are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units valued daily. The fund earns dividends which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are made daily at the NAV and are considered as made immediately after daily valuation, and the participant's accounts are charged or credited with the number of units properly attributable to each participant.

The Plan invests in registered investment companies and a common/collective trust. Such investments are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with such investments, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits. Plan assets are not FDIC insured.

Plan Expenses

The Company sponsors the Plan. Personnel within the employer organization perform certain administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included as Plan expenses. Certain record keeping, administrative expenses and transaction fees are paid by the Plan. Investment related expenses are included in net appreciation in the fair value of investments. All other expenses are paid by the Company.

Funding Policy

Contributions are funded as accrued.

Payment of Benefits

Benefits are recorded when paid.

3. Certified Information

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2025 and 2024, and net appreciation in fair value of investments and interest and dividends for the year ended June 30, 2025, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC (the custodian of the Plan).

4. Fair Value Measurement

In accordance with generally accepted accounting principles, the Plan has adopted the provisions which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Items carried at fair value on a recurring basis consist primarily of financial instruments which are valued primarily based on quoted prices in active or brokered markets for identical as well as similar assets and liabilities. Items carried at fair value on a non-recurring basis generally consist of assets held for sale if applicable. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2025 and 2024.

Registered investment companies: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Galliard Stable Return Fund C: The common/collective trust fund primarily invests directly or indirectly in fully benefit-responsive investment contracts. The fund is valued daily at the NAV as provided by the trustee and is based on the fair value of the underlying contracts except for certain investment contracts that generally are valued at contract value.

4. Fair Value Measurement (continued)

The NAV is used as a practical expedient to estimate fair value. Unit values are computed by dividing total net assets by the total number of participants' units outstanding on the valuation date. The fund declares and pays dividends which are reinvested in the fund and included in the determination of unit value.

The Galliard Stable Return Fund C provides for daily redemption at reported NAV for participant directed withdrawals. There are no unfunded commitments. Any plan sponsor initiated withdrawal from the Fund will require a 12-month written notice of the intent to withdraw assets from the Fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) In accordance with accounting standards, certain investments that were measured at NAV per share or its equivalent have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

5. Related Party Transactions

Certain Plan investments are held in a guaranteed investment contract managed by Empower Trust Company, LLC for June 30, 2025 and 2024. Empower Trust Company, LLC is the custodian as defined by the Plan. Additionally, the employer sponsors the Plan. Expenses for the custodian, audit, and outside administration services are paid directly by the Plan sponsor. Both Empower and the Plan sponsor qualify as a parties-in-interest.

6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

7. Tax Status

Effective July 1, 2023, the Plan adopted a non-standardized form of a prototype plan sponsored by Empower Trust Company, LLC. The prototype plan received an opinion letter from the Internal Revenue Service dated November 14, 2022 that states that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
