INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Earthstone Operating, LLC 401(k) Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Earthstone Operating, LLC 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.


Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 9 to the financial statements, Plan Management made a decision to terminate the Earthstone Operating, LLC 401(k) Retirement Plan and determined that liquidation is imminent. As a result, in accordance with accounting principles generally accepted in the United States of America, Earthstone Operating, LLC 401(k) Retirement Plan has changed its basis of accounting from the accrual basis of accounting used to present the December 31, 2023, financial statements to the liquidation basis of our accounting used in presenting the March 31, 2024, financial statements. Our opinion is not modified with respect to this matter.

Auditors' Report on the 2023 Financial Statements

The financial statements of Earthstone Operating, LLC 401(k) Retirement Plan as of December 31, 2023, were audited by predecessor auditors. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated November 7, 2024, indicated that in their opinion (a) the amounts and disclosures in the 023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of the Plan

The following description of Earthstone Operating, LLC 401(k) Retirement Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established effective January 1, 2017, by Earthstone Operating, LLC ("EOP") and its affiliates ("the Company") to qualify as a defined contribution, profit sharing plan under Section 401(a) of the Internal Revenue Code, for the benefit of eligible employees of the Company. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not subject to guarantee by the Pension Benefit Guaranty Corporation.

Plan Merger

On November 1, 2023, Permian Resources Operating, LLC completed a merger with Energy Holdings, LLC (the "Merger"). Upon the completion of the Merger, Earthstone Operating, LLC became a wholly owned subsidiary of Permian Resources Operating, LLC. The Plan was merged into the respective 401(k) plan for the employees of Permian Resources Management, LLC on April 1, 2024.

Custodian and Administration of the Plan

Trustee, recordkeeping, and investment management services are performed by Reliance Trust Company ("Trustee"), along with ADP Retirement Services.

The Plan is administered by the Administration Committee. The Administration Committee may retain independent advisors and consultants and is responsible for administration and for managing the Plan's activities. Permian Resources appoints members of the Investment Committee and the Investment Committee reviews and selects the investment fund options offered under the Plan.

Eligibility

All employees of the Company are eligible to participate in the Plan immediately upon permanent hire as an Earthstone Operating employee.

Contributions and Participant Accounts

Each year, participants may contribute up to 80% of their eligible annual compensation on a Pre-Tax or Roth basis or combination thereof, as defined in the Plan, subject to certain IRS regulations. Participants may also contribute amounts representing distributions from other qualified plans. Eligible employees who attain age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan.

1. Description of Plan (continued)

Separate accounts are maintained for each participant and are credited with the participant's contributions, Plan Sponsor contributions and rollover contributions, if any, including the allocations of earnings and losses to these accounts calculated daily based on participant account balances. Participants direct their investments by electing the percentages of their accounts and contributions to be allocated between investment fund alternatives. Participants may make unlimited changes in their future investment allocations or make transfers of existing balances between investment fund alternatives.

Vesting

Participants are fully vested in their contributions and employer matching contributions immediately. Additionally, participants become fully vested in Plan Sponsor discretionary contributions upon death, disability, change of control, or attainment of retirement age while employed by Earthstone Operating, LLC. Terminated employees are subject to the vesting schedule in place at the time of their termination of employment with Earthstone Operating, LLC.

Non-vested balances of employees who terminate are forfeited and generally used to reduce subsequent Plan Sponsor contributions to the Plan and to pay administrative expenses of the Plan. There were no forfeitures during 2024 and no forfeiture balances at March 31, 2024 and 2023.

Payment of Benefits

At the time of a participant's death, the vested balances in all of his or her accounts will be paid in a lump sum to the designated Beneficiary or Beneficiaries. If a participant meets the definition of Disability under the Plan, they may request a distribution of their account balance only if they have terminated their employment with the employer. Upon termination of employment for reasons other than death or disability, participants are entitled to receive a lump sum payment for the value of the non-forfeitable portion of their account. Such lump sum payments may result in adverse tax consequences for the participant.

With regard to Participants with vested account balances of \$5,000 or less, the Plan's administrator will direct the Trustee that any account exceeding \$1,000 be distributed to an Individual Retirement Account or Annuity (IRA) for the participant's benefit. If the vested account balance is \$1,000 or less, the Plan administrator will direct the Trustee to distribute to the participant as a lump sum distribution without his or her consent. Benefits are recorded when paid.

Administration Fees

Administrative fees include recordkeeping fees, Trustee fees, audit fees, account maintenance fees, and legal fees. Participant loan origination fees are included in *Administrative and other expenses* in the Statement of Changes in Net Assets Available for Benefits and deducted from participant's accounts as they are paid directly by the participants to the Trustee.

Administrative expenses on behalf of the Plan are paid through the use of forfeitures, by the Plan and by the Company. No Plan-related expenses were paid by the Company for the period ended March 31, 2024.

Participant Loans

Participants may borrow from their individual plan account, with a minimum amount of \$1,000 and a maximum amount equal to the lesser of 50% of such participant's vested balance or \$50,000. All loans shall bear a reasonable rate of interest as determined by the Plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances and shall remain fixed throughout the duration of the loan. The repayment period may be up to five years for a general loan, or up to 10 years for the purchase of a principal residence.

2. Significant Accounting Policies

Basis of Presentation and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America. This requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

All the Plan's investments all maintained in registered investment companies, which are valued using quoted market prices from the respective securities' principal active exchange or at net asset value. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Delinquent notes receivable from participants are treated as a distribution based upon the terms of the plan document. These notes have interest rates ranging from 4.25% to 9.50% and mature from January 2024 through January 2029.

The Plan Sponsor estimates that these notes receivable from participants are fully collectible and therefore no allowance for credit losses has been recorded as of March 31, 2024, or December 31, 2023.

Risks and Uncertainties

The Plan provides for various investment options in registered investment companies. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

3. Information Prepared and Certified by Custodian

The following information included in the accompanying financial statements was obtained from data that has been prepared and certified to as complete and accurate by the Trustee:

- Investments at fair value as shown in the Statements of Net Assets Available for Benefits as of March 31, 2024, and December 31, 2023, and in Note 4;
- Investment income and interest income on notes receivable from participants as shown in the Statement of Change in Net Assets Available for Benefits for the year ended March 31, 2024.

The Plan Sponsor has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits. The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Financial Accounting Standards Board's ("FASB"), Accounting Standards Codification 820, *Fair Value Measurements and Disclosures* ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation of other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Investments in registered investment companies: Reported at fair value based on quoted market price of the fund and classified within Level 1 of the valuation hierarchy, as of December 31, 2024. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

Investments in common collective trusts and self-directed brokerage funds: Valued determined by the trustee of the common collective trust based on the underlying assets, which represents the net asset value. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

5. Related Parties and Parties in Interest

All Plan investments are managed by the Trustee and therefore qualify as party-in-interest transactions. Fees paid to the Trustee by the Plan for recordkeeping and administration totaled \$14,350 as of March 31, 2024. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

7. Forfeited Accounts

On March 31, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$0, respectively. Forfeitures may be used to reduce employer contributions and to pay Plan expenses.

8. Tax and Plan Status

U.S GAAP required plan management to evaluate tax positions taken by the plan and recognize a tax liability of the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of March 31, 2024, there are no uncertain positions taken, or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has received a favorable determination letter from the Internal Revenue Service as to the qualified status of the user plans on October 6, 2020. Although the Plan has been amended since receipt of the determination letter, the Plan's administrator believes the Plan remains a qualified plan and is not subject to tax. Accordingly, no provision for federal or state income taxes has been recorded.

9. Termination of the Plan upon Merger

Effective January 1, 2024, the Plan Sponsor approved an addendum to merge plan assets with Permian Resources Operating, LLC. On March 31, 2024, the merger was finalized, and the plan was terminated. All participants were fully vested in their account balances. The account balances were liquidated and transferred to the surviving plan as soon as administratively practicable. As a result of the imminent liquidation, the 2024 financial statements have been presented on the liquidated basis of accounting. This had no impact on the values of the assets reported in the financial statements. No liabilities were recognized in connection with the termination.
