My name is Michael Adebawale Ajomale, and I am the owner of Design Depictions Structural Engineering, P.C. In 2024, my company established a small business 401(k) retirement plan through ADP Retirement Services, which was integrated with our payroll system. As part of our compliance obligations associated with this new retirement plan, ADP Retirement Services informed us that we were required to file IRS Form 5500 for the first time for the 2024 fiscal year.

Regrettably, our company faced a shortage of staff over the past year. Due to this lack of personnel, we were unable to complete essential administrative tasks, including the timely filing of IRS Form 5500 ahead of the October 15, 2025, deadline.

Once I became aware that IRS Form 5500 had not been filed, I acted promptly to ensure that the form was filed immediately. As this is our company's first experience with filing this particular document, I respectfully request that any late penalties associated with this filing be waived.
