INDEPENDENT AUDITORS' REPORT

To The Plan Administrator of

Opinion

We have audited the accompanying financial statements of LifePath, Inc. NOTE 1 DESCRIPTION OF PLAN

The following description of the LifePath, Inc. Employee Benefit Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan provides health benefits (medical, dental, vision, and prescription drugs), short and long term disability, and life and accidental death and dismemberment covering the full-time employees and dependents of LifePath, Inc. (Company). The Plan was established on January 1, 2013. Prior to March 1, 2019, the Plan was funded by the general assets of the Company. The Plan was substantially amended and restated as of March 1, 2019, and a trust was established to fund the plan and hold payments for health claims. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan also provides health benefits under the Consolidated Omnibus Budget Reconciliation Act (COBRA). COBRA was effective on the date the Plan began. The Plan is required to offer continuation of benefits for a specified period of time to qualified employees and their dependents who would not otherwise be eligible for continued coverage because of a particular qualifying event as required by law.

Stop-Loss Coverage

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). The premiums are paid by the Plan and recorded as a plan expense.

Self-insured Benefits

All medical and prescription drug plan benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and then are reimbursed by the Plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Fully-insured Benefits

The Plan covers medical benefits including dental and vision benefits through insurance contracts.

NOTE 1 **DESCRIPTION OF PLAN (continued)**

Contributions

The Company will periodically deliver to the Plan such amounts of money as shall be necessary for timely payment of all health claims, benefit premiums, and reasonable administrative expenses of the plan.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable weekly premiums for their respective benefit elections.

COBRA premiums are paid directly to the third-party administrator. These premiums are reflected on the financial statements as COBRA contributions. COBRA claims are paid in the same manner as other health claims.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual basis of accounting.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein incurred but not reported (IBNR), and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

Investments consist of money market funds held at UMB Bank.

Payment of Benefits

Premiums paid by participants are recorded as participant contributions in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party-claims processor. Claim payments are recorded as benefits paid on behalf of participants for health claims in the accompanying statement of changes in net assets available for benefits. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payables for health claims in the accompanying statements of net assets available for benefits.

NOTE 2 **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

Stop Loss

Premiums for stop loss insurance are included in insurance premiums in the accompanying statements of changes in net assets available for benefits. Stop loss refunds are netted against benefits paid on behalf of participants for health claims in the accompanying statements of changes in net assets available for benefits.

Administrative Expenses

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party administrators and the custodian. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company.

NOTE 3 **FAIR VALUE MEASUREMENTS**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair values of money market funds are based on quoted market prices from active markets.

NOTE 5 RELATED PARTY TRANSACTIONS

Certain Plan functions are outsourced to a third party. Health benefits are administered by Capital BlueCross (CBC) for participants in the Plan and qualify as party-in-interest transactions under ERISA. Fees paid by the Plan to CBC for administrative expenses amounted to \$184,948 and \$208,488 for the years ended December 31, 2024 and 2023, respectively.

UMB Bank is the custodian as defined by the Plan and qualifies as a party-in-interest. No fees were paid by the Plan for cash management services for the years ended December 31, 2024 and 2023.

NOTE 6 **PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE 7 **TAX STATUS**

Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the plan, and has concluded as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require changes to these financial statements.

NOTE 8 **CONCENTRATION OF CREDIT RISK**

Financial instruments that potentially subject the Plan to credit risk consist of money market funds. The Plan maintains an account with UMB Bank containing money market funds. At times, balances may exceed the insurance limits of the Securities Investor Protection Corporation.

NOTE 9 **RISKS AND UNCERTAINTIES**

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of

investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE 10 **SUBSEQUENT EVENTS**

No subsequent events were identified through November 21, 2025, the date these financial statements were available to be issued.
