I am writing regarding the compliance filings for BCLM Harrell Corporation. I engaged Guidant Financial to manage all required documentation for the corporation's retirement plan associated with the ROBS program. Unfortunately, I was not aware that two plans had been created.

Plan **002** was the plan actively used to remain in compliance with the ROBS program, and Form 5500-EZ/5500SF was properly filed for that plan. However, I recently discovered that Guidant did not file the final 5500-EZ/5500SF to terminate **Plan 001**, despite my request in 2022. The business officially closed on May 31, 2022, and I believed all necessary documentation had been completed at that time.

Upon learning of the oversight, I have done my absolute best to complete and submit the Form 5500-EZ/5500SF for Plan 001 to the best of my ability given my limited knowledge of these filings. I respectfully request your understanding and consideration regarding this issue, as the error was unintentional and based on my reliance on a third-party administrator.
