NOTE 1 – DESCRIPTION OF PLAN

Daily Instruments 401(k) Plan (the Plan), which covers all employees of Daily Instruments Corporation (the Company), was established January 1, 1997, as a 401(k) profit sharing plan subject to enable participants to supplement their retirement income. Daily Thermetrics Service Corporation is a participating affiliate. The Plan was amended effective January 1, 2024. The Plan is subject to provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions.

Eligibility: To participate in the Plan, an employee must be at least age 18 and have completed three months of service. Employees will become a participant on the first day of the month coinciding with or next following the date eligibility requirements are met.

Contributions: Participants may elect to defer a percentage (up to 90%) of their eligible pay every period, not to exceed the annual dollar amount allowed by law. Participants may make pre-tax elective deferrals or Roth elective deferrals. Participants projected to reach age 50 or older during the calendar year may also make catch-up contributions. Participants may increase or decrease the amount of their contribution percentage, suspend their contributions, or resume their contributions at any pay date.

The Company will make a matching contribution to the Plan equal to 25% of a participant's elective deferrals that are on the first 8% of a participant's compensation which is deferred as an elective deferral.

The Company may also elect to make nonelective contributions to the Plan, although the Company is not required to do so. For 2024, the Company elected not to make any nonelective contributions.

Participants are permitted to deposit into the Plan distributions they have received from other retirement plans and certain IRAs, called a rollover contribution.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions and (b) Plan earnings and losses, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in all of their plan account plus actual plan earnings thereon. Vesting in the employer contribution portion of their accounts plus actual plan earnings thereon is based on years of service, with participants becoming 100% vested at six years of counted service.

Payment of Benefits: Participants may receive a distribution of the vested portion of some or all of their account upon termination of employment, normal retirement, disability, or death. If a participant's vested account balance does not exceed \$5,000, then their vested account balance may only be distributed in a single lump-sum payment. If a participant's vested account balance exceeds \$5,000, the participant must consent to any distribution before it is made. The participant can elect to receive the distribution in a single lump-sum payment or partial withdrawals.

Participants may receive a distribution from the Plan from certain accounts prior to termination of employment if they have attained age 59 1/2. Hardship distributions are also available to participants of certain conditions representing an immediate and heavy financial need.

Notes Receivable from Participants: Participants may borrow from their account a minimum of \$500 up to a maximum equal to the lesser of 50% of the participant's vested account balance or \$50,000 reduced by the highest outstanding balance of loans from the Plan during the prior 12-month period. Each loan is adequately secured by the balance in the participant's account and shall bear a reasonable rate of interest. Principal and interest payments are paid at least quarterly over a term not to exceed five years unless the loan was obtained to acquire a principal residence. Participants are limited to two outstanding loan at a time.

Forfeitures: If a participant terminates employment before being fully vested, then the non-vested portion of the terminated participant's account balance remains in the Plan and is called a forfeiture. The Company may use forfeitures to pay Plan expenses or to reduce any employer contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$60,560 and \$26,461, respectively. In 2024, employer contributions were reduced by \$9,262 from forfeited non-vested accounts.

Plan Termination: Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable. Participants will be notified in the Plan is terminated.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through October 15, 2025, which is the date the financial statements were available to be issued. No events occurred subsequent to December 31, 2024, that require disclosure in or adjustment to the accompanying financial statements.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from the estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants: Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Excess Contributions: Refunds of excess participant deferral contributions may be required to satisfy the relevant nondiscrimination provisions of the Plan. Such refunds are accrued as a liability and reduction in contributions in the Plan year in which the excess deferrals were made to the Plan.

Risks and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, credit and global impact risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefit.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company.

NOTE 4 – FAIR VALUE MEASUREMENTS

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels on inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted process in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

NOTE 4 – FAIR VALUE MEASUREMENTS (Continued)

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Money Market Fund: Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 1 inputs).

Collective Trust Funds: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

NOTE 5 – PARTY IN INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain investments are managed by Reliance Trust Company or an affiliate of Reliance Trust Company. Reliance Trust Company is a service provider to the Plan and, therefore, these transactions and the Plan's payment of fees qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter dated October 6, 2020 indicating that the non-standardized pre-approved plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, plan management believes that the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routing audits by taxing jurisdiction; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
