Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Emmis Operating Company 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan was administered by Emmis Operating Company (Company or Plan Administrator). The purpose of the Plan was to provide retirement income and other benefits to eligible employees of the Company. Subsidiaries of the Company were also participating employers of the Plan. Employees who had at least 30 days of service and were 18 years of age or older were eligible to participate in the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Bank of America, N.A. served as the trustee of the Plan and Merrill Lynch, Pierce, Fenner & Smith Incorporated (Merrill Lynch) served as the recordkeeper of the Plan.

Plan Transfer Out

Effective January 1, 2025, WorkSmart Systems, Inc., a Professional Employer Organization (PEO), began providing the Company professional employer, human resource and employee management services through co-employment of the Company's employees and Matthew Thomas of WorkSmart Systems, Inc. was appointed the new trustee of the Plan. The Plan's assets were merged and transferred to the WorkSmart Systems, Inc. 401(k) Profit Sharing Plan and Trust (the "WorkSmart Plan"). The transfer of assets initiated a blackout date beginning February 13, 2025 at which time participants could not obtain a withdrawal of their account or request a loan. Approximately \$56,866,000 was transferred to the WorkSmart Plan during the period ended April 30, 2025. The vested balance in each participant's account under the Plan was equal to that participant's vested balance under the WorkSmart Plan.

Contributions

The Plan was a contributory, defined-contribution plan. Participants could contribute up to 50% of annual compensation, as defined in the Plan document, limited to a maximum as established by the Internal Revenue Service (IRS). Employee rollover and Roth contributions were also permitted. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Eligible employees hired on or after March 1, 2008 were automatically enrolled in the Plan at a three percent deferral rate if they do not elect to participate or opt out within the specified period of time. Once automatically enrolled, the participant's deferral rate increased by one percent annually until a ten percent deferral rate was reached. Effective November 1, 2023, the deferral rate for those automatically enrolled increased to six percent and that deferral rate increased by one percent annually until a fifteen percent deferral rate was reached.

1. Description of the Plan (continued)

Participants could also contribute amounts representing qualified rollovers from other qualified plans. Participants direct the investment of their contributions into various investment funds offered by the Plan and could change the allocation daily.

The Company could make discretionary matching contributions to the Plan in the form of cash. Effective January 1, 2016 and thereafter, matching contributions to the Plan were ceased. Effective June 1, 2024, the Plan began making discretionary matching contributions in the form of cash of thirty-three percent of each one percent contributed by an employee up to six percent contributed by an employee, not to exceed \$4,000 per employee in a calendar year. Contributions of \$4,379 were deposited in January 2025 for an employer contribution for the December 31, 2024 year end. Contributions were subject to certain limitations.

Vesting

Participants were immediately 100% vested in their contributions plus actual earnings thereon. All participants whose hire date was prior to March 1, 2003 were 100% vested immediately in the Company contributions. Employees whose hire date occurred on or after March 1, 2003, were not 100% vested in the Company contributions until after completion of one year of continuous service. However, all participants balances became 100% vested as of December 31, 2024.

Administrative Expenses

Expenses related to the Plan were paid for by either the Plan or the Company. Participant accounts were charged fees for certain participant-initiated transactions. Certain investment related expenses were included in net appreciation in fair value of investments.

Participant Accounts

Each participant's account was credited with the participant's contributions, qualified rollovers, and Plan earnings. The benefit to which a participant was entitled equaled the participant's vested account balance. Forfeited balances of terminated participants' nonvested accounts were usually used to reduce future Company contributions. The forfeiture account balance consisted of forfeited non-vested accounts and unclaimed checks. As of April 30, 2025 and December 31, 2024, the forfeiture account balance was \$0 and \$15, respectively. During the four months ended April 30, 2025, funds from the forfeiture account were used to re-issue unclaimed checks.

Payment of Benefits

Benefits generally were distributed on the participant's termination of employment with the Company, normal retirement, disability retirement, or death. Benefits were payable in a lump-sum distribution unless otherwise elected by the participant.

Notes Receivable from Participants

Participants could borrow up to the lesser of \$50,000 or 50% of their vested account balance. Loans typically did not exceed five years unless the participant used the loan proceeds to acquire their principal residence. Loans were secured by the balance of the participant's account and bore interest fixed at 1% above prime on the loan origination date. Principal and interest payments were made through payroll deductions.

2. Significant Accounting Policies

Use of Estimates and Basis of Accounting

The preparation of financial statements in accordance with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The financial statements of the Plan were prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States.

Valuation of Investments and Investment Income

Investments were stated at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. See Note 4 for further information.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants were recorded upon distribution.

3. Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., the trustee of the Plan, has certified the following information included in the accompanying financial statements and supplemental schedule is complete and accurate.

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the four months ended April 30, 2025.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4. Fair Value Measurements

Fair Value Measurements and Disclosures, FASB ASC 820, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

4. Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds were valued at quoted market prices which represent the net asset values of shares held by the Plan at year-end.

5. Income Tax Status

Effective January 1, 2022, the Plan was amended and restated using a Merrill Lynch, Pierce, Fenner & Smith Inc. Defined Contribution Pre-Approved Plan. The primary objective of the amendment and restatement was to adopt the updated provisions of the underlying plan as most recently opined on by the IRS. The underlying Merrill Lynch, Pierce, Fenner & Smith Inc's non-standardized pre-approved profit sharing/money purchase/CODA plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the plan is qualified under Section 401 of the Internal Revenue Code (the Code), and therefore the related trust is tax exempt. In accordance with Revenue Procedure (Rev. Proc.) 2017-41, 2017-29 I.R.B. 92, the Company has determined that it is eligible to and has chosen to rely on the IRS opinion letter dated June 30, 2020. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

The Plan Sponsor believes the Plan was operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended, was qualified and the related trust was tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related-Party and Party-In-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

ProCourse Fiduciary Advisors, LLC (ProCourse) served as an ERISA Section 3(38) Investment Manager of the Plan. Effective January 1, 2024, ProCourse changed their name to MJ Retirement.

Some fees incurred by the Plan for investment management services were included in net appreciation in fair value of investments, as they were paid through revenue sharing, rather than direct payment.

The Plan paid \$4,452 of recordkeeping fees to Merrill Lynch during the period ended April 30, 2025. The Company provided certain administrative services at no cost to the Plan.

7. Subsequent Events

Subsequent events have been evaluated through November 18, 2025, which is the date of the financial statements were available to be issued.
