2023 Form 5500-SF Explanation for Late Filing

The Form 5500-SF for the 2023 plan year was filed late due to a change in plan administration. During the 2023 plan year, the plan's administration and recordkeeping responsibilities were transferred to a new third-party administrator. At the time of the transition, we were not informed that we remained responsible for filing Form 5500-SF for that year, and we mistakenly believed that the new administrator would complete and file the form on our behalf.

Once we became aware that the 2023 Form 5500-SF had not been filed, we acted promptly to prepare and submit the required filing. The late filing was unintentional and resulted from a misunderstanding during the administrative transition. We have since reviewed and updated our internal procedures to ensure timely filings in the future.
