Employee Savings and Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — 2024 Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Walker Automotive Supply, Inc. Employee Savings and Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Walker Automotive Supply, Inc. ("Plan Sponsor") who have completed 90 days of service and are 18 years old or older. The plan was amended effective January 1, 2023, to add Walker Hardware, LLC as a participating employer (collectively the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan administrator is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan administrator.

Plan Amendment

As a result of the acquisition by a third-party of Walker Automotive Supply, Inc., a participating employer, the Plan was amended effective August 1, 2024 to become a multiple employer plan (MEP). The Plan was amended effective December 18, 2024 to cease all further contributions, loan repayments or new loans.

Plan Termination

The managing member of Walker Hardware, LLC, voted to terminate its participation in the Plan effective December 31, 2024 and determined that liquidation was imminent as of that date. Walker Hardware, LLC employees participating in the Plan became 100% vested as of December 31, 2024. Walker Hardware, LLC participants had until February 21, 2025 to initiate their distribution request, otherwise an IRA account would be set up in the participants' name. All Walker Hardware, LLC employees' participant account balances were distributed and full liquidation of the Plan occurred on March 11, 2025.

Plan Merger

On December 31, 2024, an authorized officer of the Plan Sponsor approved the spin off Walker Automotive Supply, Inc. employees' participant account balances from the Walker Automotive Supply, Inc. Savings and Retirement Plan into the Genuine Parts Company 401(k) Savings Plan effective January 1, 2025. As a result, the control of Walker Automotive Supply, Inc. employees' participant account balances of \$7,748,157 was transferred to the Genuine Parts Company 401(k) Savings on January 1, 2025. Walker Automotive Supply, Inc. employees with a participant account balance after July 31, 2024 became 100% vested in their account balance on December 18, 2024.

Contributions

Prior December 18, 2024, participants could contribute up to 100% of their annual pre-tax compensation, as defined in the Plan. Participants could also make qualified Roth contributions to the Plan and could contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions").

Contributions (Continued)

Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and after 2 years increased annually by an increment of 1% up to a maximum deferral rate of 10% of eligible compensation, unless otherwise elected by the participant. Contributions were invested in the Plan's designated default investment fund until changed by the participant. Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company could make safe harbor contributions equal to 100% of the first 1% of the participant's eligible compensation, plus 50% of the participant's next 5% of eligible compensation, not to exceed 6% of eligible compensation. The Company could also make discretionary matching and profit sharing contributions to the Plan. There were no discretionary matching or profit sharing contributions made for the period January 1, 2025 through March 11, 2025 (in liquidation) and the year ended December 31, 2024 (in liquidation). Contributions are subject to certain limitations as determined by the Internal Revenue Code.

Participant Accounts

Each participant's account was credited with the participant's contributions, including amounts rolled over from other qualified plans, and Company contributions, as well as allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that was provided from the participant's vested account.

Vesting

Prior to the Plan amendments outlined above, participants were vested immediately in their voluntary contributions, including amounts rolled over from other qualified plans, plus actual earnings thereon. Participants were 100% vested in the Company's safe harbor matching contributions after 2 years of credited service. Vesting in the Company's discretionary contributions and any actual earnings thereon is determined using a graded schedule based on years of continuous service with participants 100% vested after 6 years of credited service or in the event of death and disability, as defined in the Plan.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant could have two outstanding loans at a time. The loans were secured by the balance in the participant's account and bore interest at prime rate plus 2%, which was commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest was paid ratably through payroll deductions.

Payment of Benefits

The Plan permitted withdrawals upon attainment of the age 59 1/2 or upon disability, hardship, retirement, death or termination of service. Benefits were payable in lump-sum or partial payments.

Forfeited Accounts

Forfeited nonvested accounts totaled \$-0-, \$1,719, and \$1,402 as of March 11, 2025 (in liquidation), December 31, 2024 (in liquidation) and December 31, 2023 (ongoing), respectively. These accounts could be used to pay administrative expenses or to reduce future Company contributions. For the year ended December 31, 2024 (in liquidation), revenue sharing income of \$24,813 was used to pay Plan expenses and \$11,088 of forfeitures were used to reduce Company contributions. For the period January 1, 2025 through March 11, 2025 (in liquidation), revenue sharing income and forfeitures of \$13,207 were used to pay Plan expenses and \$522 of forfeitures were used to reduce Company contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The managing member of Walker Hardware, LLC elected to terminate its participation in the Plan effective December 31, 2024. The termination was deemed to be imminent during 2024 and 2025. In accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting used to determine the amounts at which investments and benefit distribution information is stated from the accrual (ongoing) basis used in the presentation of the 2023 financial statements to the liquidation basis of accounting presentation of the 2024 and 2025 financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses has been recorded as of March 11, 2025 (in liquidation), December 31, 2024 (in liquidation) or December 31, 2023 (ongoing).

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation of fair value of investments. Expenses relating to specific transactions, such as loan set up, loan maintenance and distributions fees, are paid directly by the participant and are included in administrative expenses.

Subsequent Events

The Company has evaluated events and transactions for potential recognition or disclosure through November 20, 2025, which is the date the financial statements were issued.

NOTE 3 - INFORMATION CERTIFIED BY EMPOWER (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at March 11, 2025 (in liquidation), December 31, 2024 (in liquidation) and 2023 (ongoing), and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period January 1, 2025 through March 11, 2025 (in liquidation) and year ended December 31, 2024 (in liquidation), was obtained or derived from information supplied to the Plan administrator and trustee and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively "Empower").

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Collective investment trust funds: Valued at the NAV of units of a collective investment trust fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective investment trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a separate investment contract that meets the fully benefit-responsive investment contract criteria, and therefore, is reported at contract value. Contract value is the relevant measurement for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the fully benefit-responsive investment contract at March 11, 2025 (in liquidation), December 31, 2024 (in liquidation) and December 31, 2023 (ongoing) was \$-0-, \$139,628 and \$122,367, respectively.

The investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than -0-% as specified by the contract. Such interest rates are declared on a quarterly basis by the contract issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Withdrawals caused by the Company upon a 60 day notice may either be paid out immediately (subject to a market value adjustment) or at the full contract value no later than 12 months from contract termination date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments within the Plan's portfolio consisted of a guaranteed interest contract held in general accounts managed and guaranteed by Empower Annuity Insurance Company of America, and affiliated companies, therefore, these investment transactions qualify as party-in-interest transactions. Plan recordkeeping, transaction processing, custodial services and loan maintenance services were provided by Empower, subsidiaries and affiliates. Brokerage and investment advisory services were provided by OneDigital Investment Advisors LLC. Plan compliance, consulting, and accounting services were provided by Gilliam Bell Moser. Fees associated with these services qualify as party-in-interest transactions. The Plan may receive revenue sharing payments from Empower, which offset fees paid by the plan. Fees in excess of the revenue sharing amount are allocated to participant accounts and expensed.

NOTE 8 - PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Effective December 31, 2024, a participating employer, Walker Hardware, LLC, ceased its participation into the Plan and determined liquidation was imminent formally approving a plan of liquidation on the same date. During the period January 1, 2025 through March 11, 2025, Plan assets of Walker Hardware, LLC employees were liquidated and distributed in accordance with instructions received from the impacted Plan participants. These participants became 100% vested in their Company contributions as of December 31, 2024.

NOTE 9 - TAX STATUS

Effective January 1, 2022, the Plan adopted a pre-approved plan sponsored by FIS Business Systems, LLC. The pre-approved plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 11, 2025 (in liquidation), December 31, 2024 (in liquidation) and 2023 (ongoing), there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
