Opinion

1. Summary of significant accounting policies

The following is a summary of the significant accounting policies followed by 1st Pet Employee Stock Ownership Plan (the Plan). The policies conform with accounting principles generally accepted in the United States of America, which require management to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates. Management has reviewed the financial statements for subsequent events through November 14, 2025 the date the financial statements were available to be issued.

a. Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

b. Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

c. Investment valuation

The shares of common stock of the Company are valued at fair value. See note 4 for discussion of the fair value measurements. Net appreciation/depreciation includes the Plan’s gains and losses on the value of the company stock.

d. Income taxes

The Plan received a favorable determination letter dated October 11, 2022 from the Internal Revenue Service, which states that the Plan qualifies under the applicable provisions of the Internal Revenue Code. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

1st Pet Veterinary Centers, Inc. (Company) established the 1st Pet Employee Stock Ownership Plan (ESOP) effective January 1, 2021. The Plan covers employees with at least one year of service to the Company who are age eighteen or older. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the employer except to the extent the Employer appoints any one or more persons, including, but not limited to, Employees of the Employer, to perform the duties of the Administrator. The Plan's Trustee is appointed by the Employer.

The 1st Pet Employee Stock Ownership Trust purchased 1,000,000 shares of the Company's common stock with a loan of \$1,000,000 from the 1st Pet Veterinary Centers, Inc. (see Note 5). The borrowing is collateralized by the unallocated shares of common stock of the Company.

b. Contributions

The Company may make a discretionary contribution in cash or Company Stock to the Plan, such amount shall be determined by the Employer in its discretion. To the extent necessary, the Employer shall contribute to the Plan the amount necessary to provide the top-heavy minimum contribution.

c. Vesting

Participants are vested based on years of service. Participants vest at 20% after two years of service, and the percentage increases by 20% annually until the participant is fully vested after six years of service. Participants who reach normal retirement age, total and permanent disability, or death while still employed, shall become fully vested.

d. Participant accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of each Anniversary Date, or other Valuation Date with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation.

Contributions are allocated to each Participant's Account in the same proportion that each Participant's total points earned for that Plan Year bears to the total points earned by all Participants who are eligible to share in the allocations for that Plan year.

d. Participant accounts, continued

Points are awarded based on years of service and compensation. Participants are awarded one point for each "Allocation Year of Service". However, solely for Dr. Randy Spencer, he is awarded a half point for each "Allocation Year of Service". Additionally, one point is allocated for each full \$1,000 of compensation received during the applicable Plan Year, but shall not exceed 30 points with respect to any plan year.

e. Payment of benefits

Each participant is entitled to plan benefits equal to 100% of his/her vested account balance. Benefits begin upon the earliest of retirement age, termination of employment, total and permanent disability or death of the participant. Distributions are to commence no later than the close of the Plan year that is the 6th Plan year following the Plan year in which the Participant separates from service. Benefits are paid in a lump sum either in cash or in the form of whole shares of Company common stock plus cash for any fractional shares or in substantially equal annual installments over a period not to exceed 5 years unless the participant's account balance exceeds a certain amount.

Shares of Company stock distributed under the Plan shall be subject to the right of first refusal. Prior to any sale or other disposition of any such shares of the Company stock by a participant, beneficiary, spouse, next of kin or other heir or transferee, such shares must first be offered for sale to the Trust and then, if such offer is not accepted, all the remaining shares must be offered to the Company.

f. Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The sale price of the Company stock shall be the fair value of such shares at the time the option is exercised. The put option shall permit the participant to sell such Company stock to the Company at any time during two option periods. The first put option period shall be 60 days beginning on the date of distribution of the Company stock from the Plan. The second put option shall be for a period of 60 days on the first day of the fifth month in the plan year following the plan year in which the Company stock is distributed from the Plan.

Company stock sold under a put option shall be paid for either in a lump sum or substantially equal installments over a period not later than 30 days after the exercise of the put option and not extending beyond 5 years.

g. Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investments in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect in writing to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. A participant may diversify up to 25 percent of the shares allocated to his account and during the last year in which the participant can make the election, the participant may elect to diversify up to 50 percent of the total number of shares of company stock.

h. Forfeitures

Plan forfeitures are allocated to each participant's account based upon the same proportion that each Participant's total points earned for that Plan Year bears to the total points earned by all participants who are eligible for allocations of shares for that plan year. During the plan years ended December 31, 2024 and 2023, 7,094 and 2,548 shares were allocated to participants, respectively.

i. Administrative expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. Currently, the Company is paying substantially all expenses.

j. Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account when it is considered a corporate matter that involves the voting of corporate stock. The Trustee is required to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries and to vote any allocated shares of Company Stock as to which no voting instructions have been received. If there is an issue not subject to participant voting, the Trustee shall vote all shares of Company Stock.

k. Plan termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, all amounts credited to the affected participants' accounts shall be 100% vested and distributed to such participants or their beneficiary at the time prescribed by the terms of the Plan and the IRC.

4. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification 820, Fair Value Measurements (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

1st Pet Employee Stock Ownership Plan common stock held by the Plan is valued at fair value based upon an independent appraisal. For the Plan years ended December 31, 2024 and 2023, the appraisal was based on the discounted cash flow method using the Black Scholes Option Pricing Model.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Note payable

In 2021, the Plan entered into a \$1,000,000 loan agreement with 1st Pet Veterinary Centers, Inc. to purchase the Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 28,572 shares being released and allocated during each of the plan years ended December 31, 2024 and 2023.

The promissory note provides for the loan to be repaid over 35 years, with annual payments of \$38,864 at an interest rate of 1.890% per year. The scheduled amortization of the loan for the next 5 years is as follows:

6. Company dividends

The Company did not pay dividends to the Plan for the Plan years ended December 31, 2024 and 2023.

7. Related party and party-in-Interest transactions

The Plan invests in Company common stock and has indebtedness to the Company. The Plan has several service providers. Such providers are parties in interest under ERISA. The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan Sponsor, Custodian of the Plan assets, record keeper, and other service providers are considered parties-in-interest with respect to the Plan. Such transactions are party-in-interest and related party transactions for which a statutory exemption exists.

8. Risk and uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimation and assumption process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

9. Contingency

The valuation report has not considered the potential financial implications of subsequent events or their impact on the valuation as of December 31, 2024.

10. Subsequent events

As described in the Company's financial statements the Company has debt obligations in 2025 and 2026, including its obligations to the Plan, that significantly exceed its net income and net cash provided by operating activities. To offset the shortfall, the selling shareholder has agreed to provide financing of \$1,000,000 to the Company through December 31, 2026 until the Company can generate net income that will fund its ongoing operations and meet debt obligations including payments to the Plan. Management has generated projections through December 31, 2026 and believes that the Company and the Plan will have access to sufficient cash to continue operations and satisfy obligations during that time period.
