INDEPENDENT AUDITORS' REPORT

To those charged with governance of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Magellan Transport Logistics 401(k) Plan. (the "Company") Employee Savings & Protection Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Magellan Transport Logistics 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Note 1 – Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the participating employers who have at least 1 year of service and have attained age 18. The Plan was formed and adopted effective January 1, 2012. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Administration

Principal Life Insurance Company (the "Custodian") serves as custodian of the Plan's assets and performs certain recordkeeping functions for the Plan. The Trustee is responsible for oversight of the Plan. The Trustee determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Participating Employers

The following employers have adopted the provisions of the Plan:

Magellan Transport Logistics, Inc.
Magellan Transport, Inc.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined by the Plan documents, subject to limitations imposed by the Internal Revenue Service. The maximum participant deferral for the years ended December 31, 2024 and 2023, were \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year were also eligible to make catch-up contributions of up to \$7,500 for both years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Note 1 – Description of the Plan (continued)

Contributions (continued)

Magellan Transport Logistics, Inc. and Magellan Transport, Inc. (the “Companies”) contribute 100% of the first 3% and 50% of the next 2% up to \$305,000 of compensation that a participant contributes to the Plan. Participants direct the investment of the Company’s matching contribution into various investment options offered by the Plan. Additional amounts may be contributed at the option of the Company’s board of directors and are invested as directed by the Participants. During the years ended December 31, 2024 and 2023, the Company made profit-sharing contributions into the plan of \$982,962 and \$960,214, respectively.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s profit-sharing contribution and Plan earnings. Participants’ accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum loan amount of \$1,000 up to a maximum loan amount equal to the lesser of \$50,000 (reduced by the excess of the participant’s highest outstanding balance of loans from the Plan during the one-year period ending on the day before the issuance of the new loan) or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at a reasonable rate, which equal to the prime rate plus 1%. Loan terms may not exceed five years, unless the loan is used for the purchase of a principal residence, in which case the plan administrator may permit a longer term. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued by unpaid interest. Interest income is recorded on the accrual basis. Loans are considered to be “in default” if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. The Plan has the authority to take all reasonable actions, including filing a lawsuit or foreclosing on the security for the loan. A loan considered to be in default may also be deemed a taxable distribution from the Plan.

Vesting

Participants are immediately vested in their employee contributions plus actual earnings thereon. Vesting in the employer's discretionary contribution portion of the participants' accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of credited service. The vesting percentages are as follows:

20% after two years of service
40% after three years of service
60% after four years of service
80% after five years of service
100% after six years of service

Payment of Benefits

Upon termination of service due to death, disability, retirement, or any other reason, a participant may receive a lump sum distribution if their vested account balance does not exceed \$5,000. For vested account balances in excess of \$5,000, participants may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals.

The plan also permits participants to take distributions prior to termination of employment upon attaining age 59 ½ or normal retirement age. These in-service distributions may only be drawn from accounts in which the participants are 100% vested.

Additionally, participants who have incurred a "hardship", as defined in the Plan, may take hardship withdrawals, which will be sourced only from accounts which are 100% vested.

Forfeitures

Forfeitures may first be used to reduce employer matching contributions. The Plan had no balance in the forfeited, non-vested account as of December 31, 2024 and 2023.

Note 2 – Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with U.S. GAAP.

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, as well as the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, net of investment management fees.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The FASB has established a framework for measuring fair value in ASC 820, *Fair Value Measurements*. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy are described as follows:

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities & Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the net asset value (“NAV”) provided by the custodian. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the trust, minus its liabilities, divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There were no unfunded commitments to purchase investments at December 31, 2024 and 2023. Participant directed redemptions have no restrictions and are recorded at the end of every business day.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. Investments measured using the NAV as a practical expedient are exempt from being presented in the fair value hierarchy.

Collective investment trust (CIT): Valued based on the closing price reported by the fund. Net assets and net investment income held by the securities listed below are allocated to those securities on a specific identification basis. Benchmark data for the following indices is provided by third party vendors and assumes reinvestment of all dividends and distributions. Actual benchmark data may differ from that of the funds described below, which may impact reported net assets and changes therein.

Fund	Index
Principal Stable Value Fund	iMoneyNet All-Taxable Money Market Fund Index

The objective of the above fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments. The above fund is typically appropriate for investors who desire low volatility, stable principal value, and returns commensurate with a capital preservation objective for a component of their retirement savings.

Note 5 – Party-In-Interest Transactions

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Certain Plan investments and the related transactions were in investment funds managed by the Custodian; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid to parties-in-interest by the Plan for services amounted to \$86,8603 and \$67,042 during the years ended December 31, 2024 and 2023.

Note 6 – Plan Termination

Although the participating employers have not expressed any intent to do so, they have the right under the Plan at any time to discontinue their contributions and at any time to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 7 – Income Tax Status

The IRS has informed the Custodian by an opinion letter dated June 30, 2020, that the prototype plan adopted by the Plan, as then designed, was in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The plan administrator evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the accompanying financial statements. The Plan is subject to routine audit by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued. No other material recognizable subsequent events were noted.
