## **Note 1. Description of the Plan**

### ***General***

The following description of Novak Construction Company 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Novak Construction Company, Inc. (Company) for the benefit of its full-time employees and part-time employees (with at least one year of service) and are age 21 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation. Lincoln Financial Group Trust Company is the trustee of the Plan.

### ***Contributions***

The Plan permits eligible employees, through a pre-tax or Roth salary deferral election, to have up to 90% of their eligible compensation contributed to the Plan. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company determines in its sole discretion how much, if any, it will make as matching contributions. Company profit-sharing contributions are discretionary as determined by the Company's Board of Directors. For the year ended December 31, 2024, the Company made matching contributions equal to 50% of participants' deferral, excluding any catch-up contributions. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. Participants are auto-enrolled at 6 percent of eligible compensation. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 12 percent.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service.

### ***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account bear reasonable interest and are to be repaid over a period not to exceed 5 years, except as related to the purchase of a primary personal residence in which case the loan repayment may not exceed 20 years from the date of the loan. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid through monthly payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account or installment payments. Participants who terminate employment or upon death, and whose balances do not exceed \$5,000, shall receive a single lump-sum cash distribution.

Participants are allowed to make in-service withdrawals from their vested interest in the Plan prior to age 59½ for reasons of financial hardship or disability, as defined in the plan document.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,825 and \$22,837, respectively. This account is available to be used to pay Plan expenses and to reduce future employer contributions. No forfeitures were used in the current year to pay Plan expenses or reduce employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value, with the exception of the stable value separate account which is stated at contract value. Shares of mutual funds and self-directed brokerage accounts are valued at quoted market prices which represent the net asset value of shares held in the Plan. The Lincoln *YourPath* custom funds are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the Plan level. There are no unfunded commitments at December 31, 2024 and 2023.

The Plan's investment in a the stable value fund investment contract is fully-benefit responsive and is reported at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable From Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Employer or the Plan, at the Employer's discretion. If the Employer does not pay Plan-related expenses, such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. Such expenses include costs related to certain employees of the Employer who perform administrative and trustee services for the Plan for which the Plan does not reimburse the Employer.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Certain Plan investments are shares of mutual funds managed Lincoln Financial Group Trust Company (Lincoln). Lincoln is a trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Investment-related expenses are included in the net appreciation of fair value of investments. Expenses paid by the Plan for processional service amounted to \$1,209 during 2024.

**Note 5. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 (Audited) and 2023 (Compiled).

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6. Investment Contract With Insurance Company**

The investment in the general account, the Lincoln Stable Value Account fixed annuity contract (Contract), is considered fully benefit-responsive with a contract value equal to the fair value less any market value adjustment. The account is credited with deposits that are guaranteed in both principal and interest by Lincoln. Amounts are held in Lincoln's general account and are credited on a net daily basis at annual effective rates.

The Contract does not have a maturity date. Participants may request a lump-sum distribution with a market value adjustment, or an installment payout, at contract value, over a period of years. The Contract continues in force until all assets have been distributed, or no further payments are due.

The net rate, crediting rate and average yield earned are the same. The crediting rate is reset quarterly. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the Plan's ability to transact at contract value with Lincoln Stable Value Account. Such events include the following: (a) amendments to plan documents (including complete or partial plan termination or merger with another plan); (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event which would limit the Plan's ability to transact at contract value with plan participants is probable.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their entire account balance.

**Note 8. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Lincoln Retirement Services Company LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
